## **Communities Facilities Grant Program**

## Authority: U. S. Department of Agriculture

**Summary:** Community Facilities program grants assist in the development of essential community facilities in rural areas and towns of up to 20,000 in population. Grant funds can be used to construct, enlarge, or improve community facilities for health care, public safety, and community and public services. This can include the purchase of equipment required for a facility's operation. **Eligibility:** Grants are available to public entities such as municipalities, counties, and special-purpose districts, as well as non-profit corporations and tribal governments.

**Eligibility:** The Governor of each State is required to designate a State Administrative Agency (SAA) to apply for and administer SHSP funds.

**Summary:** UASI Program funds address the unique planning, equipment, training, and exercise needs of high-threat, high-density Urban Areas, and assist them in building an enhanced and sustainable capacity to prevent, protect against, respond to, and recover from acts of terrorism.

**Eligibility:** The Governor of each State and Territory is required to designate a State Administrative Agency (SAA) to apply for and administer these funds to local units of government and other designated recipients.

# Justice Assistance Grants (JAG) Local Program

## Authority: U.S. Department of Justice

**Summary:** The Edward Byrne Memorial Justice Assistance Grant (JAG) Program is the primary provider of federal criminal justice funding to state and local jurisdictions. JAG funds can be used to support state and local initiatives, technical assistance, training, personnel, equipment, supplies, contractual support, and information systems for criminal justice entities.

**Eligibility:** Units of local government appearing on the FY 2009 Units of Local Government List established by the Bureau of Justice Statistics (BJS) are eligible to apply for JAG funds.

**Summary:** The Edward Byrne Memorial Competitive Grant Program (Byrne Competitive Program) helps local communities improve the capacity of local justice systems and provides for national support efforts including training and technical assistance programs strategically targeted to address local needs. Funds can be used for national scope replication, expansion, enhancement, training, and/or technical assistance programs.

**Eligibility:** Eligibility includes criminal justice agencies; national, regional, state, or local public and private entities, including for-profit (commercial) and nonprofit organizations, faith and community-based organizations, institutions of higher education, tribal jurisdictions, and units of local government. **Projected 2010 deadline:** 4/27/2010

Authority: The Hearst Foundations / William Randolph Hearst Foundations

**Summary:** The Hearst Foundations support well-established nonprofit organizations that address important issues within our major areas of interests – education, health, culture, and social service – and that primarily serve large demographic and/or geographic constituencies. Within these areas, the Foundations generally provide endowment, program, and capital grant support. Private nonprofits with significant support from the philanthropic community are favored over those financed through government sources.

**Eligibility:** Current IRS documentation certifying that the applicant is tax-exempt under Section 501(c)(3) of the Internal Revenue Code and not a private foundation under Section 509(a) is necessary to be eligible. Grant funds must be used for charitable purposes exclusively within the United States and its territories.
