

## Google Cloud Services Terms & Conditions

THESE TERMS AND CONDITIONS (THE "TERMS") APPLY TO SEAT OR USER BASED SUBSCRIPTIONS FOR GOOGLE CLOUD SERVICES (EACH A "SUBSCRIPTION"). PLEASE READ THESE TERMS CAREFULLY BEFORE ACCEPTING THESE TERMS OR ACCESSING OR USING THE SUBSCRIPTIONS. BY PLACING AN ORDER FOR THE SUBSCRIPTIONS OR ACCESSING OR USING THE SUBSCRIPTIONS, YOU ACCEPT AND AGREE TO THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS, OR DO NOT HAVE THE AUTHORITY TO ACCEPT THESE TERMS, DO NOT SUBSCRIBE TO, ACCESS OR USE THE SUBSCRIPTIONS.

Your use of the Subscriptions reflected on your Google Cloud account with Dell and any changes or additions to the Subscriptions that you purchase from Dell are subject to the Commercial Terms of Sale (the "Agreement"), its Cloud Subscription Schedule and the Service Description for Google Cloud with Dell available at <a href="https://www.dell.com/cloudservicecontracts">www.dell.com/cloudservicecontracts</a> (the "Google Cloud Service Description"). The Commercial Terms of Sale, the Cloud Subscription Schedule and the Google Cloud Service Description are incorporated by reference in their entirety herein.
- 2. You are purchasing a Subscription to Google Cloud Services. "Google Cloud Services" are any of the currently available Google Cloud Services offered by Dell that you Subscribe to under these Terms (for example, and not by way of limitation, Drive Enterprise or Google Workspace). "Subscription" means an order for a quantity of Google Cloud Services. The billing plan options for each Subscription are as follows:

## **Annual Plan with Annual Pay:**

- For Subscriptions purchased under this plan, you commit to a full one (1) year period (a "Term") and will be charged annually in advance based on the quantity of Google Cloud Services that you purchase. You agree to pay for the total amount of the Subscription upfront in accordance with the payment terms set forth in the Agreement.
- Within the first 30 days following your order for the Google Cloud Services, you may terminate your Subscription and receive a full refund for the Google Cloud Services terminated. You may not terminate your Subscription after the first 30 days (except as otherwise set forth in the Agreement).
- During the Term, you may not remove seats or downgrade Google Cloud Services.
- During the Term, if you order additional Google Cloud Service units for services that you already subscribe to, your charge for those additional Google Cloud Services will be prorated.
- At the end of the initial one (1) year Term and each renewal Term thereafter, your Subscription will automatically renew using your selected payment method unless otherwise set forth herein or notified by Dell. You may elect to opt out of auto renewal by sending notice of non-renewal to Dell or by opting out of automatic renewal in the online portal for the Google Cloud Services.

## **Annual Plan with Monthly Pay:**

- For Subscriptions purchased under this plan, you commit to a full one (1) year Term and will be charged monthly in advance based on the quantity of Google Cloud Services that you purchase. You agree to pay for the Google Cloud Services on a monthly basis in accordance with the payment terms set forth in the Agreement.
- Within the first 30 days following your order for the Google Cloud Services, you may terminate your Subscription and receive a full refund of any fees paid for the services terminated. You may not terminate your Subscription after the first 30 days (except as otherwise set forth in the Agreement).
- During the Term, you may add but not remove seats. You may also upgrade Google Cloud Services but not downgrade Google Cloud Services.
- During the Term, if you order additional Google Cloud Service units for services that you already subscribe to, your charge for those additional Google Cloud Services will be prorated.
- At the end of the initial one (1) year Term and each renewal Term thereafter, your Subscription will automatically renew using your selected payment method unless otherwise notified by Dell. You may elect to opt out of auto renewal by sending notice of non-renewal to Dell or by opting out of automatic renewal in the online portal for the Services.

## Flexible Plan with Monthly Pay:

- For Subscriptions purchased under this plan, there is no commitment or defined Subscription term. You will be billed for each month in arrears and You agree to pay for the Google Cloud Services on a monthly basis in accordance with the payment terms set forth in the Agreement. Any partial day of Google Cloud Services usage will be rounded up to a full day of Google Cloud Services usage for the purposes of calculating applicable fees.
- You may add or remove users at any time and will only be charged for the number of users and days used per user during the previous month.
- Your Subscription will continue until terminated. You may terminate your Subscription
  at any time by sending notice of termination to Dell or by cancelling your Subscription
  in the online portal for the Google Cloud Services. You will be responsible for paying
  for all use per user up to the date of termination. No refunds will be provided.
- 3. In the event you Subscribe under a promotional offer from Google, your promotional pricing will be valid for the duration of the applicable promotion period and will not auto renew at the end of such period.
- 4. Additional services and optional services, such as point-of-need support, installation, consulting, and professional or training services, may be available for purchase from Dell and subject to a separate service description or supplemental terms of service.

    - You hereby consent to Dell providing Google with a copy of these Terms as Google may reasonably request.
    - You are responsible for providing the necessary notices, and obtaining and maintaining any consents, required from your end users to allow Dell and Google to perform their respective contractual obligations hereunder.
    - The Service Level Agreement in the TOS (the "SLA") sets out your sole and exclusive remedy for any failure by Google to meet the SLA, and the you must request any such remedies directly from Dell.
    - Google will only provide technical support directly to you as set out in the Google TOS.
    - Dell, Google and you are independent contractors with respect to the purchase and use of the Google Cloud Services.
- 6. Access to and use of the Google Cloud Services will begin once you have been onboarded. You may contact your Dell sales representative at any time for pricing information.
- 7. Dell reserves the right to cancel orders as a result of pricing or other errors.
- 8. You are required and agree to adhere to the Terms which may be updated from time to time. By renewing, modifying, extending or continuing to utilize the Subscription(s) beyond the initial Subscription term, the Subscriptions will be subject to the then-current Terms available at: https://i.dell.com/sites/csdocuments/Legal\_Docs/en/offeringspecifictermstable.pdf.
