1 Introduction

1.1 Purpose

This document describes:

1. Dell Wyse Datacenter for Citrix® XenDesktop® Reference Architecture scaling from 50 to 50,000+ VDI users.
2. Solution options encompass a combination of solution models including local disks, iSCSI or Fiber Channel based storage options.

This document addresses the architecture design, configuration and implementation considerations for the key components of the architecture required to deliver virtual desktops via XenDesktop 7.6 on Windows® Server Hyper-V® 2012 R2 or VMware® vSphere® 5.

Relative to delivering the virtual desktop environment, the objectives of this document are to:

- Define the detailed technical design for the solution.
- Define the hardware requirements to support the design.
- Define the design constraints which are relevant to the design.
- Define relevant risks, issues, assumptions and concessions – referencing existing ones where possible.
- Provide a breakdown of the design into key elements such that the reader receives an incremental or modular explanation of the design.
- Provide solution scaling and component selection guidance.

2 Solution Architecture Overview

2.1 Introduction

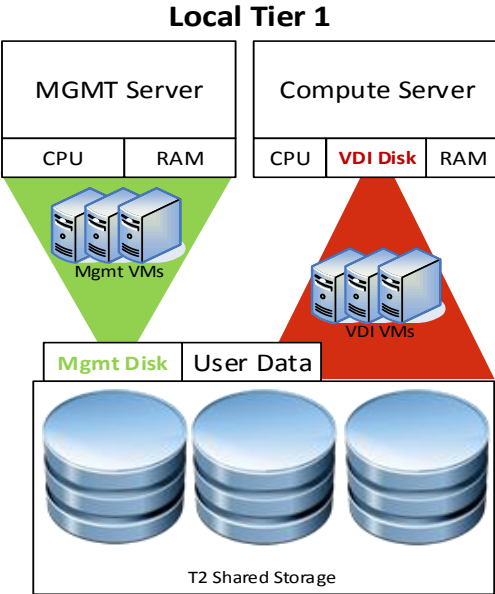
The Dell Wyse Datacenter Solution leverages a core set of hardware and software components consisting of five primary layers:

- Networking Layer
- Compute Server Layer
- Management Server Layer
- Storage Layer
- Cloud Client Layer

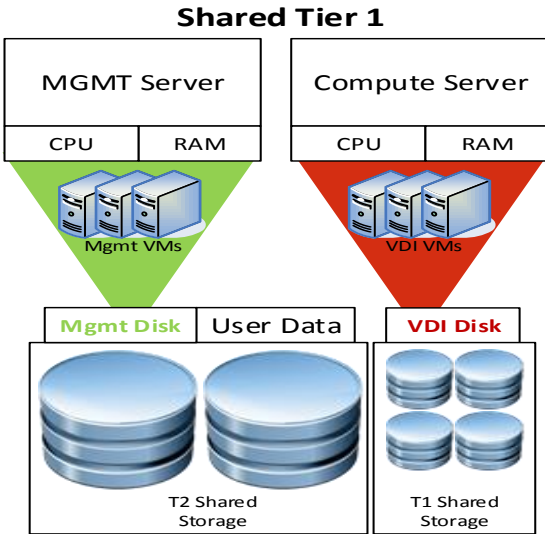
These components have been integrated and tested to provide the optimal balance of high performance and lowest cost per user. Additionally, the Dell Wyse Datacenter Solution includes an approved extended list of optional components in the same categories. These components give IT departments the flexibility to custom tailor the solution for environments with unique VDI features, scale or performance needs. The Dell Wyse Datacenter stack is designed to be a cost effective starting point for IT departments looking to migrate to a fully virtualized desktop environment slowly. This approach allows you to grow the investment and commitment as needed or as your IT staff becomes more comfortable with VDI technologies.

2.1.1 Physical Architecture Overview

The core Dell Wyse Datacenter architecture consists of two models: Local Tier1 and Shared Tier1. "Tier 1" in the Dell Wyse Datacenter context defines from which disk source the VDI sessions execute. Local Tier1 includes rack servers or blades with SSDs while Shared Tier 1 can include rack or blade servers due to the usage of shared Tier 1 storage. Tier 2 storage is present in both solution architectures and, while having a reduced performance requirement, is utilized for user profile/data and Management VM execution. Management VM execution occurs using Tier 2 storage for all solution models. Dell Wyse Datacenter is a 100% virtualized solution architecture.

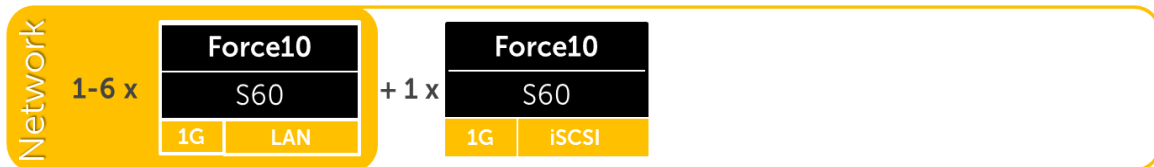


In the Shared Tier 1 solution model, an additional high-performance shared storage array is added to handle the execution of the VDI sessions. All compute and management layer hosts in this model are diskless.

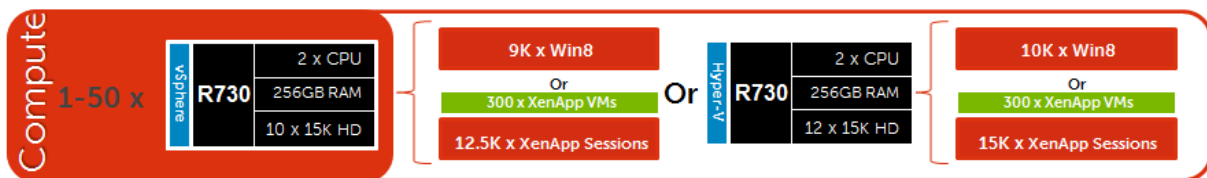


2.1.2 Dell Wyse Datacenter – Solution Layers

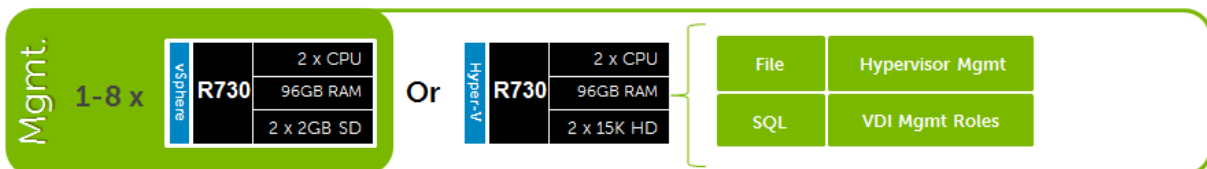
Only a single high performance Force10 48-port switch is required to get started in the network layer. This switch hosts all solution traffic consisting of 1Gb iSCSI and LAN sources for smaller stacks. Above 500 users we recommend that LAN and iSCSI traffic be separated into discrete switching Fabrics. Additional switches are added and stacked as required to provide High Availability for the Network layer.



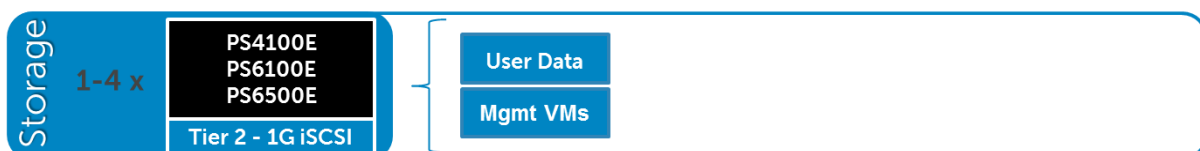
The compute layer consists of the server resources responsible for hosting the XenDesktop or XenApp user sessions, hosted either via VMware vSphere or Microsoft Hyper-V hypervisors, local or shared Tier 1 solution models (local Tier 1 pictured below).



VDI management components are dedicated to their own layer so as to not negatively impact the user sessions running in the compute layer. This physical separation of resources provides clean, linear, and predictable scaling without the need to reconfigure or move resources within the solution as you grow. The management layer will host all the VMs necessary to support the VDI infrastructure.



The storage layer consists of options provided by EqualLogic (EQL) for iSCSI and Compellent arrays for Fiber Channel to suit your Tier 1 and Tier 2 scaling and capacity needs.

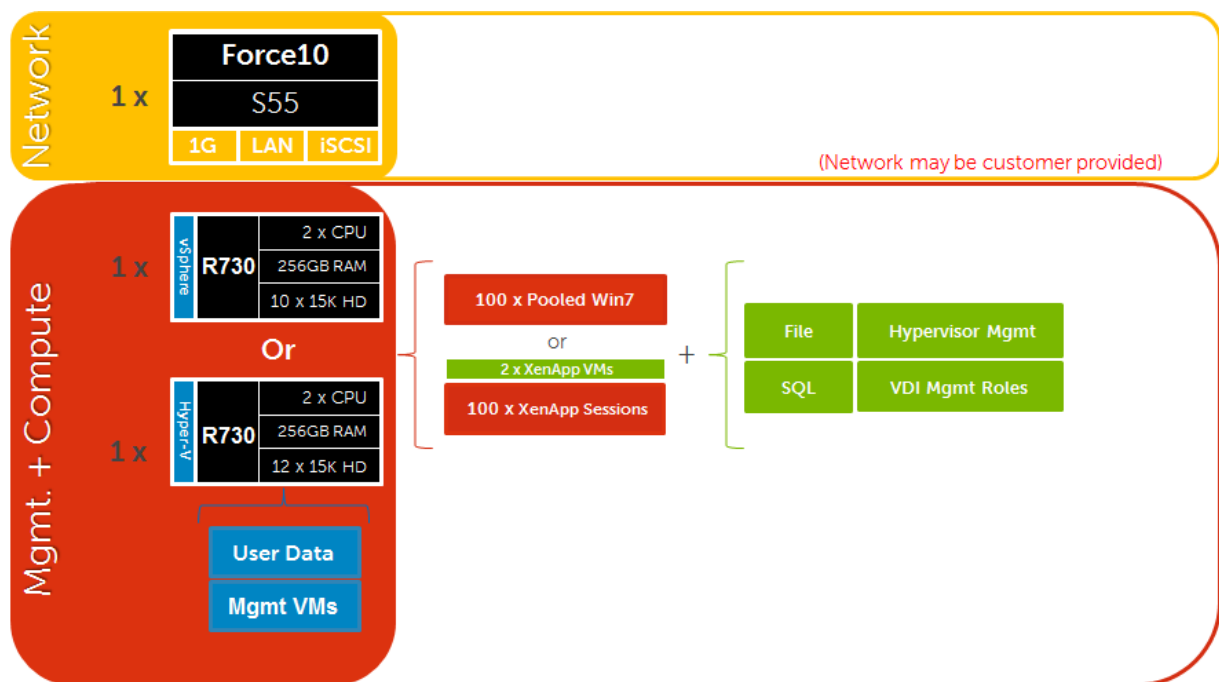


2.2 Local Tier 1

2.2.1 Pilot Offerings

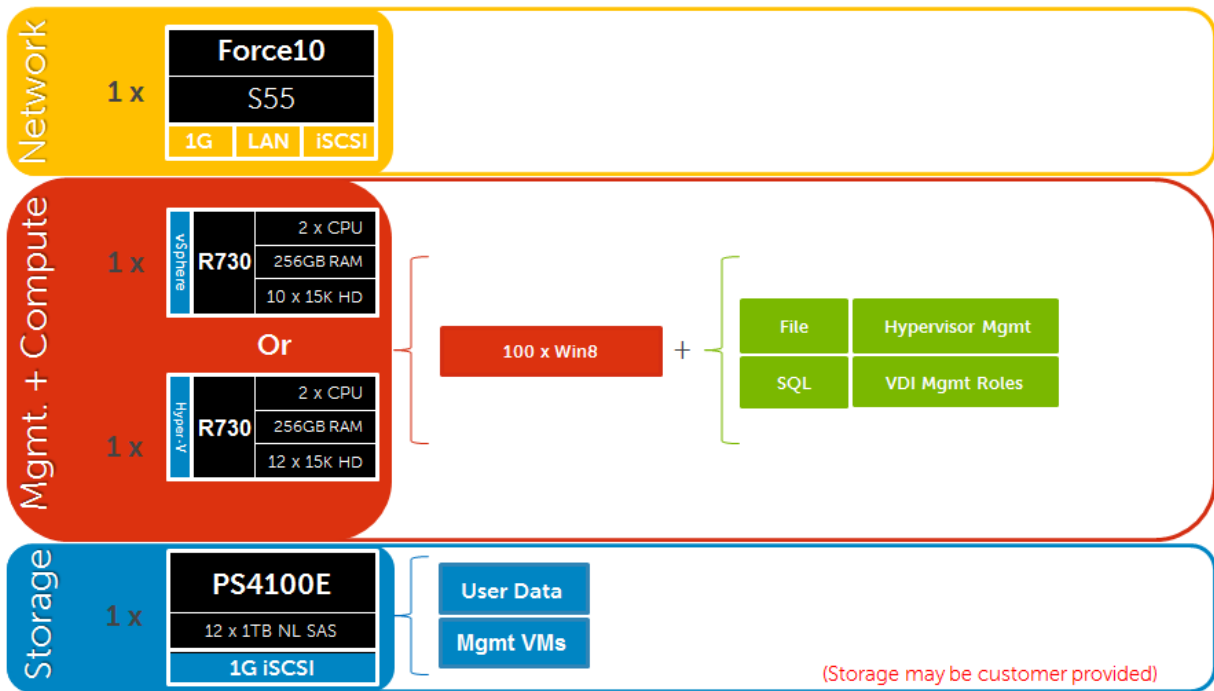
2.2.1.1 100 User Combined Pilot

For a very small deployment or pilot effort to familiarize oneself with the solution architecture, we offer a 100 user combined pilot solution. This architecture is non-distributed with all VDI, Management, and storage functions on a single host running either vSphere or Hyper-V. If additional scaling is desired, you can grow into a larger distributed architecture seamlessly with no loss on initial investment. Our recommended delivery mechanism for this architecture is Citrix Machine Creation Services (MCS).



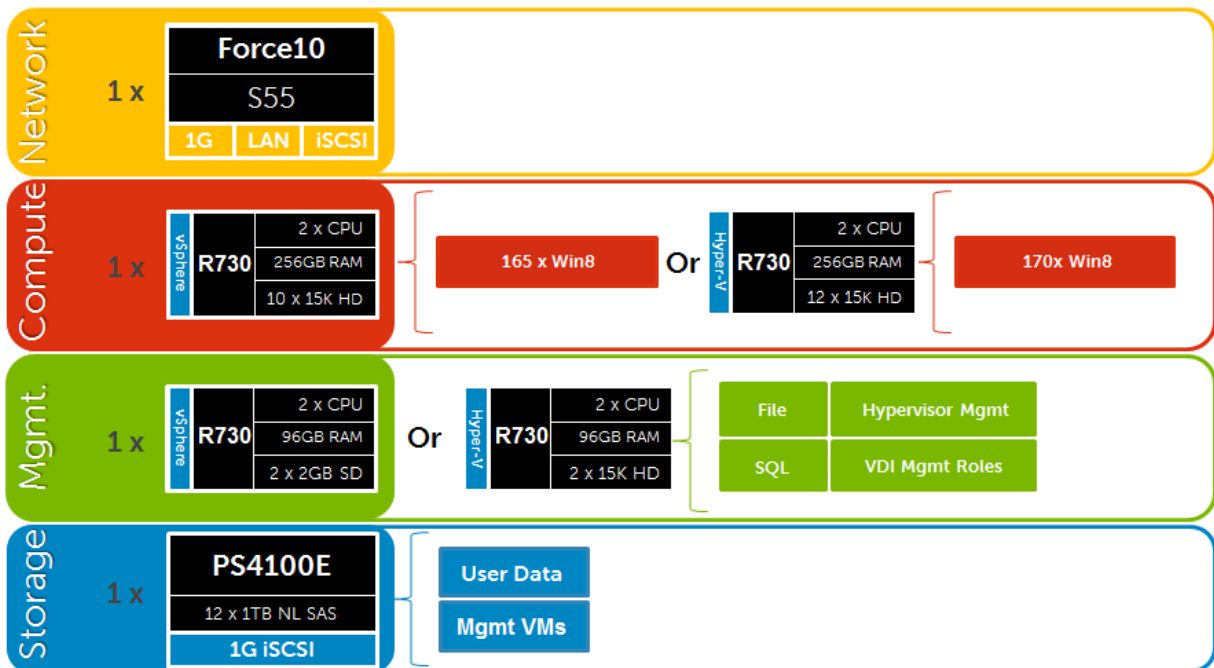
2.2.1.2 100 User Scale Ready Pilot

In addition to the 100 user combined offering we also offer a scale ready version that includes Tier 2 storage. The basic architecture is the same but customers looking to scale out quickly benefit by building out into Tier 2 initially.



2.2.2 Local Tier 1 for Rack Servers (iSCSI)

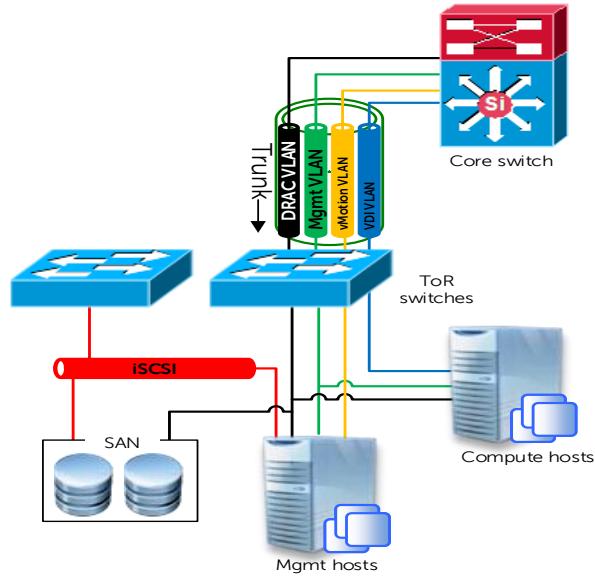
The Local Tier 1 solution model provides a scalable rack-based configuration that hosts user VDI sessions on local disk in the compute layer. vSphere or Hyper-V based solutions are available and scale based on the chosen hypervisor.



2.2.2.1 Local Tier 1 – Network Architecture (iSCSI)

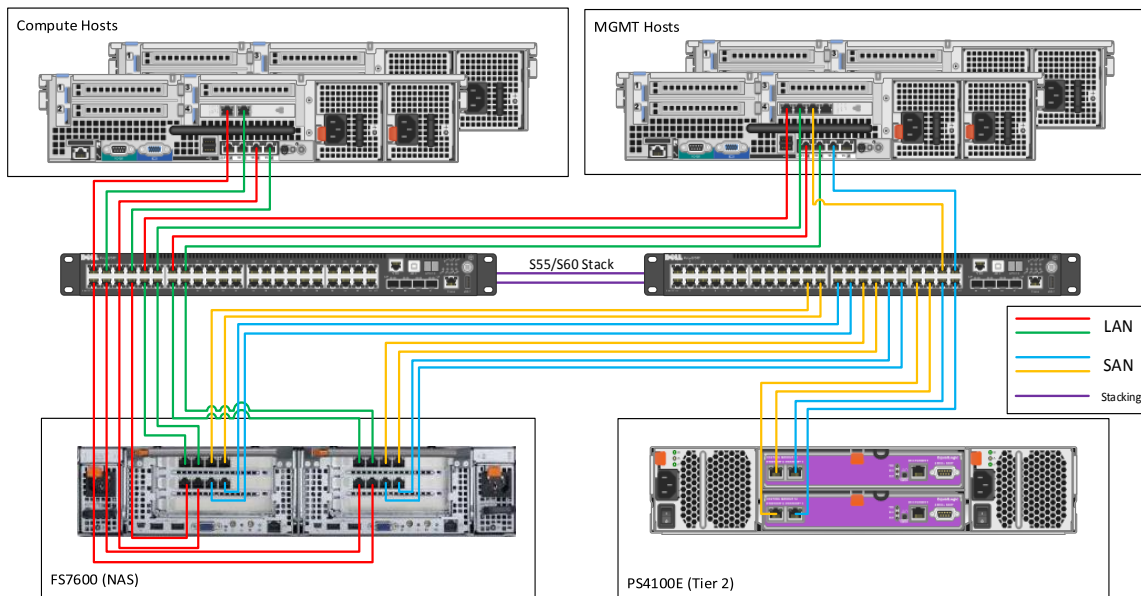
In the Local Tier 1 architecture, a single Force10 switch is shared among all network connections for both management and compute, up to 1000 users. Over 1000 users Dell Wyse Solutions

Engineering recommends separating the network Fabrics to isolate iSCSI and LAN traffic as well as making each switch stack redundant. Only the management servers connect to iSCSI storage in this model. All Top of Rack (ToR) traffic has been designed to be layer 2 (L2)/ switched locally, with all layer 3 (L3)/ routable VLANs trunked from a core or distribution switch. The following diagrams illustrate the logical data flow in relation to the core switch.

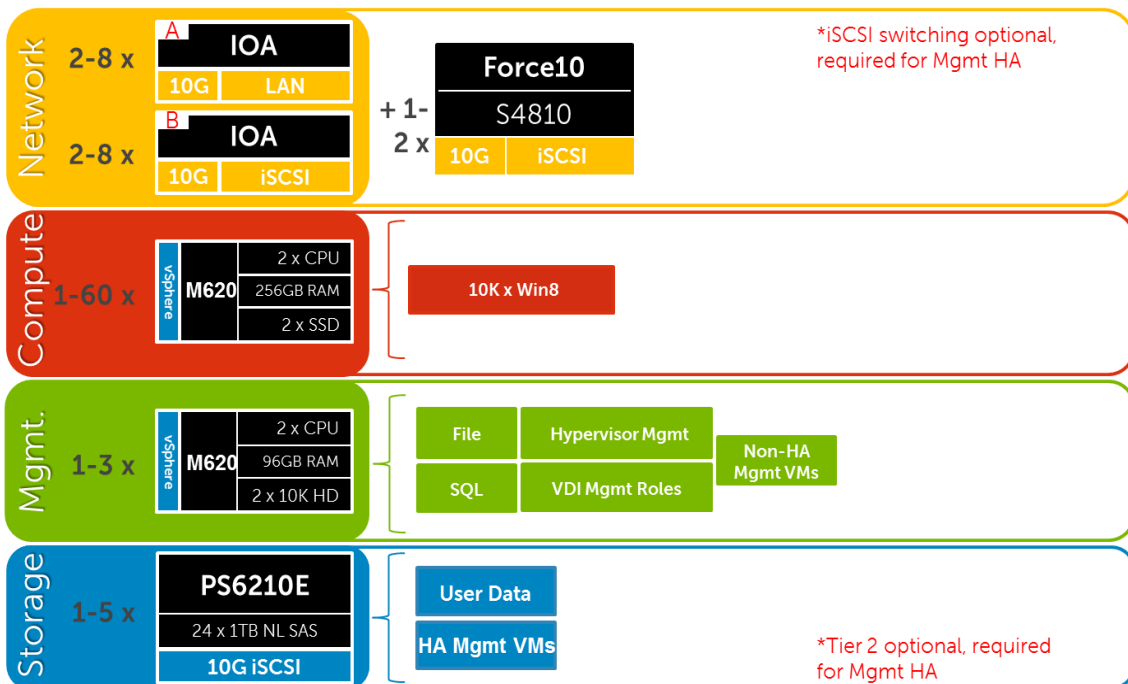

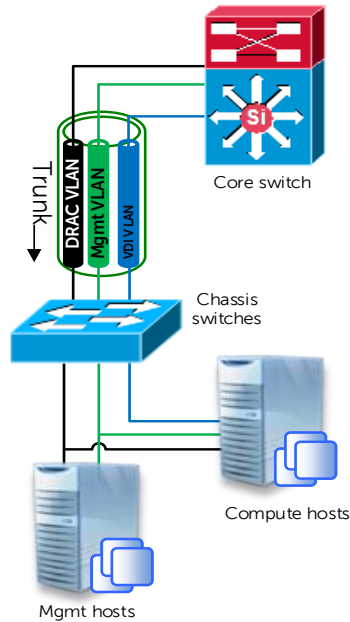
2.2.3 Local Tier 1 for Blade Servers

The Local Tier 1 solution model for blade servers provides a high-performance configuration that does not require shared storage but Tier 2 is added to provide HA to the management layer infrastructure. User VDI sessions are hosted locally on SSDs in each blade server using Citrix MCS for desktop delivery. Only a pair of PowerEdge M I/O Aggregator switches is required in the A Fabric. The B Fabric, ToR iSCSI switches and Tier 2 storage are optional.



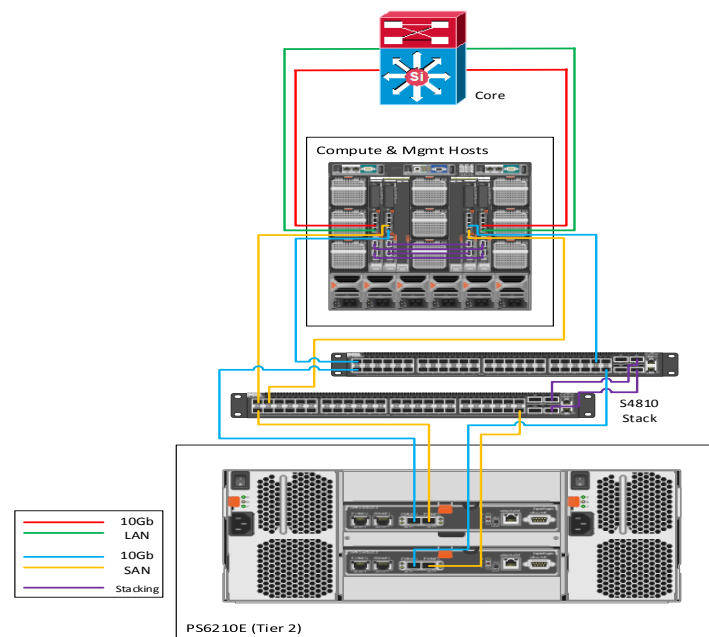
2.2.3.1 Local Tier 1 – Network Architecture

In the Local Tier 1 architecture for blades, there is no need for a ToR switch unless iSCSI is present for HA. The A Fabric IOA switches can connect directly to the core or distribution network layer. Both Management and Compute servers connect to all VLANs in this model via a single vSwitch. The following diagram illustrates the server NIC to chassis switch connections, vSwitch assignments, as well as logical VLAN flow in relation to the core switch.



2.2.3.2 Local Tier 1 – Cabling (Blades - HA)

The following diagram depicts the LT1 blade solution including optional components for HA. The A Fabric, B Fabric and ToR switches are stacked, respectively.



2.2.3.3 Local Tier 1 – Blade Scaling Guidance

If limited rack depth is an issue at higher user scales, the 6210E are used in lieu of the 6510E.

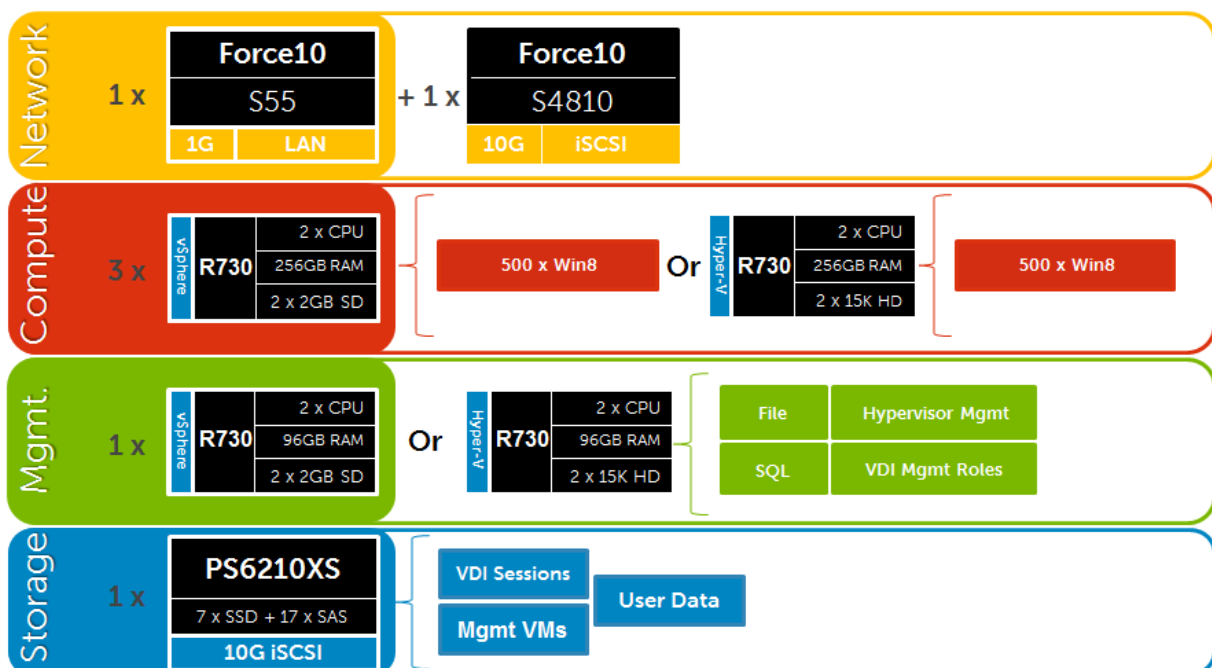

2.3 Shared Tier 1 Rack

Shared Tier 1 for rack servers incorporates shared Tier 1 storage used for execution of VDI sessions.

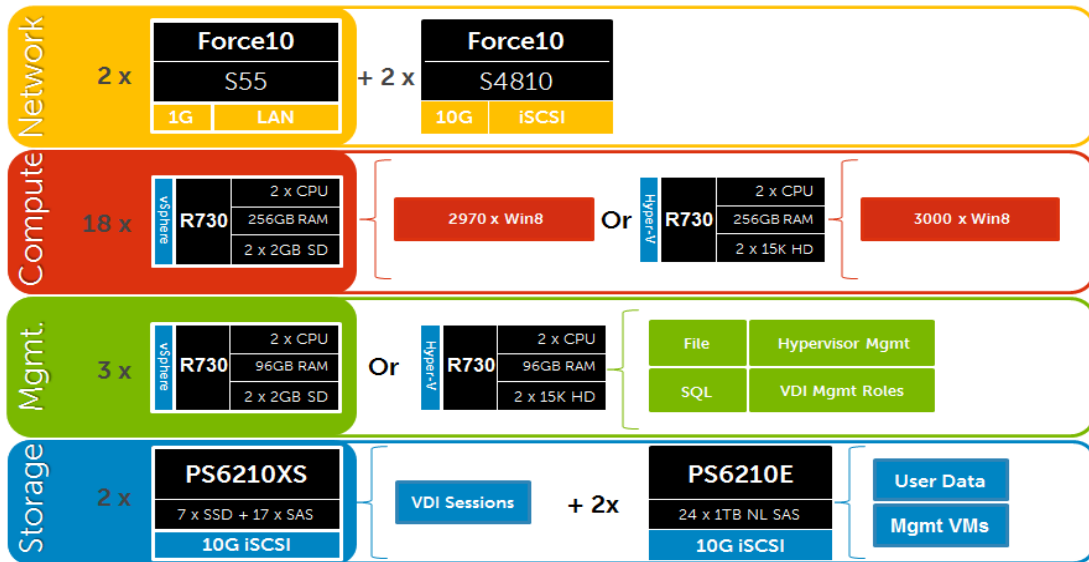
2.3.1 Shared Tier 1 – Rack – 500 Users (iSCSI – EQL)

For POCs or small deployments, Tier1 and Tier2 are combined on a single 6210XS storage array. Above 500 users, a separate array is used for Tier 2.



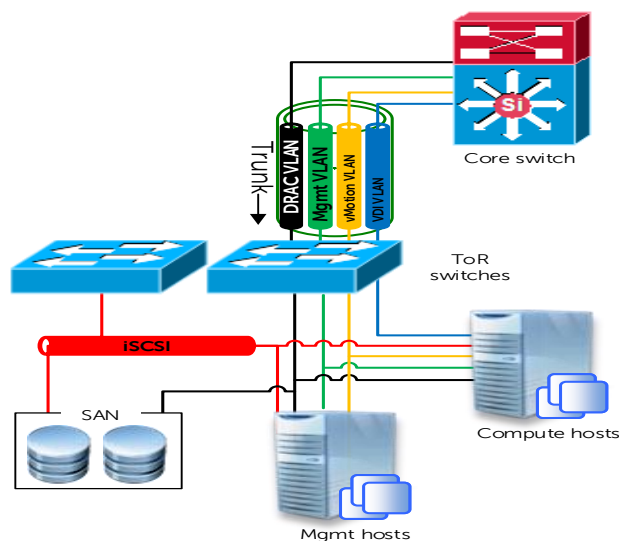
2.3.2 Shared Tier 1 – Rack (iSCSI – EQL)

For over 500 users on EqualLogic, the storage layers are separated into discrete arrays. The figure below depicts a 3000 user build with separate network Fabrics for LAN and iSCSI traffic. Additional 6210XS arrays are added for Tier 1 as the user count scales, just as the Tier 2 array models change also based on scale. The 4110E, 6210E, and 6510E are 10Gb Tier 2 array options. NAS is recommended above 1000 users to provide HA for file services.

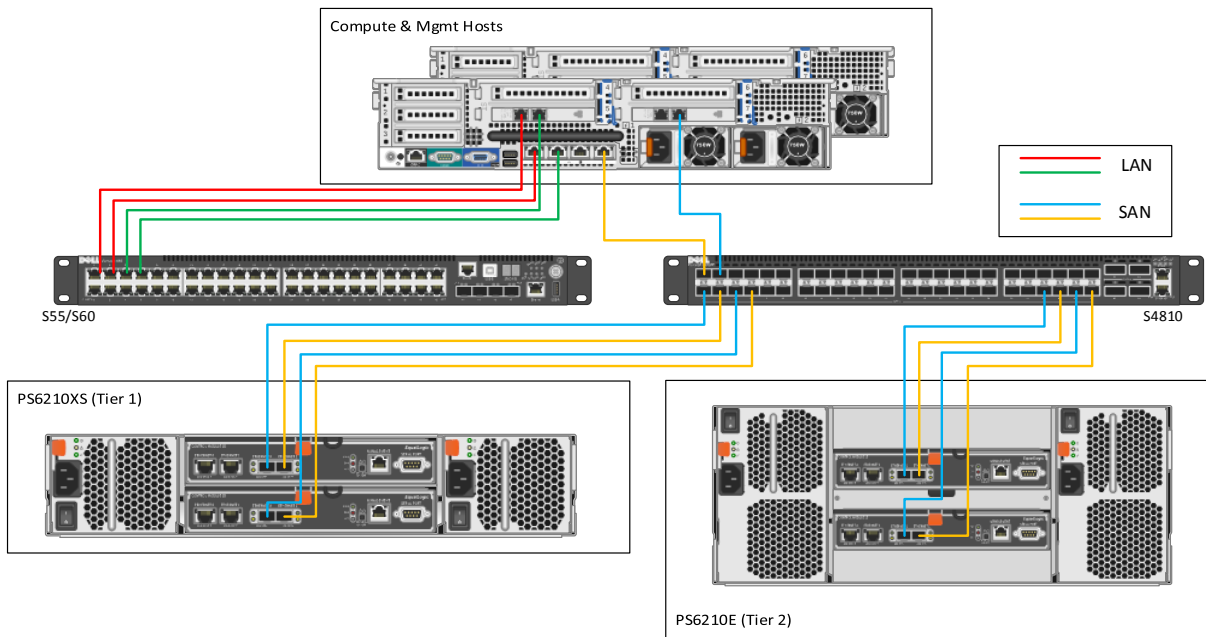


2.3.2.1 Shared Tier 1 Rack – Network Architecture (iSCSI)

In the Shared Tier 1 architecture for rack servers, both management and compute servers connect to shared storage. All ToR traffic has designed to be layer 2/ switched locally, with all layer 3/ routable VLANs routed through a core or distribution switch. The following diagrams illustrate the server NIC to ToR switch connections, vSwitch assignments, as well as logical VLAN flow in relation to the core switch.

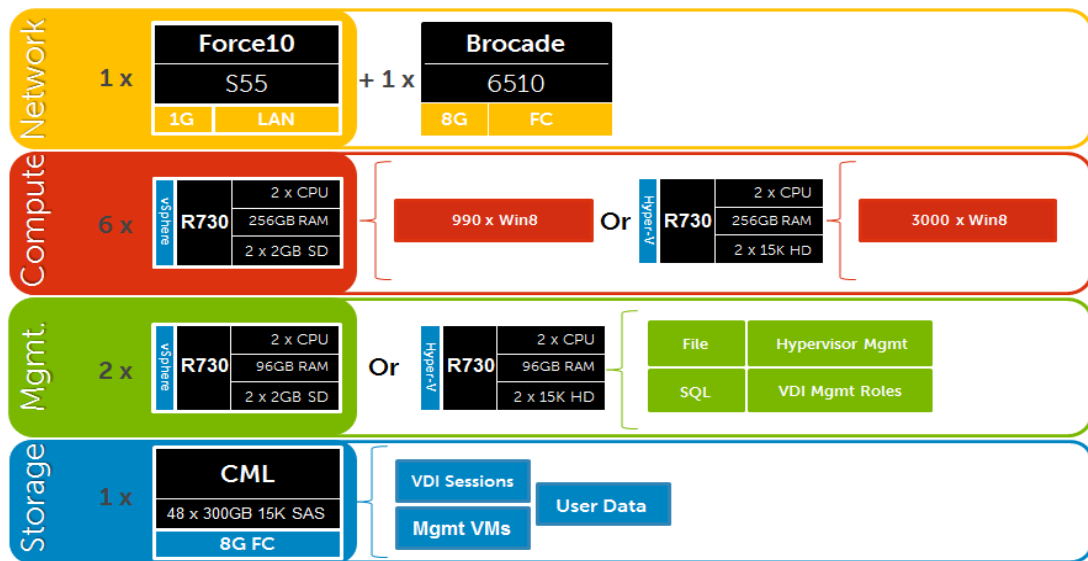

2.3.3 Shared Tier 1 – Rack – 1000 Users (FC – CML)

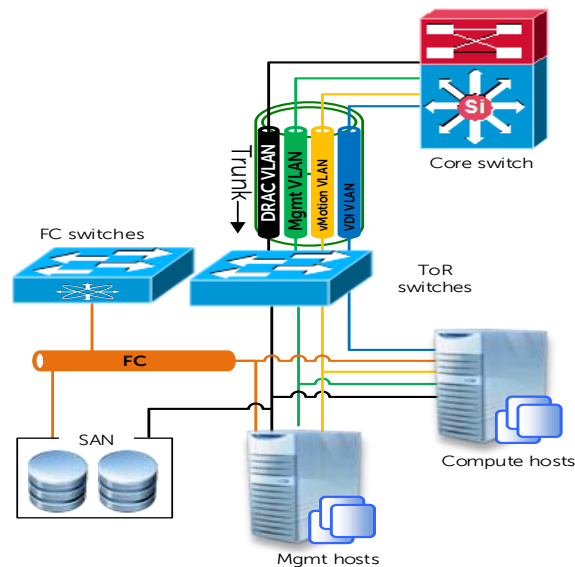
Utilizing Compellent storage for Shared Tier 1 provides a fiber channel (FC) solution where Tier 1 and Tier 2 can optionally be combined in a single array. Tier 2 functions (user data + Mgmt VMs) are removed from the array if the customer has another Tier 2 solution in place or if a Tier 2 Compellent array is used. Scaling this solution is very linear by predictably adding Compellent arrays

for every 2000 basic users, on average. The image below depicts a 1000 user array. For 2000 users, 96 total disks in 4 shelves are required. Please see section 3.3.3 for more information.

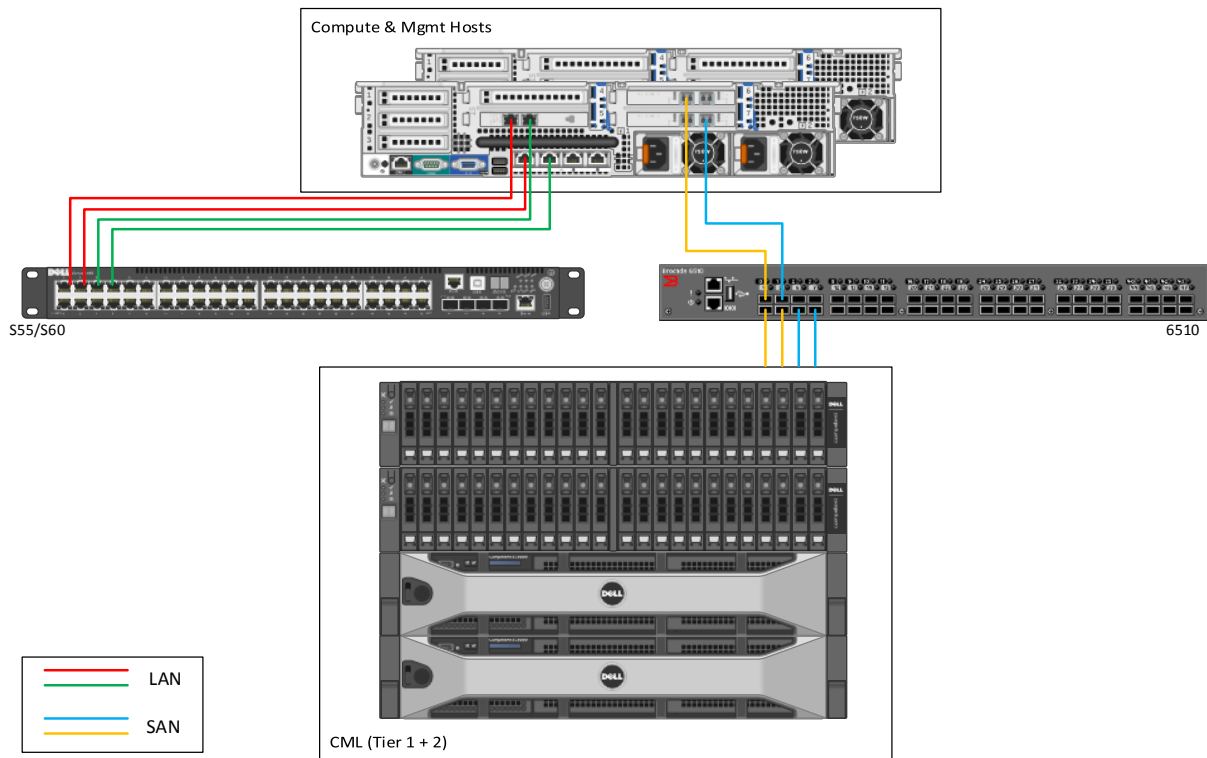


2.3.3.1 Shared Tier 1 Rack – Network Architecture (FC)

In the Shared Tier 1 architecture for rack servers using FC, a separate switching infrastructure is required for FC. Management and compute servers both connect to shared storage using FC. Both management and compute servers connect to all network VLANs in this model. All ToR traffic has designed to be layer 2/ switched locally, with all layer 3/ routable VLANs routed through a core or distribution switch. The following diagrams illustrate the server NIC to ToR switch connections, vSwitch assignments, as well as logical VLAN flow in relation to the core switch.

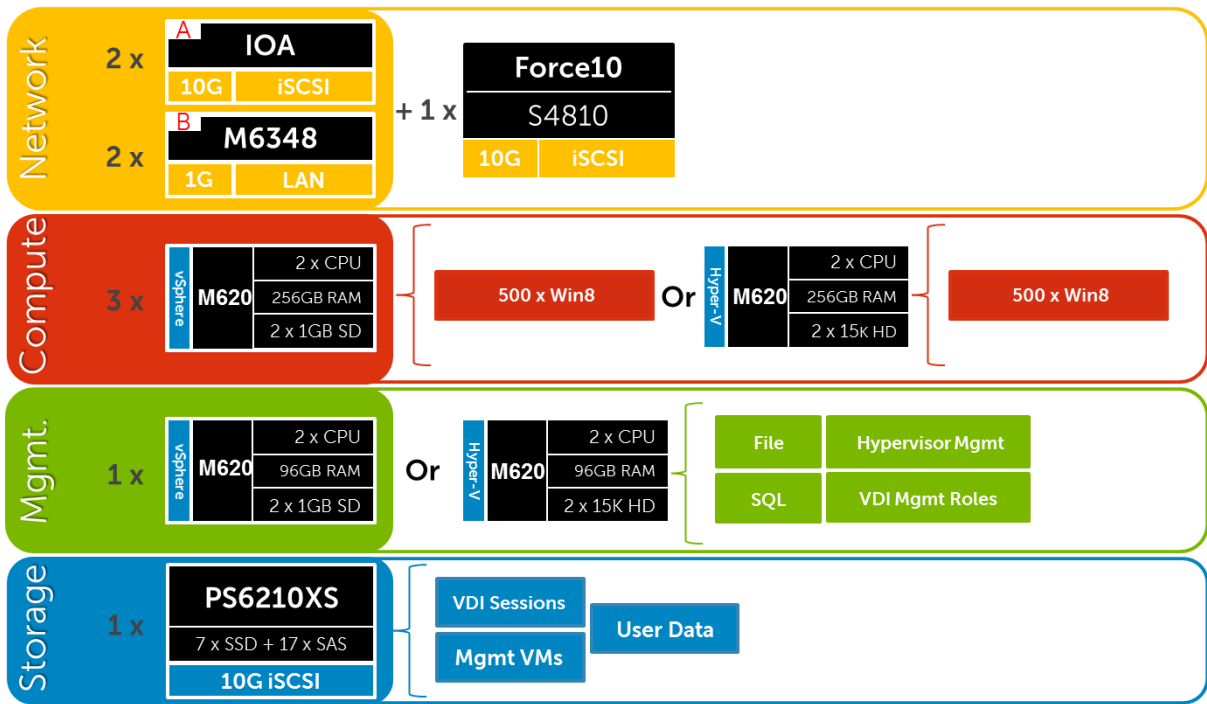

2.4 Shared Tier 1 Blade

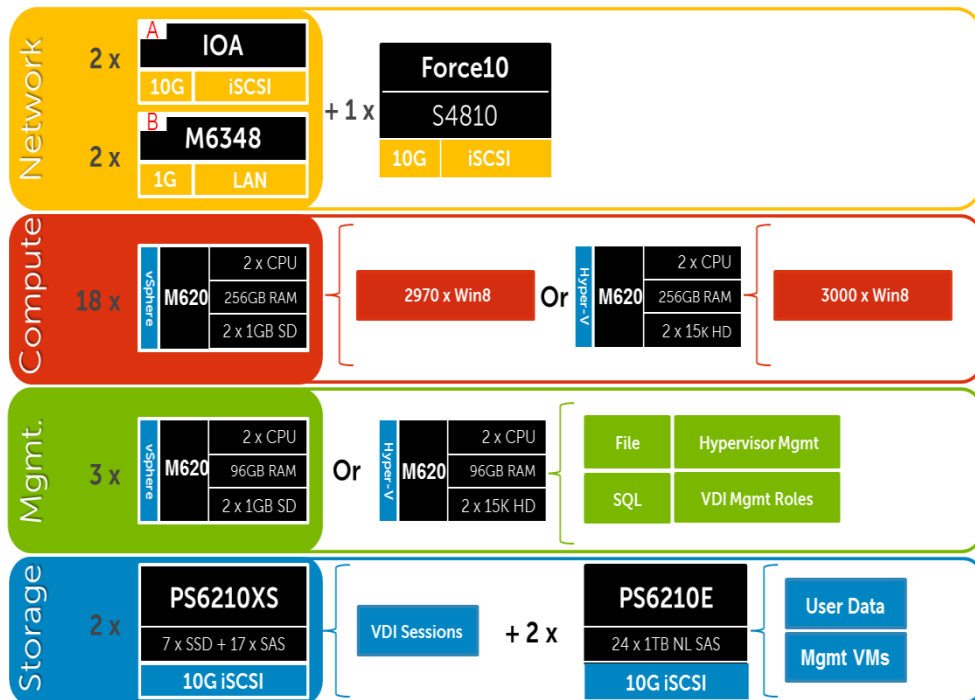
2.4.1 Shared Tier 1 – Blade – 500 users (iSCSI – EQL)

As is the case in the Shared Tier 1 model using rack servers, blades can also be used in a 500 user bundle by combining Tier 1 and Tier 2 on a single 6210XS array. Above 500 users, separate Tier 1 and Tier 2 storage into discrete arrays.



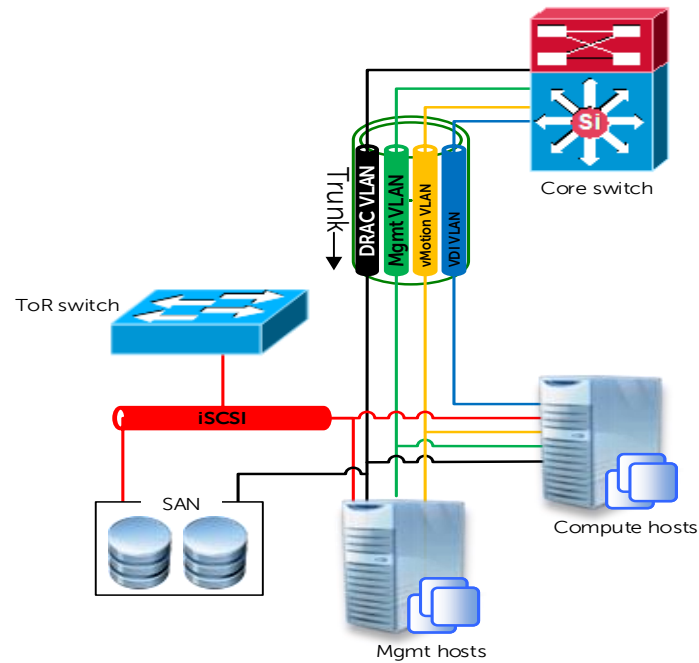
2.4.2 Shared Tier 1 – Blade (iSCSI – EQL)

Above 1000 users the Storage Tiers need to be separated to maximize the performance of the 6210XS for VDI sessions. At this scale we also separate LAN from iSCSI switching. Load balancing and NAS are added optionally for HA. The figure below depicts a 3000 user solution:

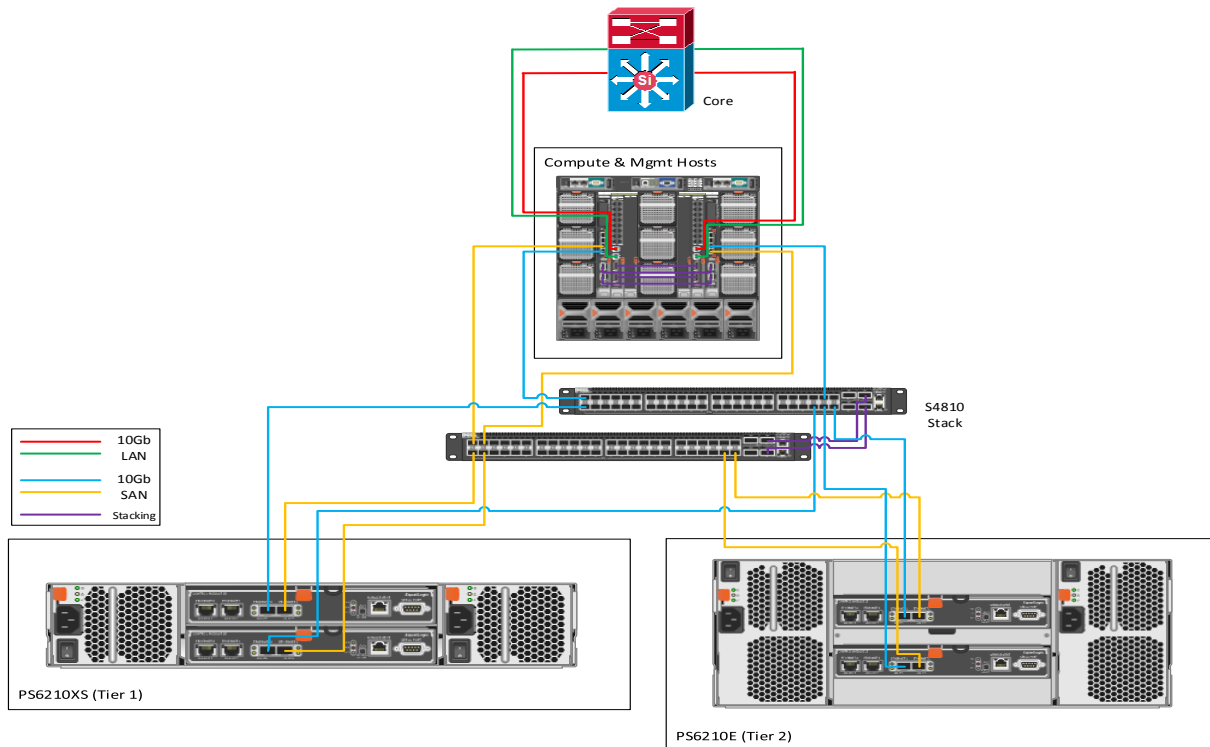


2.4.2.1 Shared Tier 1 Blade – Network Architecture (iSCSI)

In the Shared Tier 1 architecture for blades, only iSCSI is switched through a ToR switch. There is no need to switch LAN ToR since the M6348 in the chassis supports LAN to the blades and are uplinked to the core or distribution layers directly. The M6348 has 16 external ports per switch that are optionally used for DRAC/ IPMI traffic. For greater redundancy, a ToR switch is used to support iDRAC/IPMI used outside of the chassis. Both Management and Compute servers connect to all VLANs in this model. The following diagram illustrates the chassis switch uplink ports to ToR/ core switch connections, vSwitch assignments, as well as logical VLAN flow in relation to the core switch.

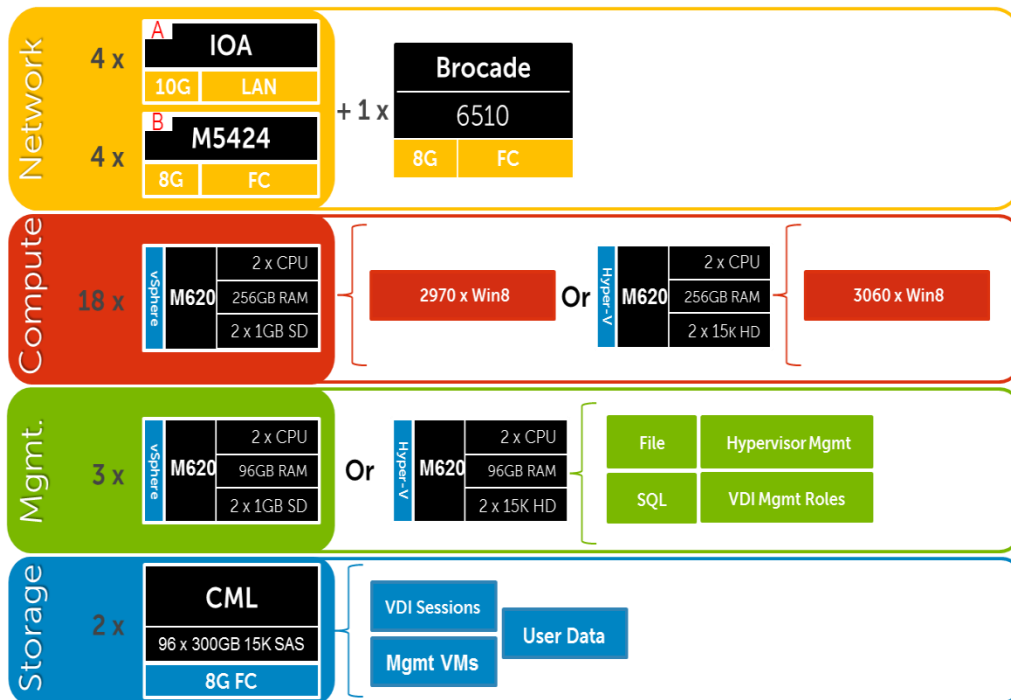

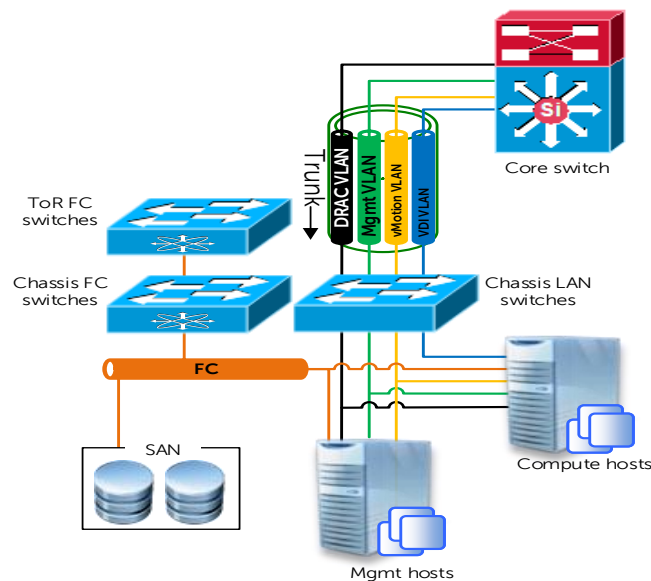

2.4.3 Shared Tier 1 – Blade (FC – CML)

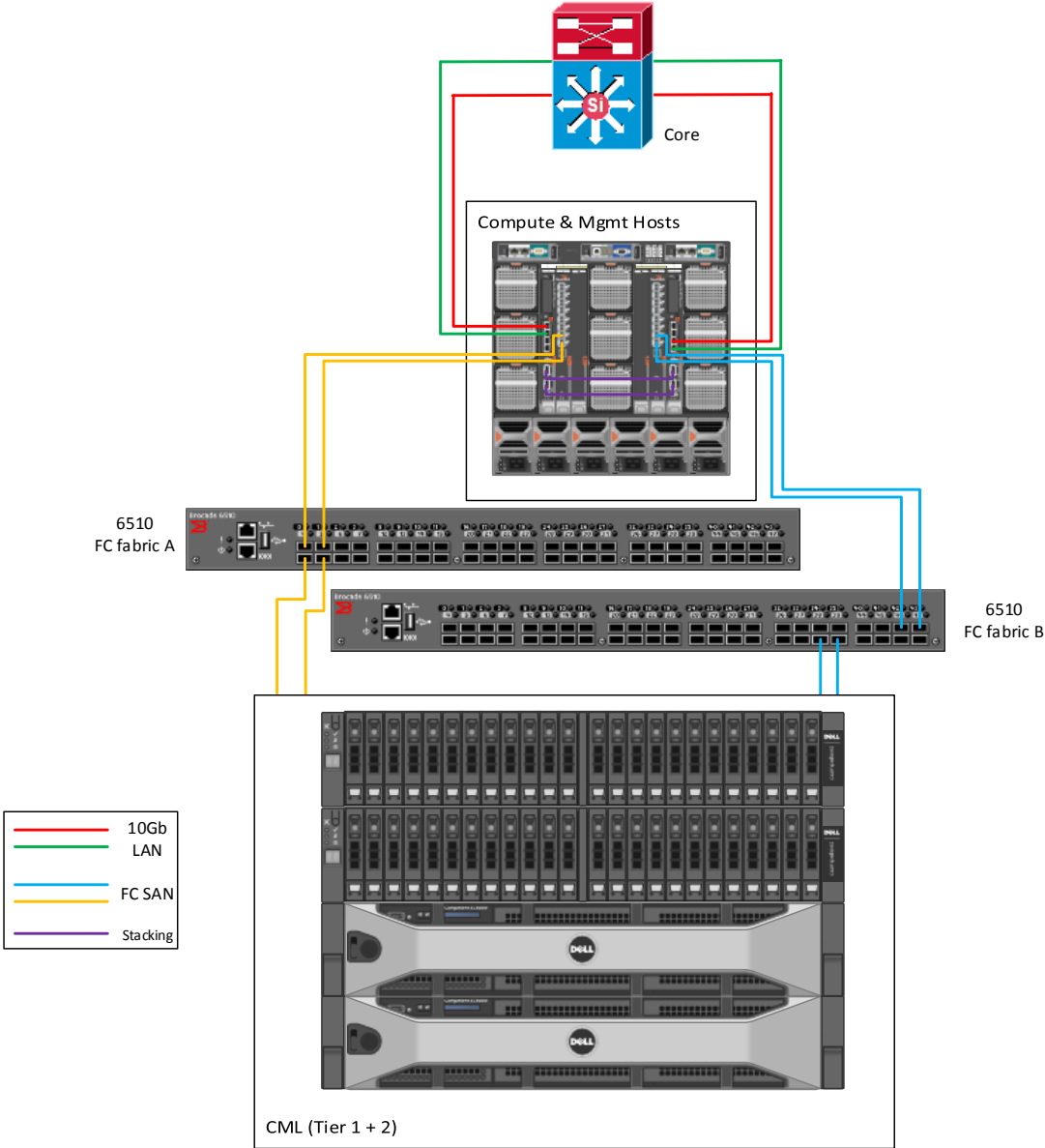
Fiber channel is also an option in the Shared Tier 1 model for blades. There are a few key differences using FC with blades instead of iSCSI: Blade chassis interconnects, FC HBAs in the servers, and FC IO cards in the Compellent arrays. ToR FC switching is optional if a suitable FC infrastructure is already in place. The image below depicts a 4000 user stack.

3 Hardware Components

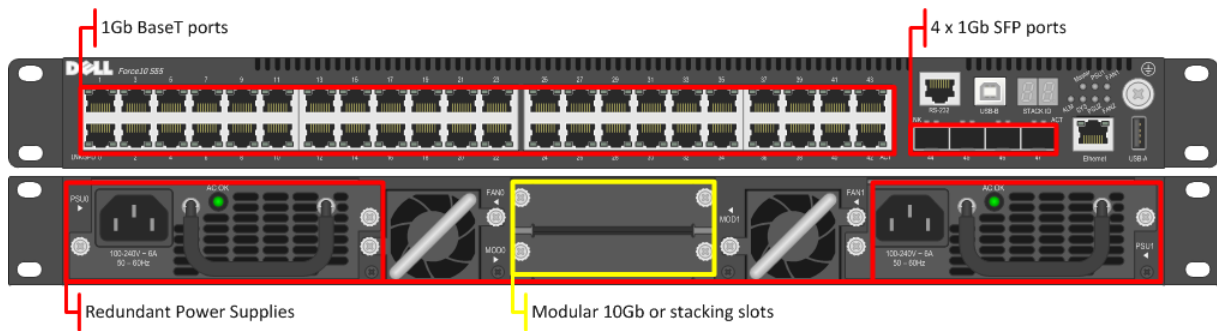
3.1 Network

The following sections contain the core network components for the Dell Wyse Datacenter solutions. General uplink cabling guidance to consider in all cases is that TwinAx is very cost effective for short 10Gb runs and for longer runs use fiber with SFPs.

3.1.1 Force10 S55 (ToR Switch)

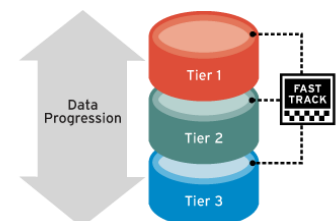
Each tier of EqualLogic storage has to be managed as a separate pool or group to isolate specific workloads. Manage shared Tier 1 arrays used for hosting VDI sessions together, while managing shared Tier 2 arrays used for hosting Management server role VMs and user data together.



3.3.4 Compellent Storage (FC)

Dell Wyse Solutions Engineering recommends that all Compellent storage arrays be implemented using two controllers in an HA cluster. Fiber Channel is the preferred storage protocol for use with this array, but Compellent is fully capable of supporting iSCSI as well. Key Storage Center applications used strategically to provide increased performance include:

- Fast Track – Dynamic placement of most frequently accessed data blocks on the faster outer tracks of each spinning disk. Lesser active data blocks remain on the inner tracks. Fast track is well-complimented when used in conjunction with Thin Provisioning.



- Data Instant Replay – Provides continuous data protection using snapshots called Replays. Once the base of a volume has been captured, only incremental changes are then captured going forward. This allows for a high number of Replays to be scheduled over short intervals, if desired, to provide maximum protection.

3.3.4.1 Compellent Tier 1

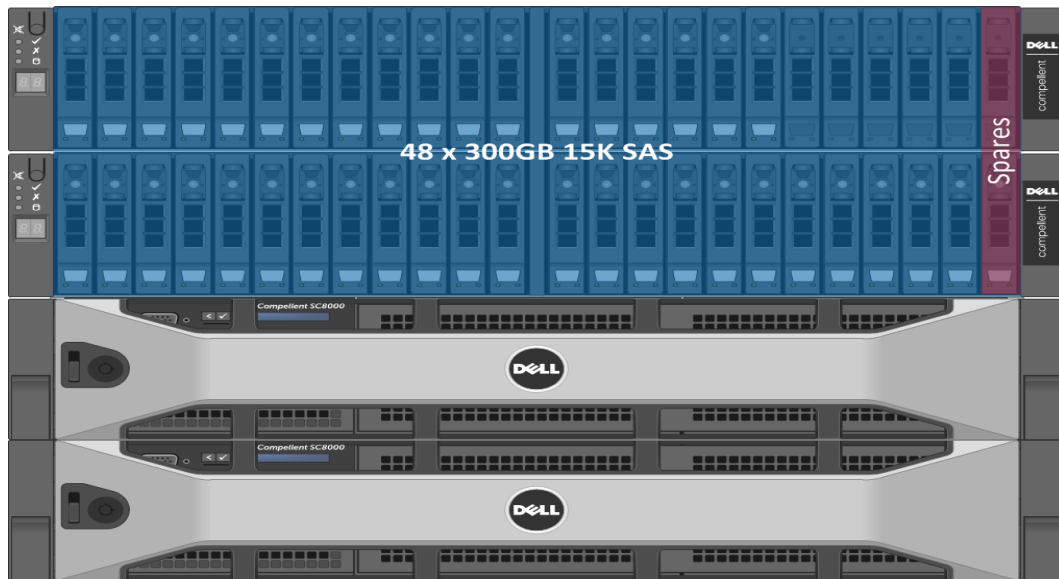
Compellent Tier 1 storage consists of a standard dual controller configuration and scales upward by adding disks/ shelves and additional discrete arrays. A single pair of SC8000 controllers will support Tier 1 and Tier 2 for up to 2000 knowledge worker users, as depicted below, utilizing all 15K SAS disks. If Tier 2 is to be separated then an additional 30% of users are added per Tier 1 array. Scaling above this number, additional arrays will need to be implemented. 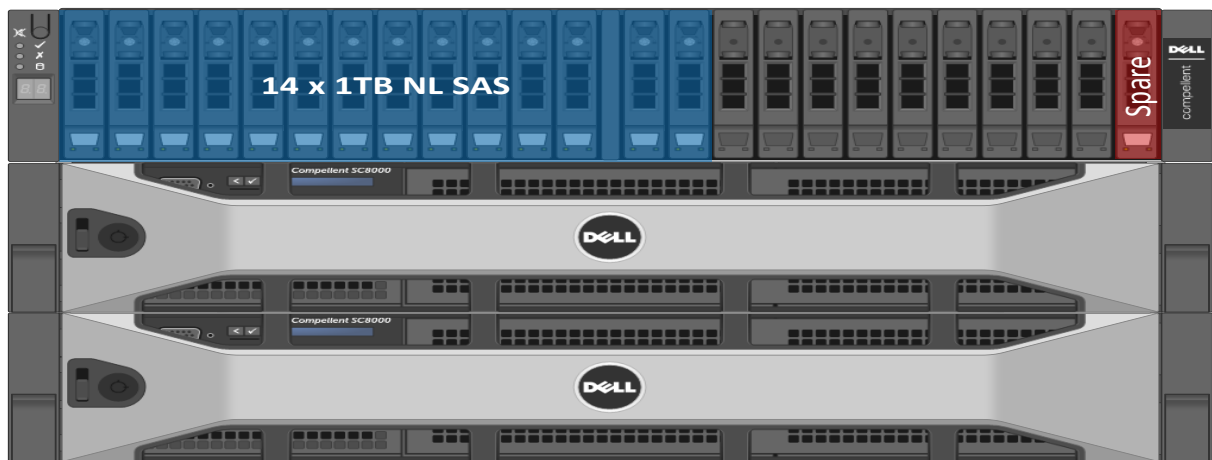

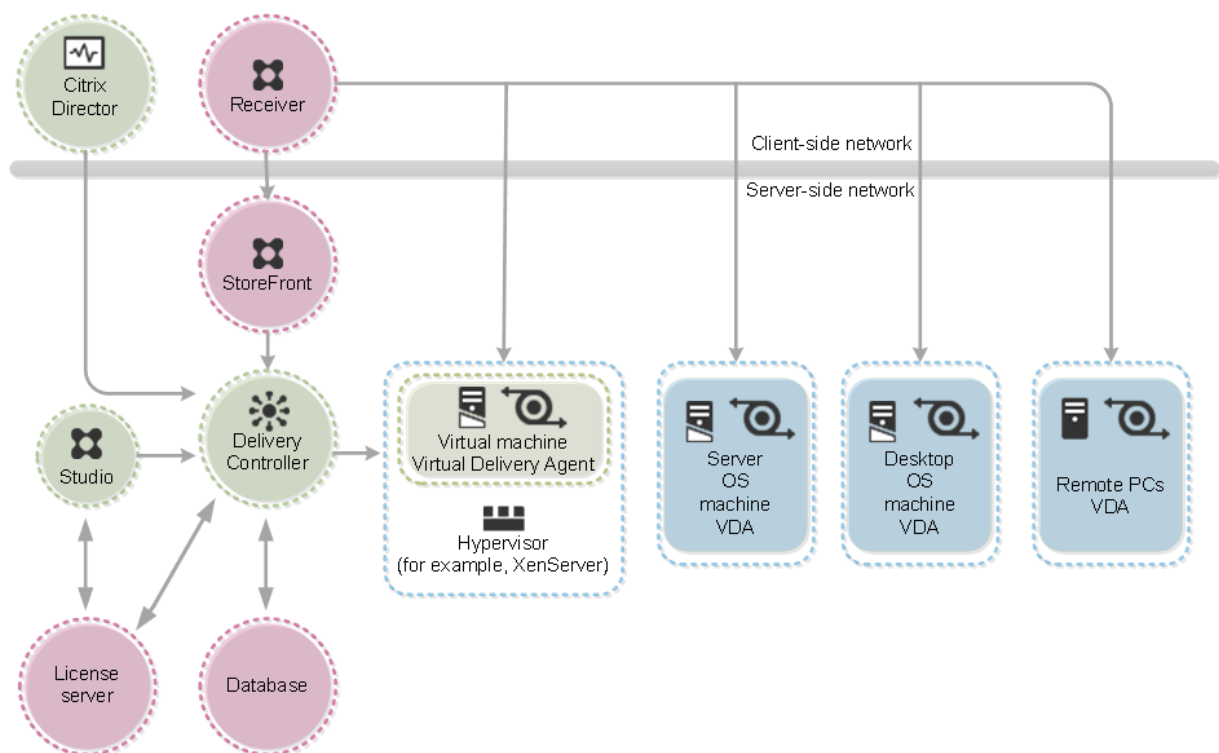


4 Software Components

4.1 Citrix XenDesktop

The solution is based on Citrix XenDesktop 7.6 which provides a complete end-to-end solution delivering Microsoft Windows virtual desktops or server-based hosted shared sessions to users on a wide variety of endpoint devices. Virtual desktops are dynamically assembled on demand, providing users with pristine, yet personalized, desktops each time they log on.

Citrix XenDesktop provides a complete virtual desktop delivery system by integrating several distributed components with advanced configuration tools that simplify the creation and real-time management of the virtual desktop infrastructure.



The core XenDesktop components include:

- **Studio**

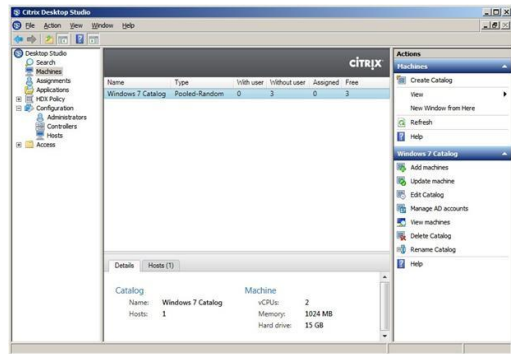
Studio is the management console that enables you to configure and manage your deployment, eliminating the need for separate management consoles for managing delivery of applications and desktops. Studio provides various wizards to guide you through the process of setting up your environment, creating your workloads to host applications and desktops, and assigning applications and desktops to users.

- **Director**
Director is a web-based tool that enables IT support teams to monitor an environment, troubleshoot issues before they become system-critical, and perform support tasks for end users. You can also view and interact with a user's sessions using Microsoft Remote Assistance.
- **Receiver**
Installed on user devices, Citrix Receiver provides users with quick, secure, self-service access to documents, applications, and desktops from any of the user's devices including smartphones, tablets, and PCs. Receiver provides on-demand access to Windows, Web, and Software as a Service (SaaS) applications.
- **Delivery Controller (DC)**
Installed on servers in the data center, the controller authenticates users, manages the assembly of users' virtual desktop environments, and brokers connections between users and their virtual desktops.
- **StoreFront**
StoreFront authenticates users to sites hosting resources and manages stores of desktops and applications that user's access.
- **License Server**
The Citrix License Server is an essential component at any Citrix-based solution. Every Citrix product environment must have at least one shared or dedicated license server. License servers are computers that are either partly or completely dedicated to storing and managing licenses. Citrix products request licenses from a license server when users attempt to connect.
- **Machine Creation Services (MCS)**
A collection of services that work together to create virtual servers and desktops from a master image on demand; optimizing storage utilization and providing a pristine virtual machine to users every time they log on. Machine Creation Services is fully integrated and administrated in Citrix Studio.
- **Provisioning Services (PVS)**
The Provisioning Services infrastructure is based on software-streaming technology. This technology allows computers to be provisioned and re-provisioned in real-time from a single shared-disk image.
- **Virtual Delivery Agent (VDA)**
The Virtual Desktop Agent is a transparent plugin that is installed on every virtual desktop or XenApp host (RDSH) and enables the direct connection between the virtual desktop and users' endpoint devices.

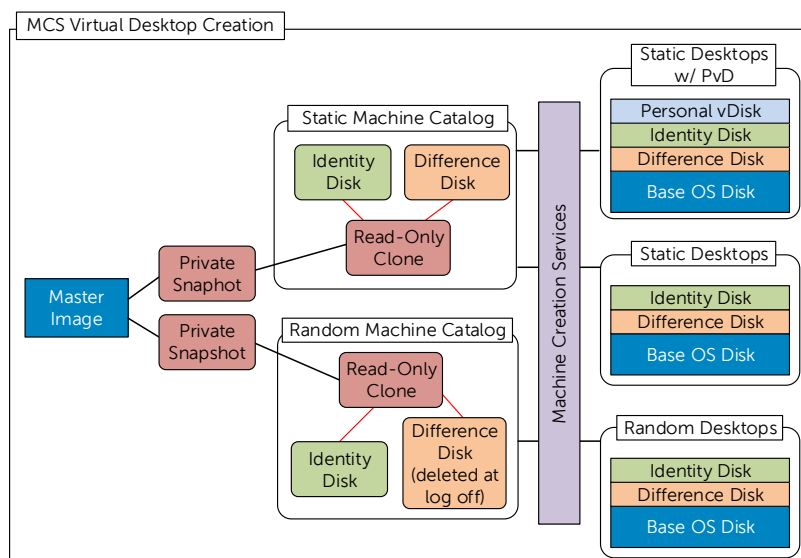
4.1.1 Machine Creation Services (MCS)

Citrix Machine Creation Services is the native provisioning mechanism within Citrix XenDesktop for virtual desktop image creation and management. Machine Creation Services uses the hypervisor APIs to create, start, stop, and delete virtual desktop images. Desktop images are organized in a Machine Catalog and within that catalog there are a number of options available to create and deploy virtual desktops:

- **Random:** Virtual desktops are assigned randomly as users connect. When they logoff, the desktop is reset to its original state and made free for another user to login and use. Any changes made by the user are discarded at log off.
- **Static:** Virtual desktops are assigned to the same user every time with three options for how to handle changes made to the desktop: Store on local vDisk, Personal vDisk, or discarded on user log off.



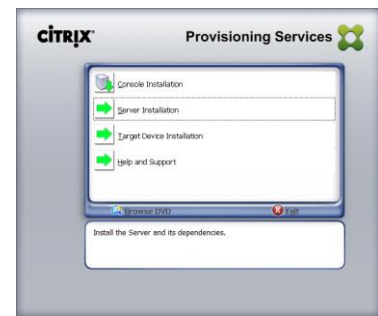
All the desktops in a random or static catalog are based off a master desktop template which is selected during the catalog creation process. MCS then takes snapshots of the master template and layers two additional virtual disks on top: an Identity vDisk and a Difference vDisk. The Identity vDisk includes all the specific desktop identity information such as host names and passwords. The Difference vDisk is where all the writes and changes to the desktop are stored. These Identity and Difference vDisks for each desktop are stored on the same data store as their related clone.



While traditionally used for small to medium sized XenDesktop deployments, MCS can bring along with it some substantial Tier 1 storage cost savings because of the snapshot/identity/difference disk methodology. The Tier 1 disk space requirements of the identity and difference disks when layered on top of a master image snapshot, is far less than that of a dedicated desktop architecture.

4.1.2 Provisioning Services (PVS)

PVS is an alternative method of image provisioning which uses streaming to share a single base vDisk image instead of copying images to VMs. PVS are used to deliver shared vDisk images to physical or virtual machines. Another potential use is the serial provisioning of XenApp to enable scale-out hosted shared desktop infrastructure. Provisioning Services enables real-time streamed provisioning and re-provisioning which enable administrators to completely eliminate the need to manage and patch individual systems.



Desktop images are organized in a Machine Catalog and within that catalog there are a number of options available to create and deploy virtual or physical desktops:

- **Random:** Virtual or physical desktops are assigned randomly as users connect. When they logoff, the desktop is reset to its original state and made free for another user to login and use. Any changes made by the user are discarded at log off.
- **Static:** Virtual desktops are assigned to the same user every time with user changes stored on a separate Personal vDisk.

Using Provisioning Services, vDisk images are configured in Standard Image mode, read-only, or Private Image mode, read/write. A vDisk in Standard Image mode allows multiple desktops to boot from it simultaneously greatly reducing the number of images that must be maintained and the amount of storage that is otherwise required (non-persistent). Private Image mode vDisks are equivalent to dedicated hard disks and can only be used by one target device at a time (persistent). The Provisioning Server runs on a virtual instance of Windows Server 2012 R2 on the Management Server(s).

4.1.2.1 PVS Write Cache

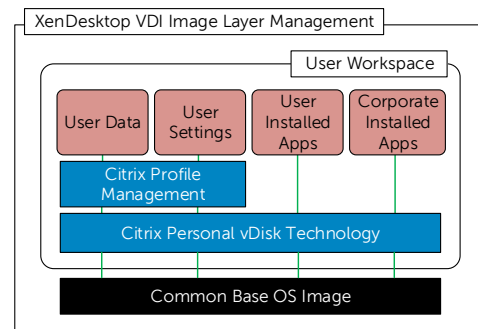
Citrix Provisioning Services delivery of standard images relies on write-caches to store any writes made by the target OS. The most common write-cache implementation places write-cache on the target machine's storage. Independent of the physical or virtual nature of the target machine, this storage has to be allocated and formatted to be usable.

While there are 4 possible locations for storage of the write cache in PVS, the Dell Wyse Datacenter solution recommends placement of the PVS write cache in the target compute host's RAM with overflow enabled. We recommend using a cache size of 512MB for virtual desktops and 21GB for XenApp VMs delivered via PVS.

4.1.3 Personal vDisk

Citrix Personal vDisk is an enterprise workspace virtualization solution that is built into Citrix XenDesktop. Personal vDisk provides the user customization and personalization benefits of a persistent desktop image with the storage savings and performance of a single/shared image.

Used in conjunction with a static desktop experience, Citrix Personal vDisk allows each user to receive personal storage in the form of a layered vDisk (3GB minimum). This personal vDisk enables users to personalize and persist their desktop environment while providing storage for any user or departmental apps.



Personal vDisk provides the following benefits to XenDesktop:

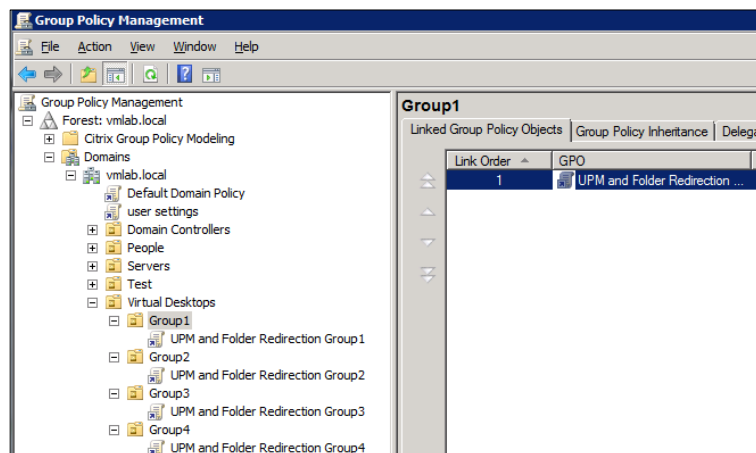
- Persistent personalization of user profiles, settings and data
- Enables deployment and management of user installed and entitlement based applications
- Fully compatible with Microsoft SCCM and App-V
- 100% persistence with VDI pooled Storage management
- Near Zero management overhead

4.1.4 Citrix Profile Manager

Citrix Profile Management is a component of the XenDesktop suite which is used to manage user profiles and minimize many of the issues associated with traditional Windows roaming profiles in an environment where users may have their user profile open on multiple devices at the same time. The profile management toolset has two components: the profile management agent, installed on any device where the user profiles is managed, and a Group Policy Administrative Template, which is imported to a group policy.

In order to further optimize, the profile management folders within the user profile is redirected the users' home drive. The folder redirection is managed via group policy objects within Active Directory. The following folders are redirected:

- Contacts
- Downloads
- Favorites
- Links
- My Documents
- Searches
- Start Menu
- Windows
- My Music



- My Pictures
- My Videos
- Desktop

4.1.5 XenApp

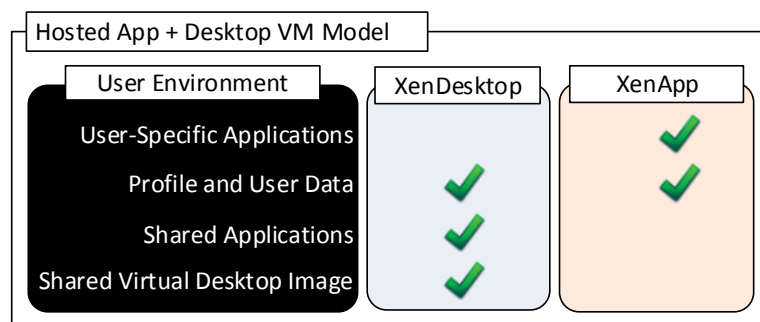
Hosted desktops and applications, delivered via Microsoft XenApp, provide a sensible and low-cost entry into VDI by consolidating many basic task user sessions within a single Windows Server instance (formerly Terminal Services with XenApp). This technology can also be used to augment a XenDesktop deployment by delivering virtualized applications to user desktops via XenApp or App-V. XenDesktop 7 brings greater simplicity to the server hosted model simply by leveraging the Citrix Virtual Delivery Agent (VDA) installed within the Windows Server OS. The management infrastructure between desktop OS (desktop VMs) and server OS (XenApp) deployments is identical.

Hosted applications give users a customized application set with a “locally-installed” experience even though the applications are centrally installed and managed on XenApp servers. This can dramatically simplify the XenDesktop environment by leveraging a widely shared virtual desktop image, while at the same time extending the scalability of XenDesktop by alleviating resource load from the desktop compute servers. This two-Tiered approach to desktop and application delivery brings management simplification, a much quicker return on investment and the absolute best end-user experience.

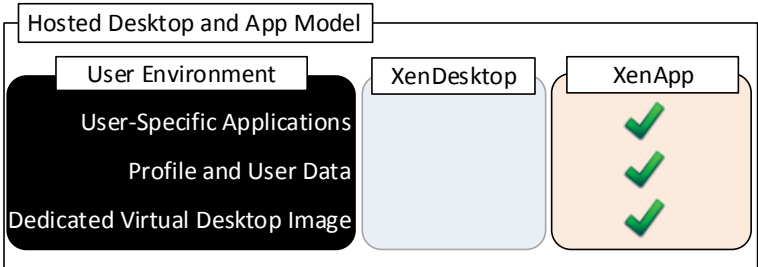
Benefits of hosted desktop sessions and applications:

- Management of applications (single instance)
- Management of simple desktop images (no applications installed)
- PVS to stream XenApp servers as well as user desktops
- Scalability of XenDesktop compute hosts: CPU and IOPS reduction via application offload
- Shared storage scalability: less IOPS = more room to grow

Citrix XenDesktop with XenApp integration can effectively deliver a desktop/application hybrid solution as well. Specifically where a single or small number of shared VDI desktop images are deployed via XenDesktop, each with common shared applications installed within the golden image. A user-specific application set is then deployed and made accessible via the hosted application compute infrastructure, accessible from within the virtual desktop.



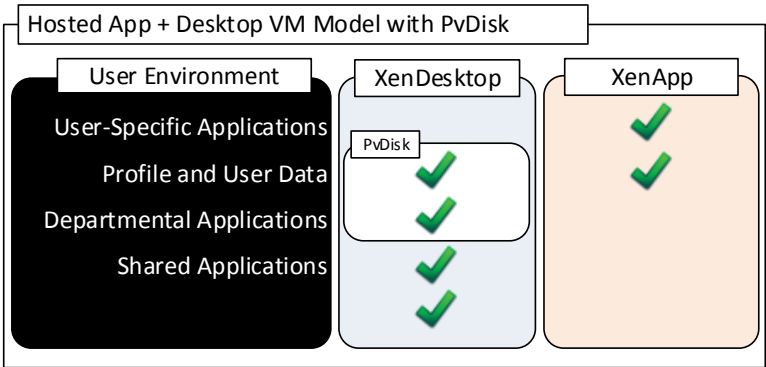
Alternatively, XenApp provides a platform for delivering a Windows server-based sessions to users who may not need a full desktop VM. Hosted desktops increase infrastructure resource utilization while reducing complexity as all applications and sessions are centrally managed.



4.1.5.1 XenDesktop with XenApp and Personal vDisk Integration

In a XenDesktop implementation that leverages hosted applications, these execute from a centralized Windows Server and are then accessed via the Citrix Receiver. There are some instances, however, where certain departmental or custom applications cannot run using XenApp. At the same time for organizational policy or certain storage considerations, delivering these applications as a part of a base image is not possible either. In this case, Citrix Personal vDisk technology is the appropriate solution.

With Citrix Personal vDisk, each user of that single shared virtual desktop image also receives a personal layered vDisk, which enables the user to personalize their desktop and receive native application execution within a Windows client OS and not from a server. When leveraging the integration of XenApp within XenDesktop, all profile and user data is seamlessly accessed within both environments.



4.1.5.2 XenApp Integration into Dell Wyse Datacenter Architecture

The XenApp servers can exist as physical or virtualized instances of Windows Server 2012 R2. A minimum of one (1), up to a maximum of eight (8) virtual servers are installed per physical compute host. Since XenApp instances are easily added to an existing XenDesktop stack, the only additional components required are:

- One or more Server OS instances running the Citrix VDA added to the XenDesktop site

The total number of required virtual XenApp servers is dependent on application type, quantity and user load. Deploying XenApp virtually and in a multi-server farm configuration increases overall farm performance, application load balancing as well as farm redundancy and resiliency.

4.1.5.3 PVS Integration with XenApp

One of the many benefits of PVS is the ability to quickly scale the XenApp instances within a farm. Bandwidth is a key consideration and PVS bandwidth utilization is mostly a function of the number of target devices and the portion of the image(s) they utilize. Network impact considerations include:

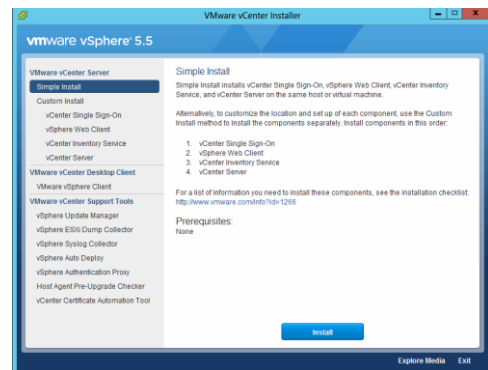
- PVS streaming is delivered via UDP, yet the application has built-in mechanisms to provide flow control, and retransmission as necessary.
- Data is streamed to each target device only as requested by the OS and applications running on the target device. In most cases, less than 20% of any application is ever transferred.
- PVS relies on a cast of supporting infrastructure services. DNS, DHCP need to be provided on dedicated service infrastructure servers, while TFTP and PXE Boot are functions that may be hosted on PVS servers or elsewhere.

4.2 VDI Hypervisor Platforms

4.2.1 VMware vSphere 5

VMware vSphere 5 is a virtualization platform used for building VDI and cloud infrastructures. vSphere 5 represents a migration from the ESX architecture to the ESXi architecture.

VMware vSphere 5 includes three major layers: Virtualization, Management and Interface. The Virtualization layer includes infrastructure and application services. The Management layer is central for configuring, provisioning and managing virtualized environments. The Interface layer includes the vSphere client and the vSphere web client.



Throughout the Dell Wyse Datacenter solution, all VMware and Microsoft best practices and prerequisites for core services are adhered to (NTP, DNS, Active Directory, etc.). The vCenter 5 VM used in the solution is a single Windows Server 2008 R2 VM or vCenter 5 virtual appliance, residing on a host in the management Tier. SQL server is a core component of the Windows version of vCenter and is hosted on another VM also residing in the management Tier. It is recommended that all additional XenDesktop components be installed in a distributed architecture, one role per server VM.

4.2.2 Microsoft Windows Server 2012 Hyper-V

Windows Server 2012 Hyper-V™ is a powerful virtualization technology that enables businesses to leverage the benefits of virtualization. Hyper-V reduces costs, increases hardware utilization, optimizes business infrastructure, and improves server availability. Hyper-V works with virtualization-aware hardware to tightly control the resources available to each virtual machine. The latest generation of Dell servers includes virtualization-aware processors and network adapters.

From a network management standpoint, virtual machines are much easier to manage than physical computers. To this end, Hyper-V includes many management features designed to make managing virtual machines simple and familiar, while enabling easy access to powerful VM-specific management functions. The primary management platform within a Hyper-V based XenDesktop virtualization environment is Microsoft Systems Center Virtual Machine Manager SP1 (SCVMM).



SCVMM provides centralized and powerful management, monitoring, and self-service provisioning for virtual machines. SCVMM host groups are a way to apply policies and to check for problems across several VMs at once. Groups are organized by owner, operating system, or by custom names such as “Development” or “Production”. The interface also incorporates Remote Desktop Protocol (RDP); double-click a VM to bring up the console for that VM—live and accessible from the management console.

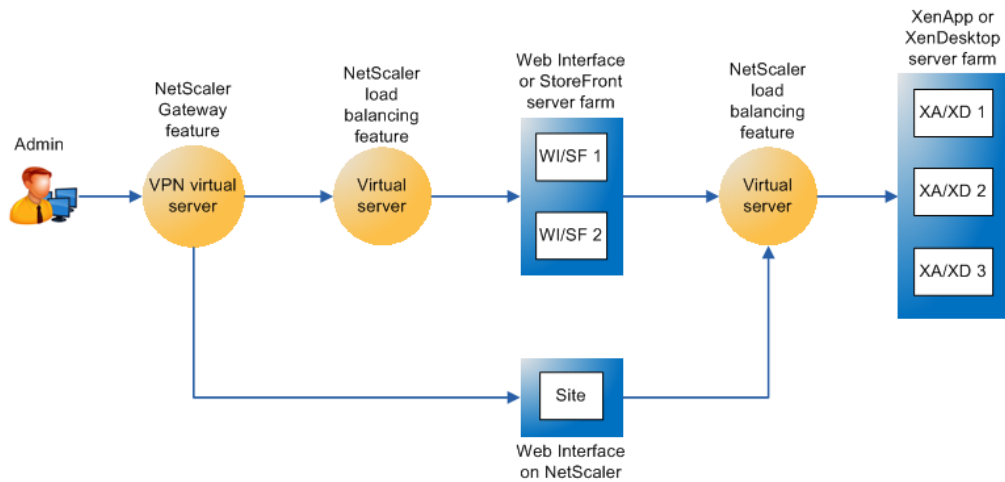
4.3 Citrix NetScaler

Citrix NetScaler is an all-in-one web [application delivery controller](#) that makes applications run five times better, reduces web application ownership costs, optimizes the user experience, and makes sure that applications are always available by using:

- Proven application acceleration such as [HTTP compression](#) and [caching](#)
- High application availability through advanced L4-7 [load balancer](#)
- Application security with an integrated [AppFirewall](#)
- Server offloading to significantly reduce costs and consolidate servers

Where Does a Citrix NetScaler Fit in the Network?

A NetScaler appliance resides between the clients and the servers, so that client requests and server responses pass through it. In a typical installation, virtual servers (vservers) configured on the NetScaler provide connection points that clients use to access the applications behind the NetScaler. In this case, the NetScaler owns public IP addresses that are associated with its vservers, while the real servers are isolated in a private network. It is also possible to operate the NetScaler in a transparent mode as an L2 bridge or L3 router, or even to combine aspects of these and other modes. NetScaler can also be used to host the StoreFront function eliminating complexity from the environment.



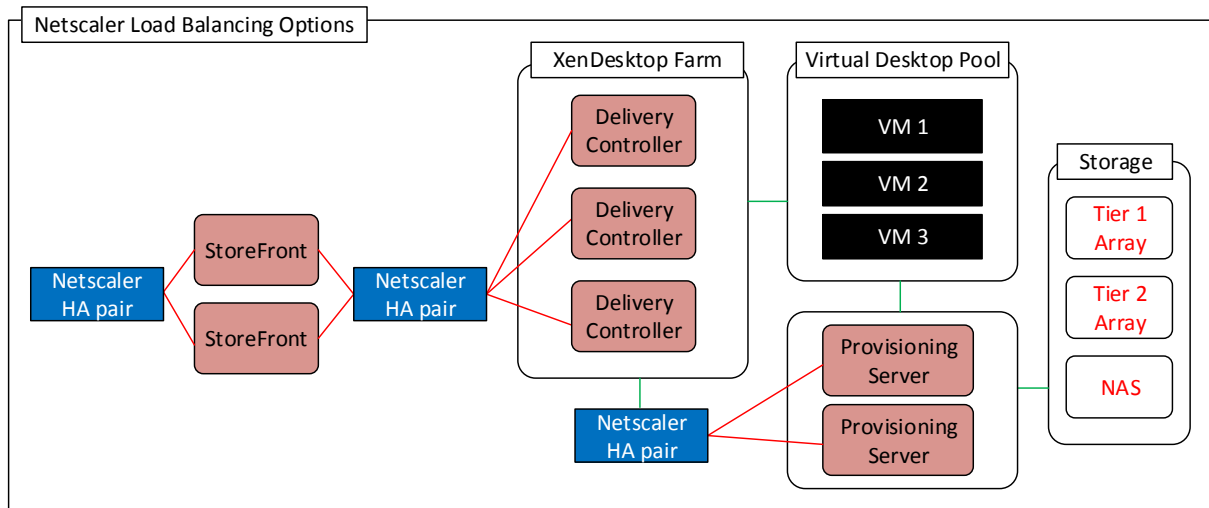
Global Server Load Balancing

GSLB is an industry standard function. It is in widespread use to provide automatic distribution of user requests to an instance of an application hosted in the appropriate data center where multiple processing facilities exist. The intent is to seamlessly redistribute load on an as required basis, transparent to the user community. These distributions are used on a localized or worldwide basis. Many companies use GSLB in its simplest form. They use the technology to automatically redirect traffic to Disaster Recovery (DR) sites on an exception basis. That is, GSLB is configured to simply route user load to the DR site on a temporary basis only in the event of a catastrophic failure or only during extended planned data center maintenance. GSLB is also used to distribute load across data centers on a continuous load balancing basis as part of normal processing.

Several of the management components of the XenDesktop stack are made highly-available using NetScaler to load balance traffic. The following management components require the use of a load balancer to function in a high availability mode:

- StoreFront Servers
- Licensing Server
- XenDesktop XML Service
- XenDesktop Desktop Director
- Provisioning Services TFTP Service



Citrix NetScaler is added to the Dell Wyse Datacenter mgmt. stack at any time and runs on the existing server infrastructure.

5 Solution Architecture for XenDesktop 7

5.1 Compute Server Infrastructure

5.1.1 Local Tier 1 Rack

In the Local Tier 1 model, VDI sessions execute on local storage on each Compute server. The hypervisors used in this solution are vSphere or Hyper-V. In this model, only the Management server hosts access iSCSI storage to support the solution's Management role VMs. Because of this, the Compute and Management servers are configured with different add-on NICs to support their pertinent network Fabric connection requirements. Refer to section 2.4.3.2 for cabling implications. The Management server host has reduced RAM and CPU and does not require local disk to host the management VMs. Any of the compute options below can also be used for XenApp while optionally reducing the amount of RAM.

5.1.2 Local Tier 1 Blade

In the Local Tier 1 model for blades, VDI sessions execute on local high-performance SSDs on each compute host. vSphere is the supported hypervisor in this solution due to its ability to run from integrated SD freeing the pair of SSDs for VDI execution only. In this model, shared storage is not required for Tier 2 unless management host-level HA is required. All management and desktop VMs is hosted locally on their respective blades. The recommended provisioning method is MCS with non-persistent desktops. Refer to Section 2.2.3 for solution cabling implications.

5.1.3 Shared Tier 1 Rack

In the Shared Tier 1 model, VDI sessions execute on shared storage so there is no need for local disk on each server to host VMs. To provide server-level network redundancy using the fewest physical NICs possible, both the Compute and Management servers use a split QP NDC: 2 x 10Gb ports for iSCSI, 2 x 1Gb ports for LAN. Two additional DP NICs (2 x 1Gb + 2 x 10Gb) provide slot and connection-level redundancy for both network Fabrics. All configuration options (beyond the hypervisor differences noted in the table below) are identical except for CPU and RAM which are reduced on the Management host.

5.1.4 Shared Tier 1 Blade

5.2.1 SQL Databases

The Citrix and VMware databases are hosted by a single dedicated SQL 2008 R2 Server VM in the Management layer. Use caution during database setup to ensure that SQL data, logs, and TempDB are properly separated onto their respective volumes. Create all Databases that are required for:

- Citrix XenDesktop
- PVS
- vCenter or SCVMM

Initial placement of all databases into a single SQL instance is fine unless performance becomes an issue, in which case database need to be separated into separate named instances. Enable auto-growth for each DB.

Best practices defined by Citrix, Microsoft and VMware are to be adhered to, to ensure optimal database performance.

The EqualLogic PS series arrays utilize a default RAID stripe size of 64K. To provide optimal performance, configure disk partitions to begin from a sector boundary divisible by 64K.

Align all disks to be used by SQL Server with a 1024K offset and then formatted with a 64K file allocation unit size (data, logs, and TempDB).

5.2.2 DNS

DNS plays a crucial role in the environment not only as the basis for Active Directory but is used to control access to the various Citrix and Microsoft software components. All hosts, VMs, and consumable software components need to have a presence in DNS, preferably via a dynamic and AD-integrated namespace. Microsoft best practices and organizational requirements are to be adhered to.

Pay consideration for eventual scaling, access to components that may live on one or more servers (SQL databases, Citrix services) during the initial deployment. Use CNAMEs and the round robin DNS mechanism to provide a front-end "mask" to the back-end server actually hosting the service or data source.

5.2.2.1 DNS for SQL

To access the SQL data sources, either directly or via ODBC, a connection to the server name\instance name must be used. To simplify this process, as well as protect for future scaling (HA), instead of connecting to server names directly, alias these connections in the form of DNS CNAMEs. So instead of connecting to SQLServer1\

For example, the CNAME "VDISQL" is created to point to SQLServer1. If a failure scenario was to occur and SQLServer2 would need to start serving data, we would simply change the CNAME in DNS to point to SQLServer2. No infrastructure SQL client connections would need to be touched.

5.3 Storage Architecture Overview

The Dell Wyse Datacenter solution has a wide variety of Tier 1 and Tier 2 storage options to provide maximum flexibility to suit any use case. Customers have the choice to leverage best-of-breed iSCSI solutions from EqualLogic or Fiber Channel solutions from Dell Compellent while being assured the storage Tiers of the Dell Wyse Datacenter solution will consistently meet or outperform user needs and expectations.

5.3.1 Local Tier 1 Storage

Choosing the local Tier 1 storage option means that the virtualization host servers use 10 locally installed hard drives to house the user desktop VMs. In this model, Tier 1 storage exists as local hard disks on the Compute hosts themselves. To achieve the required performance level, RAID 10 is recommended for use across all local disks. A single volume per local Tier 1 Compute host is sufficient to host the provisioned desktop VMs along with their respective write caches.

5.3.2 Shared Tier 1 Storage

Choosing the shared Tier 1 option means that the virtualization compute hosts are deployed in a diskless mode and all leverage shared storage hosted on a high performance Dell storage array. In this model, shared storage is leveraged for Tier 1 used for VDI execution and write cache. Based on the heavy performance requirements of Tier 1 VDI execution, it is recommended to use separate arrays for Tier 1 and Tier 2. We recommend using 500GB LUNs for VDI and running no more than 125 VMs per volume along with their respective write caches. Sizing to 500 basic users will require 4 x 500GB volumes.

5.3.3 Shared Tier 2 Storage

Tier 2 is shared iSCSI or FC storage used to host the Management server VMs and user data. EqualLogic 4100 or 6100 series 1Gb arrays are used for smaller scale deployments (Local Tier 1 only), the 6210 or 65x0 series for larger deployments (up to 16 in a group), or a single CML array scaled up to 10K users. The 10Gb iSCSI variants are intended for use in Shared Tier 1 solutions. The Compellent Tier 2 array, as specified in section 3.3.2 scales simply by adding disks. The table below outlines the volume requirements for Tier 2. Larger disk sizes are chosen to meet the capacity needs of the customer. The user data are presented either via a file server VM using RDM/PTD for small scale deployments or via NAS for large scale or HA deployments. The solution as designed presents all SQL disks using VMDK or VHDX formats. RAID 50 are used in smaller deployments but is **not** recommended for critical environments. The recommendation for larger scale and mission critical deployments with higher performance requirements is to use RAID 10 or RAID 6 to maximize performance and recoverability. The following depicts the component volumes required to support a 500 user environment. Additional Management volumes are created as needed along with size adjustments as applicable for user data and profiles.

5.3.4 Storage Networking – EqualLogic iSCSI

Dell's iSCSI technology provides compelling price/performance in a simplified architecture while improving manageability in virtualized environments. Specifically, iSCSI offers virtualized environments simplified deployment, comprehensive storage management and data protection functionality, and seamless VM mobility. Dell iSCSI solutions give customers the "Storage Direct" advantage – the ability to seamlessly integrate virtualization into an overall, optimized storage environment.

If iSCSI is the selected block storage protocol, then the Dell EqualLogic MPIO plugin or MEM (Multipathing Extension Module) is installed on all hosts that connect to iSCSI storage. This module is added via a command line using a Virtual Management Appliance (vMA) from VMware. This plugin allows for easy configuration of iSCSI on each host. The MPIO plugin allows for the creation of new or access to existing data stores and handle IO load balancing. The plugin will also configure the optimal multi-pathing settings for the data stores as well. Some key settings to be used as part of the configuration:

- Specify 2 IP Addresses for iSCSI on each host
- Specify NICs
- Specify Jumbo Frames at 9000 MTU
- Initialize iSCSI initiator
- Specify IP for the EqualLogic Storage group.

5.3.5 Storage Networking – Compellent Fiber Channel (FC)

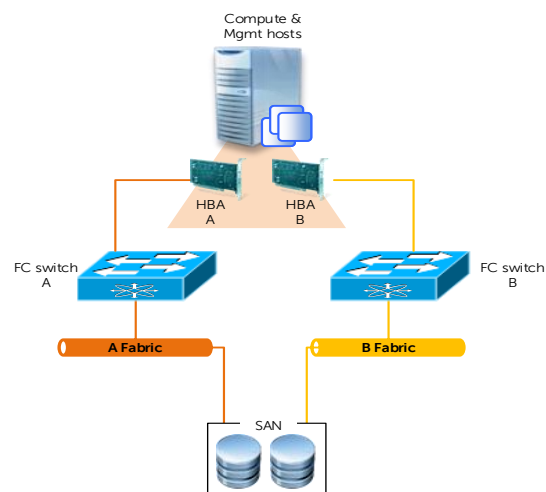
Based on Fluid Data architecture, the Dell Compellent Storage Center SAN provides built-in intelligence and automation to dynamically manage enterprise data throughout its lifecycle. Together, block-level intelligence, storage virtualization, integrated software and modular, platform-independent hardware enable exceptional efficiency, simplicity and security.

Storage Center actively manages data at a block level using real-time intelligence, providing fully virtualized storage at the disk level. Resources are pooled across the entire storage array. All virtual volumes are thin-provisioned. And with sub-LUN tiering, data is automatically moved between Tiers and RAID levels based on actual use.

If Fiber Channel is the selected block storage protocol, then the Compellent Storage Center Integrations for VMware vSphere client plug-in is installed on all hosts. This plugin enables all newly created data stores to be automatically aligned at the recommended 4MB offset. Although a single Fabric are configured to begin with to reduce costs, as a best practice recommendation, the environment is configured with two Fabrics to provide multi-pathing and end-to-end redundancy.

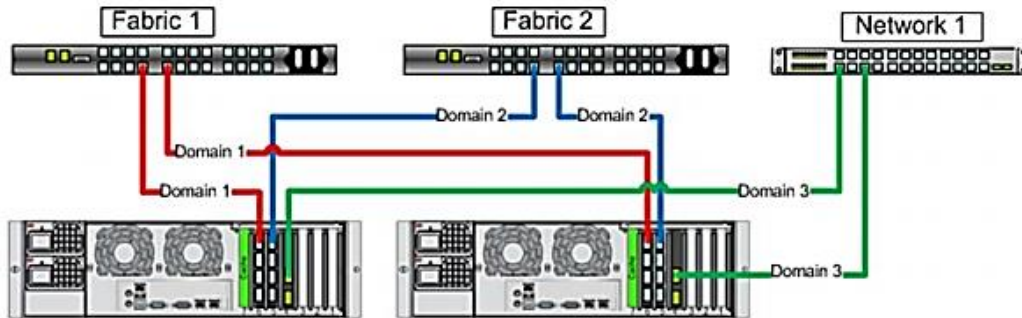
The following QLogic HBA BIOS settings are used:

- Set the “connection options” field to 1 for point to point only
- Set the “login retry count” field to 60 attempts
- Set the “port down retry” count field to 60 attempts
- Set the “link down timeout” field to 30 seconds
- Set the “queue depth” (or “Execution Throttle”) field to 255
- This queue depth are set to 255 because the ESXi VMkernel driver module and DSNRO can more conveniently control the queue depth



5.3.5.1 FC Zoning

Zone at least one port from each server HBA to communicate with a single Compellent fault domain. The result of this is two distinct FC Fabrics and four redundant paths per server as shown in the diagram below. Round Robin or Fixed Paths are supported. You can leverage Compellent Virtual Ports to minimize port consumption as well as simplify deployment. Zone each controller's front-end virtual ports, within a fault domain, with at least one ESXi initiator per server.



5.4 Virtual Networking

5.4.1 Local Tier 1 – Rack – iSCSI

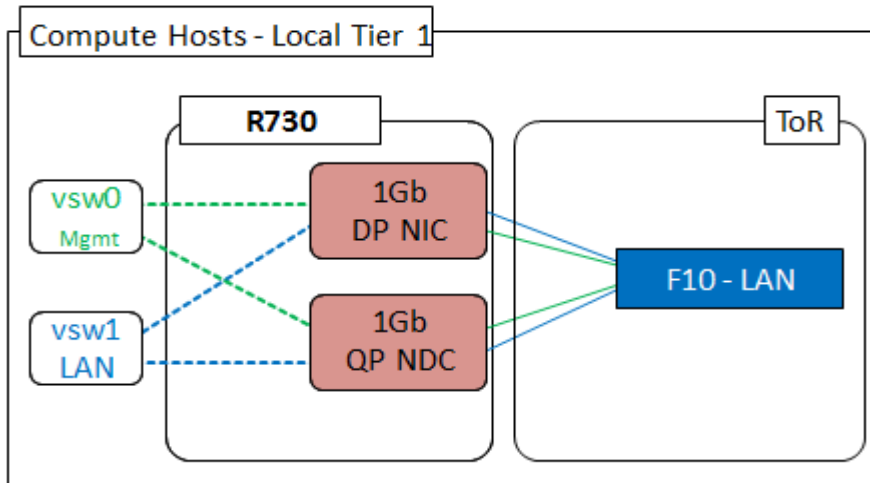
The network configuration in this model will vary between the Compute and Management hosts. The Compute hosts do not need access to iSCSI storage since they are hosting VDI sessions locally. Since the Management VMs is hosted on shared storage, they can take advantage of Live Migration. The following outlines the VLAN requirements for the Compute and Management hosts in this solution model:

- Compute hosts (Local Tier 1)
 - Management VLAN: Configured for hypervisor infrastructure traffic – L3 routed via core switch
 - VDI VLAN: Configured for VDI session traffic – L3 routed via core switch
- Management hosts (Local Tier 1)
 - Management VLAN: Configured for hypervisor Management traffic – L3 routed via core switch
 - Live Migration VLAN: Configured for Live Migration traffic – L2 switched only, trunked from Core (HA only)
 - iSCSI VLAN: Configured for iSCSI traffic – L2 switched only via ToR switch
 - VDI Management VLAN: Configured for VDI infrastructure traffic – L3 routed via core switch
- An iDRAC VLAN are configured for all hardware management traffic – L3 routed via core switch

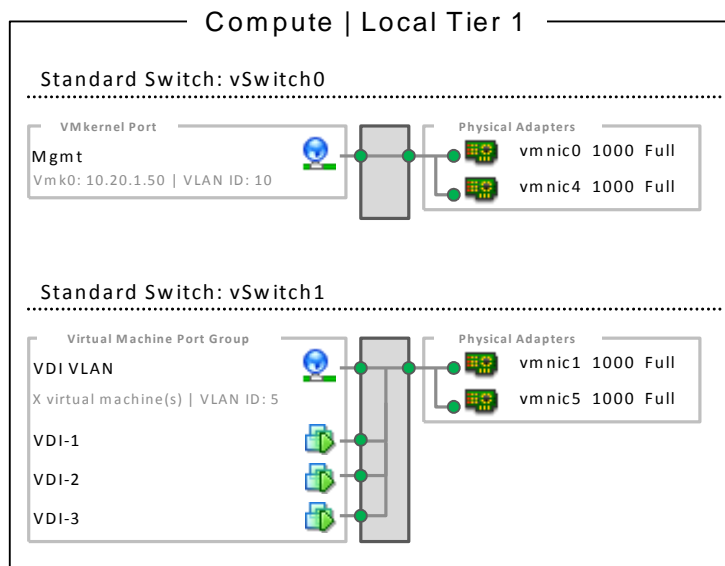
Following best practices, LAN and block storage traffic is separated in solutions >1000 users. This traffic are combined within a single switch in smaller stacks to minimize buy-in costs, however, VLANs are required for each traffic type to enable traffic separation. Each Local Tier 1 Compute

host will have a quad port NDC as well as a 1Gb dual port NIC. Configure the LAN traffic from the server to the ToR switch as a LAG.

5.4.1.1 vSphere

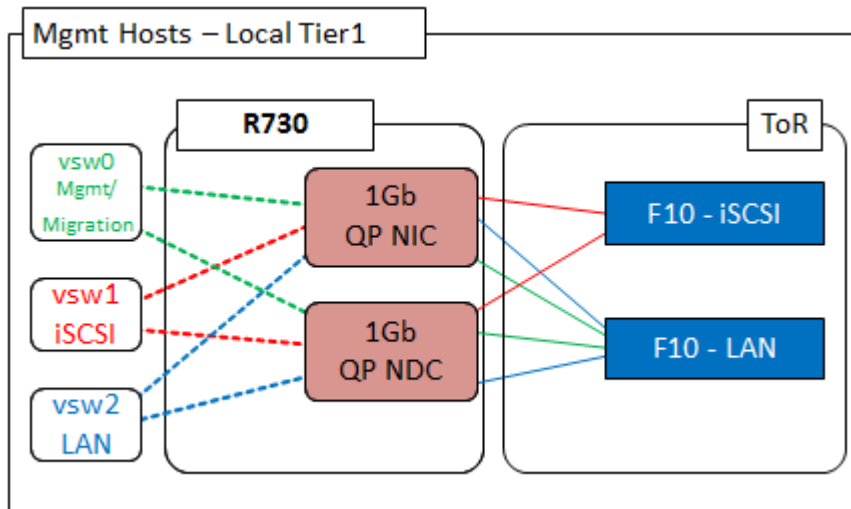


The Compute host will require two vSwitches, one for VDI LAN traffic, and another for the ESXi Management. Configure both vSwitches so that each is physically connected to both the onboard NIC as well as the add-on NIC. Set all NICs and switch ports to auto negotiate. vSphere vSwitch configuration details are shown in the figure below.

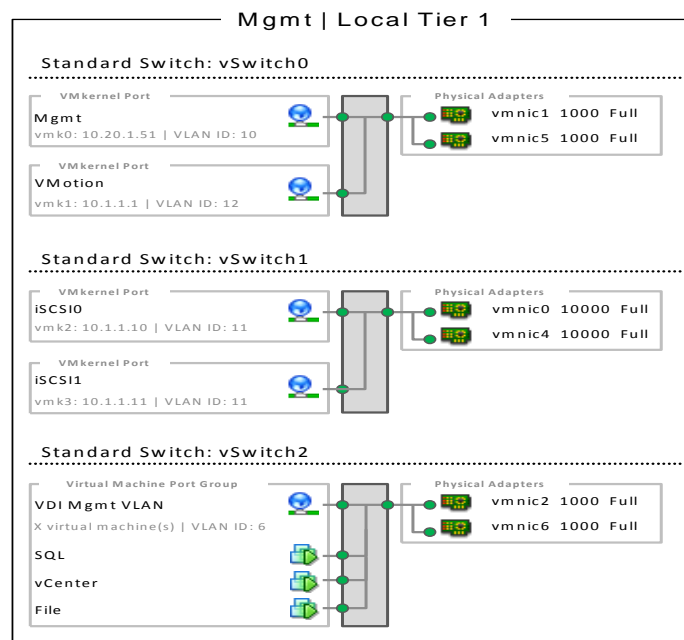


The Management hosts have a slightly different configuration since they also access iSCSI storage. The add-on NIC for the Management hosts is a 1Gb quad port NIC. Three ports of both the NDC and add-on NIC are used for the required connections. iSCSI traffic is isolated onto its own vSwitch

with redundant ports and connections from all three vSwitches. Connections pass through both the NDC and add-on NIC per the diagram below. LAN traffic from the server is configured to the ToR switch as a LAG.

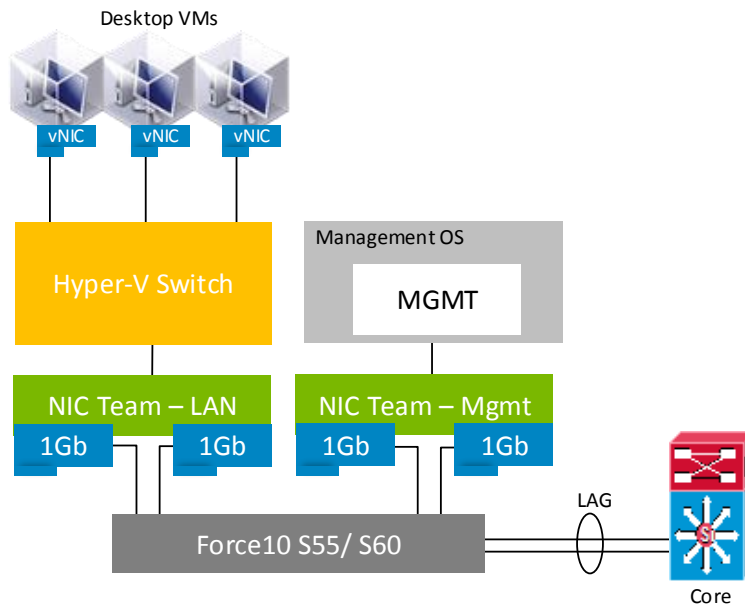


As shown in the diagram below, vSwitch0 carries traffic for both Management and Live Migration which is VLAN-tagged so that either NIC can serve traffic for either VLAN. The Management VLAN is L3 routable while the Live Migration VLAN is L2 non-routable.

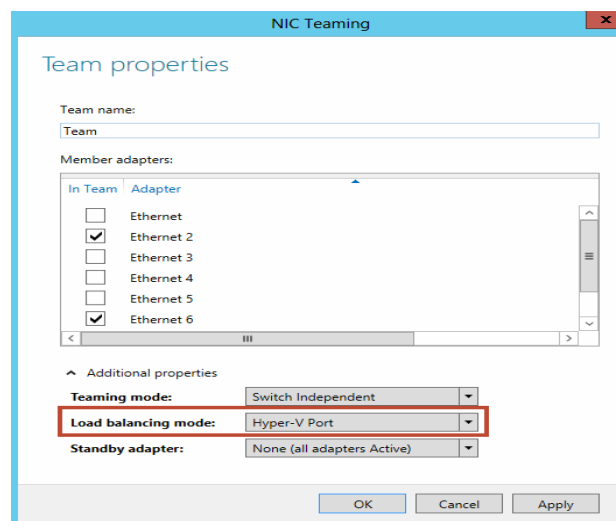


5.4.1.2 Hyper-V

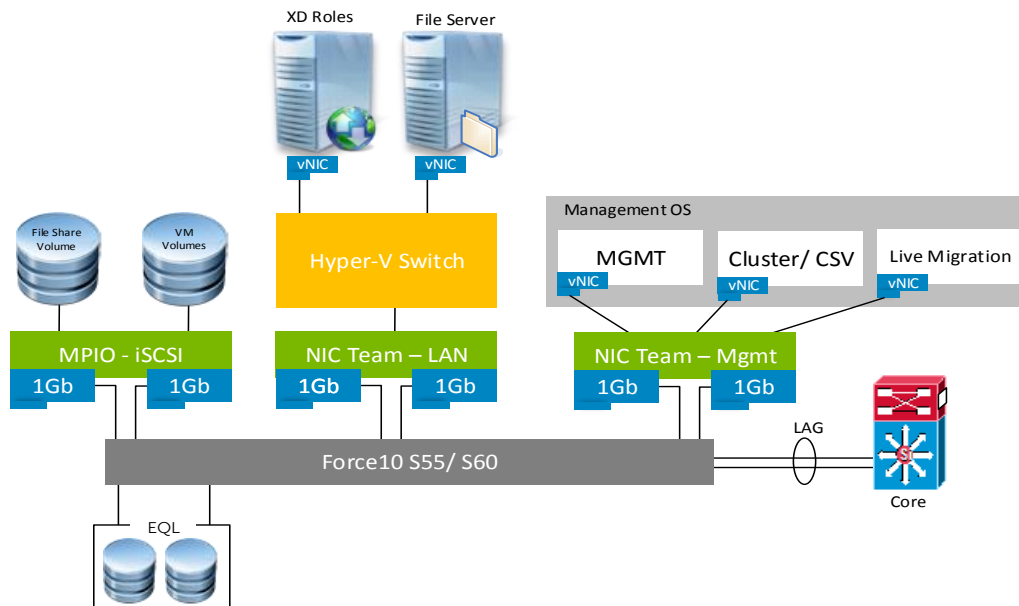
The Hyper-V configuration, while identical in core requirements and hardware, is executed differently due to how Hyper-V and Windows Server 2013 implement networking and virtual switches. As shown in the diagram below, native Windows Server 2012 NIC Teaming is utilized to load balance and provide resiliency for network connections. For the compute host in this scenario, two NIC teams are configured, one for the Hyper-V switch and one for the management OS. The desktop VMs connect to the Hyper-V switch, while the management OS connects directly to the NIC team dedicated to the Mgmt network.



The NIC team for the Hyper-V switch is configured as switch independent, and the Hyper-V port for the load balancing mode with all adapters set to active. This team is used exclusively by Hyper-V.



The management hosts in this scenario connect to shared storage and as a result have a slightly different configuration to support that requirement. Server 2012 supports native MPIO functions but we recommend using the Dell EqualLogic HIT Kit for MPIO to the iSCSI arrays. The rest of the configuration is basically the same as the compute host with two NIC teams, one for Hyper-V and the other for the management OS. If the management host is clustered or utilizes live migration, additional vNICs (Team Interfaces) with dedicated VLANs is configured on the Mgmt NIC team to support these functions.



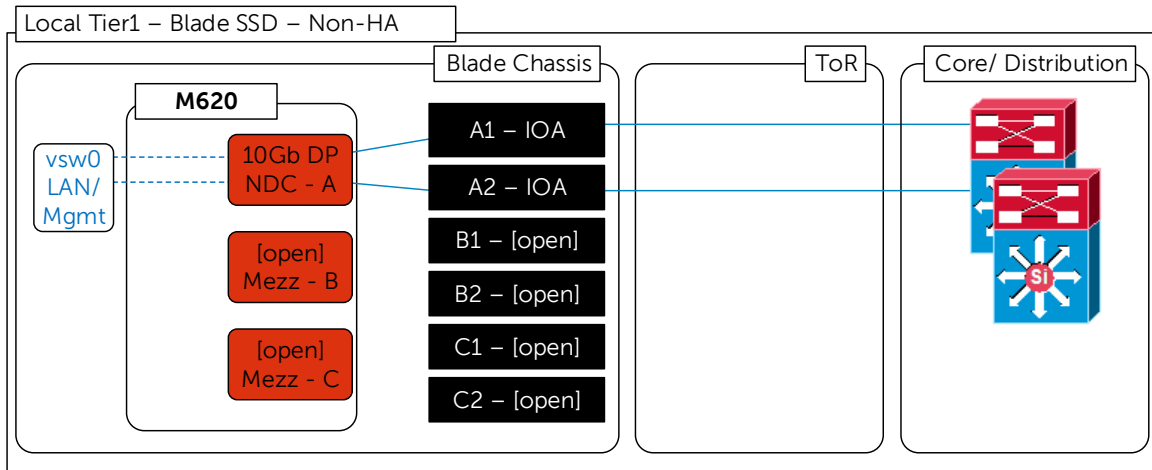
5.4.2 Local Tier 1 – Blade

The network configuration in this model will vary slightly between the Compute and Management hosts. The Management VMs are hosted on local storage and optionally on shared Tier 2 if Live Migration is a requirement. The following outlines the VLAN requirements for the Compute and Management hosts in this solution model:

- Compute hosts (Local Tier 1)
 - Management VLAN: Configured for hypervisor infrastructure traffic – L3 routed via core switch
 - VDI VLAN: Configured for VDI session traffic – L3 routed via core switch
- Management hosts (Local Tier 1)
 - Management VLAN: Configured for hypervisor Management traffic – L3 routed via core switch
 - VDI Management VLAN: Configured for VDI infrastructure traffic – L3 routed via core switch
 - Live Migration VLAN: Configured for Live Migration traffic – L2 switched only, trunked from Core (**HA**)
 - iSCSI VLAN: Configured for iSCSI traffic – L2 switched only via ToR switch (**HA**)
- An optional iDRAC VLAN are configured for all hardware management traffic – L3 routed via core switch

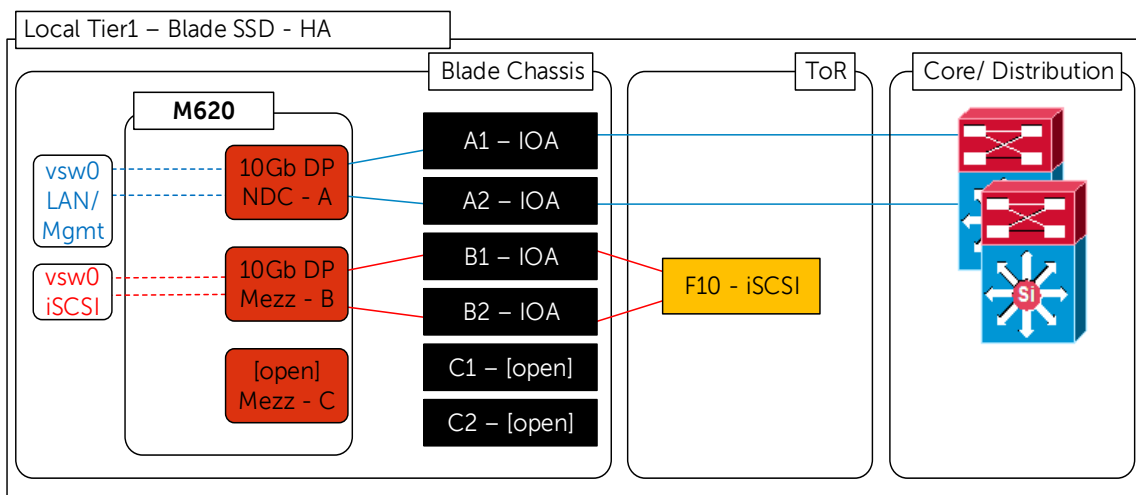
5.4.2.1 vSphere – Non HA

Each Local Tier 1 Compute and Management blade host have a 10Gb dual port LOM in the A Fabric that will flow through 2 x IOA blade interconnects. The B and C Fabrics are left open for optional expansion. Connections should pass through the blade mezzanines and interconnects per the diagram below. Configure the LAN traffic from the chassis interconnects to the ToR switch as a LAG if possible.



5.4.2.2 vSphere – HA

Following best practices, iSCSI and LAN traffic is physically separated into discrete Fabrics for the HA design. If mgmt. HA is required, the B Fabric is populated with a 10Gb DP NIC connecting through an additional pair of IOA blade interconnects.



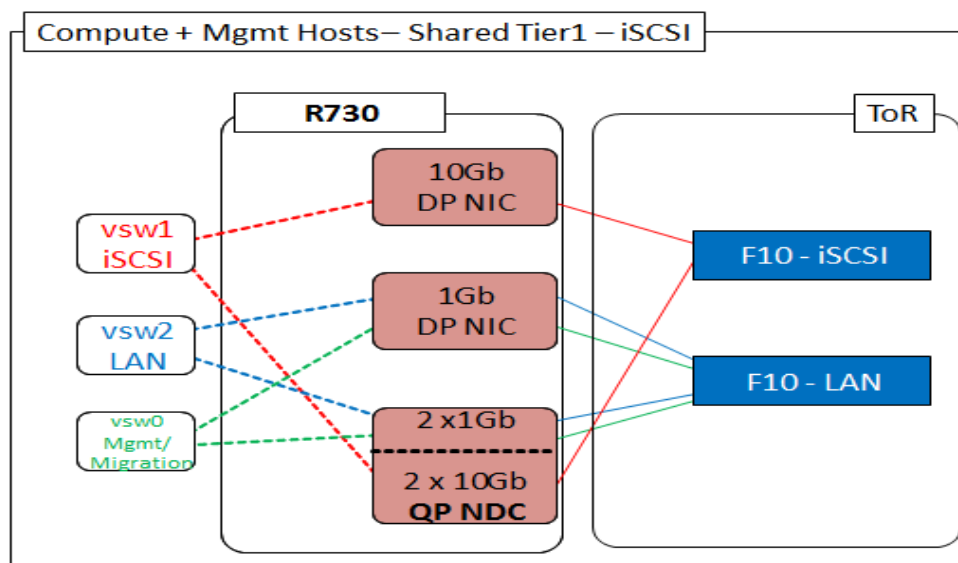
5.4.3 Shared Tier 1 – Rack – iSCSI

The network configuration in this model is identical between the Compute and Management hosts. Both need access to iSCSI storage since they are hosting VDI sessions from shared storage and both can leverage Live Migration as a result as well. The following outlines the VLAN requirements for the Compute and Management hosts in this solution model:

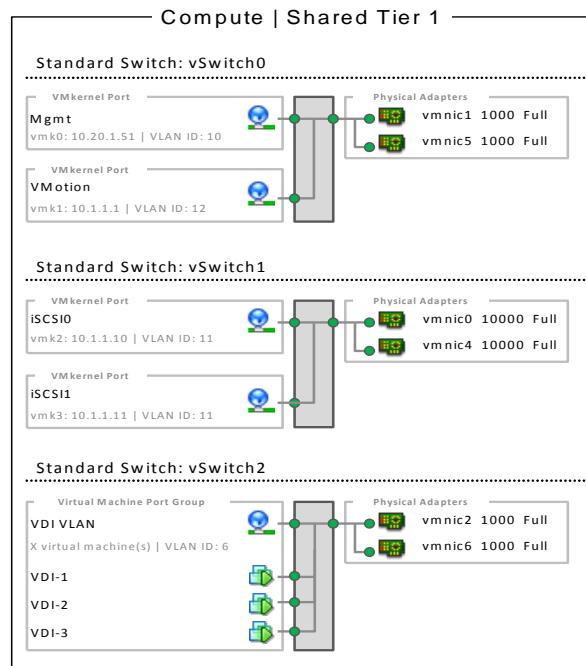

Each Shared Tier 1 Compute and Management host will have a quad port NDC (2 x 1Gb + 2 x 10Gb SFP+), a 10Gb dual port NIC, as well as a 1Gb dual port NIC. Isolate iSCSI onto its own vSwitch with redundant ports. Connections from all 3 vSwitches should pass through both the NDC and add-on NICs per the diagram below. Configure the LAN traffic from the server to the ToR switch as a LAG.

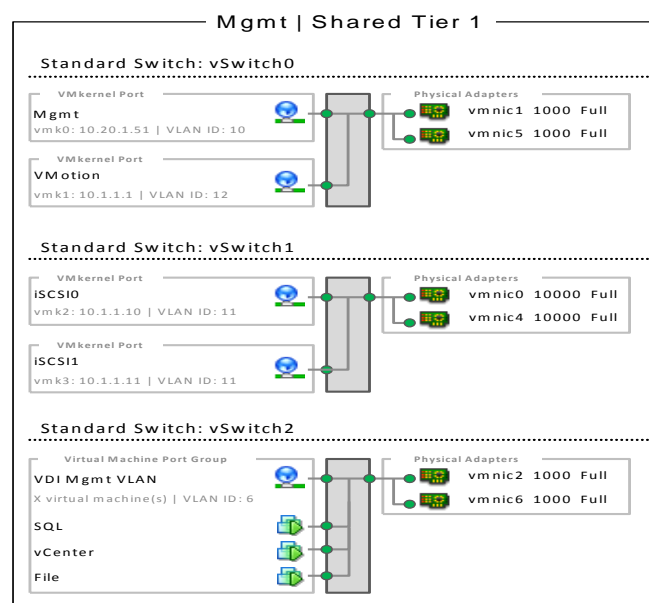
5.4.3.1 vSphere



vSwitch0 carries traffic for both Management and Live Migration which is VLAN-tagged so that either NIC can serve traffic for either VLAN. The Management VLAN is L3 routable while the Live Migration VLAN is L2 non-routable.

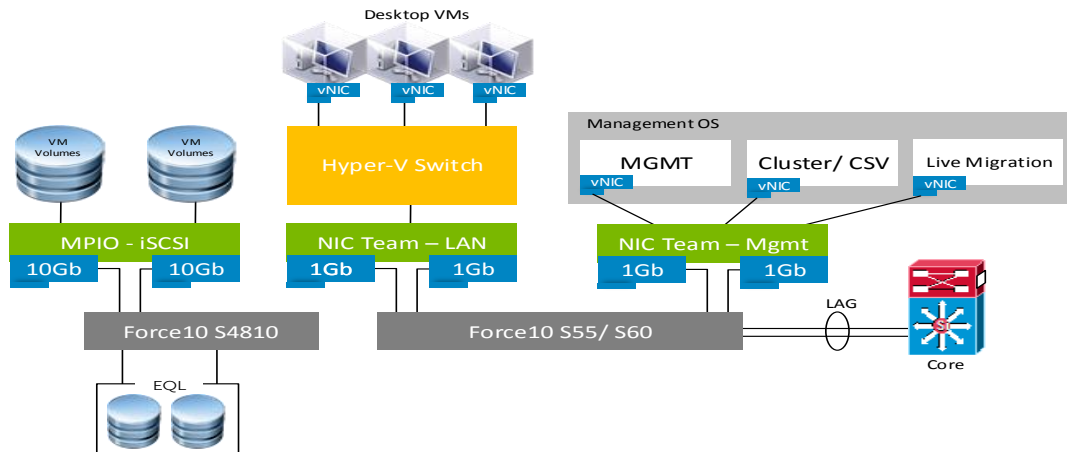


The Management server is configured identically except for the VDI Management VLAN which is fully routed and separated from the VDI VLAN used on the Compute host. Care is taken to ensure that all vSwitches are assigned redundant NICs that are NOT from the same PCIe device.

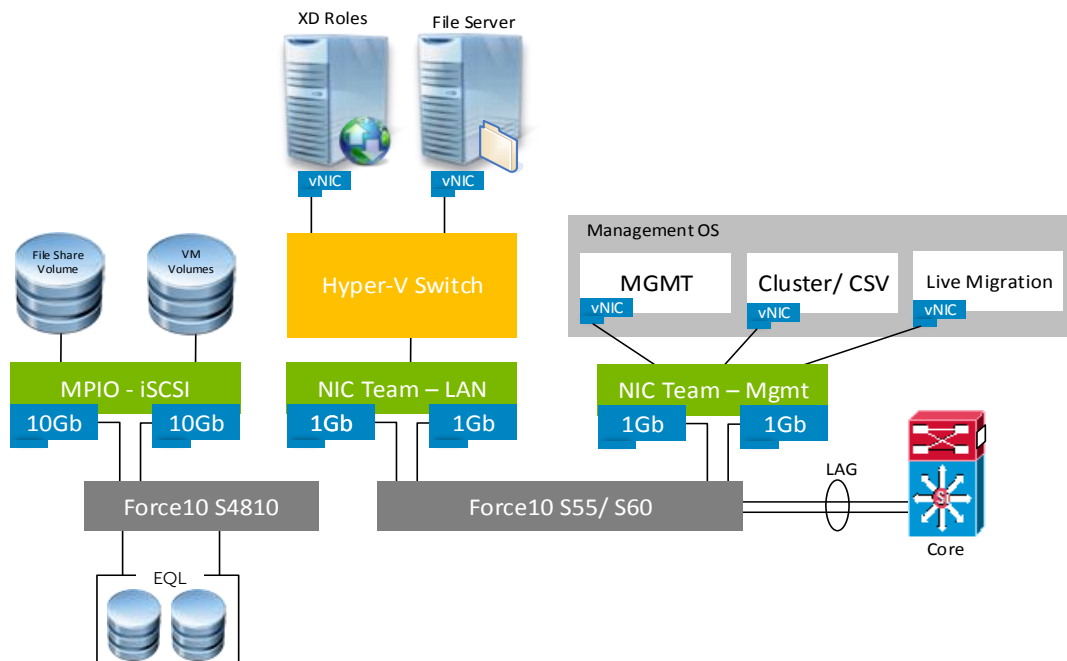


5.4.3.2 Hyper-V

The Hyper-V configuration, while identical in core requirements and hardware to the vSphere configuration, is executed a bit differently. Native Windows Server 2012 NIC Teaming is utilized to load balance and provide resiliency for network connections. The compute and management hosts are configured identically in this scenario with both connecting to shared storage. Two NIC teams is configured, one for the Hyper-V switch and one for the management OS, with Dell MPIO used to connect to shared storage. The desktop VMs will connect to the Hyper-V switch, while the management OS will connect directly to the NIC team dedicated to the Mgmt network.



Management hosts are configured in the same manner.



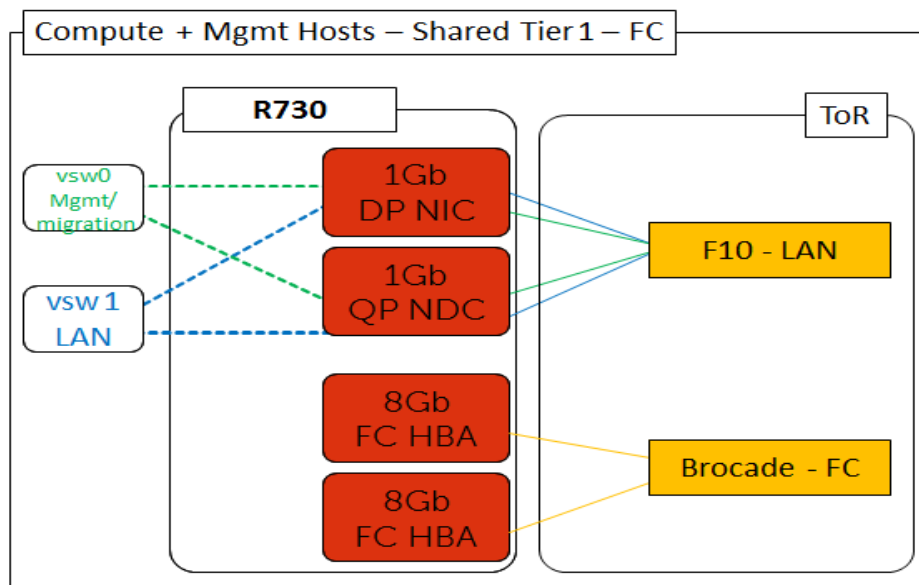
5.4.4 Shared Tier 1 – Rack – FC

Using Fiber Channel based storage eliminates the need to build iSCSI into the network stack but requires additional Fabrics to be built out. The network configuration in this model is identical between the Compute and Management hosts. Both need access to FC storage since they are hosting VDI sessions from shared storage and both can leverage Live Migration as a result. The following outlines the VLAN requirements for the Compute and Management hosts in this solution model:

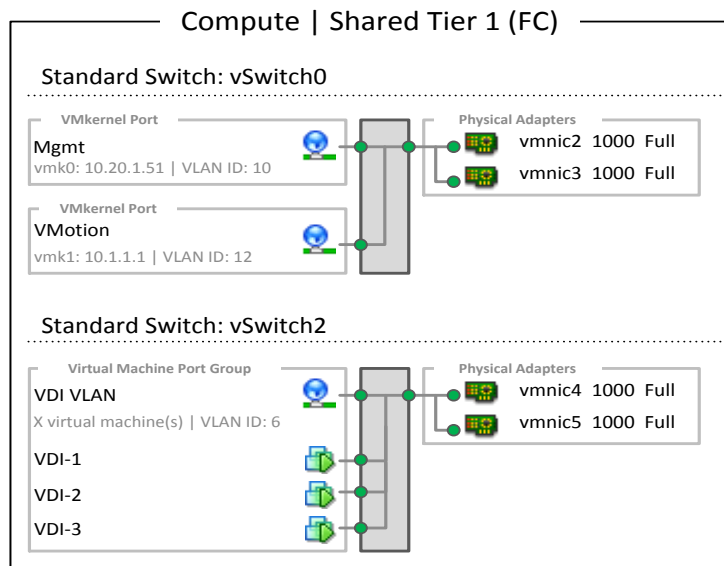

Each Shared Tier 1 Compute and Management host have a quad port NDC (4 x 1Gb), a 1Gb dual port NIC, as well as 2 x 8Gb dual port FC HBAs. Connections from both vSwitches pass through both the NDC and add-on NICs per the diagram below. LAN traffic from the server to the ToR switch is configured as a LAG.

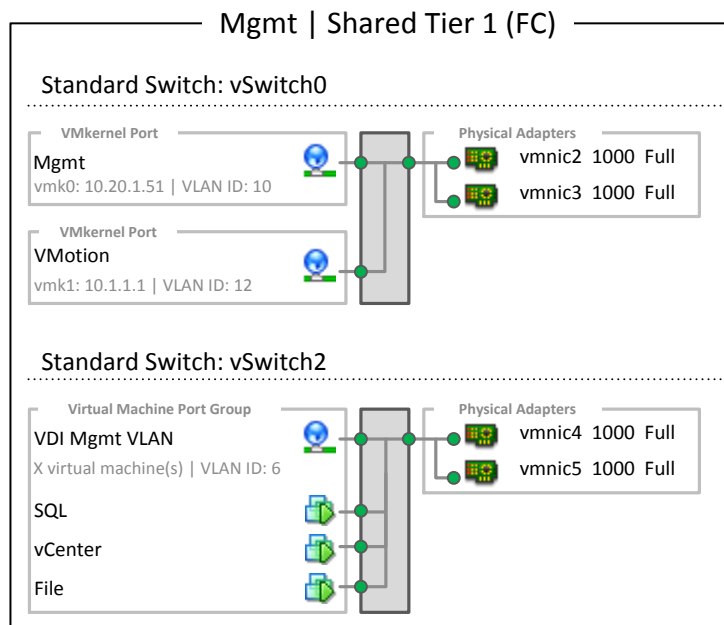

The C Fabric is left open for future expansion. Connections from 10Gb and 1Gb traffic vSwitches should pass through the blade mezzanines and interconnects per the diagram below. LAN traffic from the server to the ToR switch is configured as a LAG.

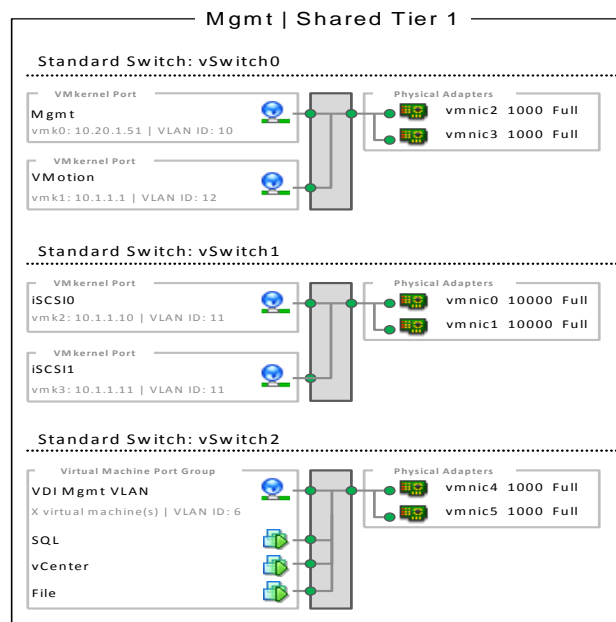

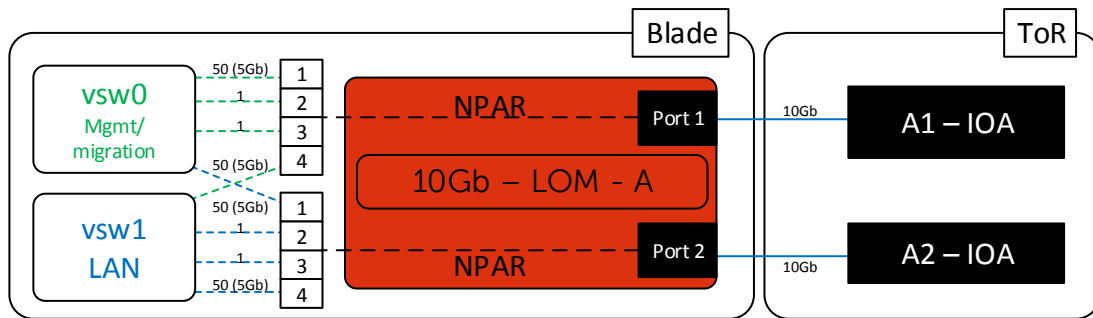
FC and LAN traffic are physically separated into discrete switching Fabrics. Each Shared Tier 1 Compute and Management blade will have a 10Gb dual port LOM in the A Fabric and an 8Gb dual port HBA in the B Fabric. All LAN and Mgmt traffic will flow through the A Fabric using 2 x IOA blade interconnects partitioned to the connecting blades. 8Gb FC traffic will flow through the B Fabric using 2 x M5424 blade interconnects. The C Fabric is left open for future expansion. Connections from the vSwitches and storage Fabrics should pass through the blade mezzanines and interconnects per the diagram below. Configure the LAN traffic from the server to the ToR switch as a LAG.

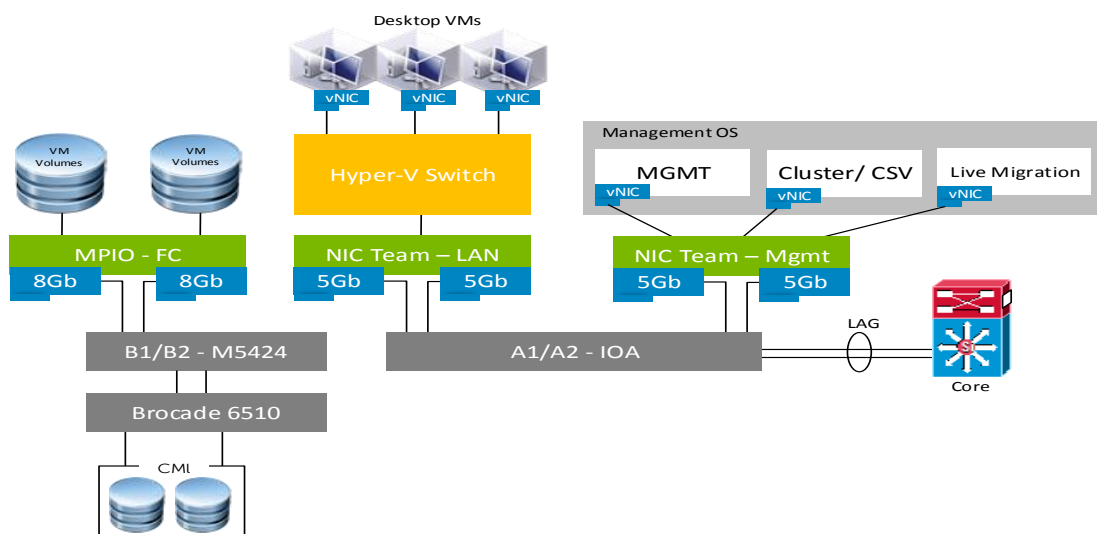
5.4.6.1.1 Shared Tier 1 – Blade – Network Partitioning

Network partitioning (NPAR) takes place within the UEFI of the 10GB LOMs of each blade in the A Fabric. Partitioning allows a 10Gb NIC to be split into multiple logical NICs that are assigned differing amounts of bandwidth. 4 partitions are defined per NIC with the amounts specified below. We only require 2 partitions per NIC port so the unused partitions receive a bandwidth of 1. Partitions are oversubscribed, but not the reverse. We are partitioning out a total of 4 x 5Gb NICs with the remaining 4 unused. Use care to ensure that each vSwitch receives a NIC from each physical port for redundancy.



5.4.6.2 Hyper-V

The Hyper-V configuration, while identical in core requirements and hardware to the vSphere configuration, is executed a bit differently. Native Windows Server 2012 NIC Teaming is utilized to load balance and provide resiliency for network connections. The compute and management hosts are configured identically in this scenario with both connecting to shared storage. Two NIC teams is configured, one for the Hyper-V switch and one for the management OS, with Dell MPIO used to connect to shared storage. The desktop VMs will connect to the Hyper-V switch, while the management OS will connect directly to the NIC team dedicated to the Mgmt network. The LAN connections are partitioned using NPAR to provide 2 x 5Gb vNICs to each NIC team. Please see section 4.7.5.1.1 above for more information.



5.5 Scaling Guidance

Each component of the solution architecture scales independently according to the desired number of supported users. PVS scales differently from MCS, as does the hypervisor in use. Using the new Intel Ivy Bridge CPUs, rack and blade servers now scale equally from a compute perspective.

- The components are scaled either horizontally (by adding additional physical and virtual servers to the server pools) or vertically (by adding virtual resources to the infrastructure)
- Eliminate bandwidth and performance bottlenecks as much as possible
- Allow future horizontal and vertical scaling with the objective of reducing the future cost of ownership of the infrastructure.

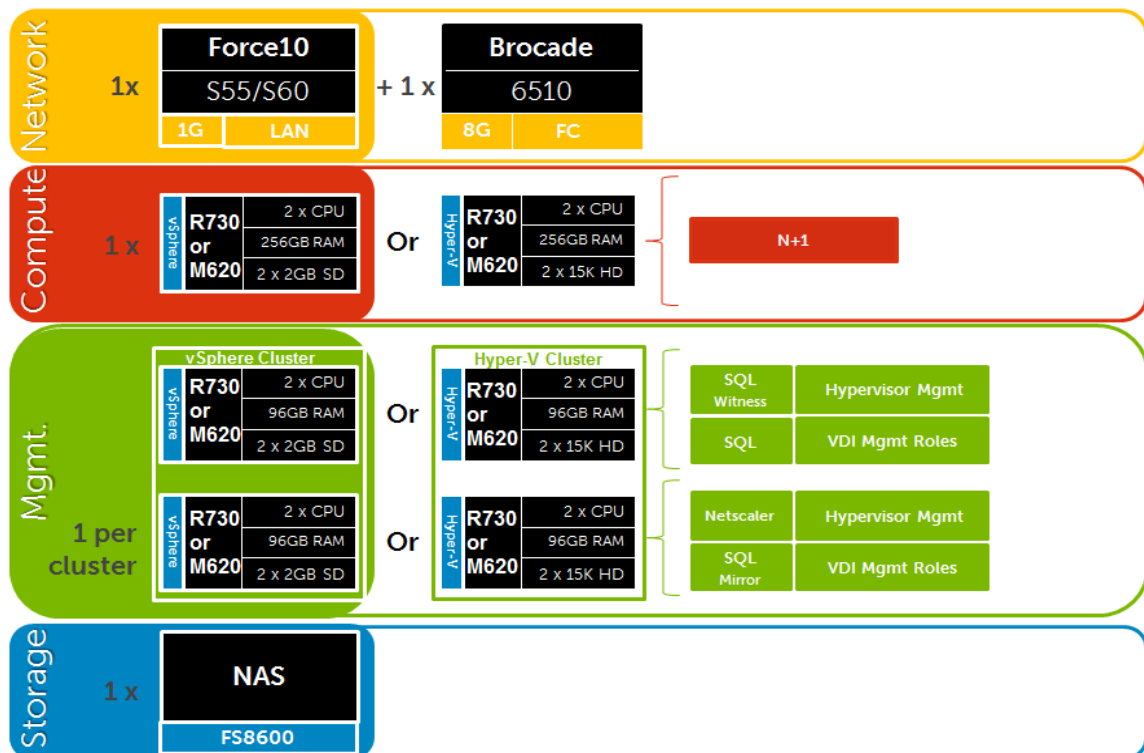

5.6 Solution High Availability

High availability (HA) is offered to protect each architecture solution layer, individually if desired. Following the N+1 model, additional ToR switches for LAN, iSCSI, or FC are added to the Network layer and stacked to provide redundancy as required, additional compute and management hosts are added to their respective layers, vSphere or Hyper-V clustering is introduced in the management layer, SQL is mirrored or clustered, NetScaler is leveraged for load balancing, and a NAS device are used to host file shares. Storage protocol switch stacks and NAS selection will vary based on chosen solution architecture. The following diagram depicts the additional components required to make a standard solution HA.



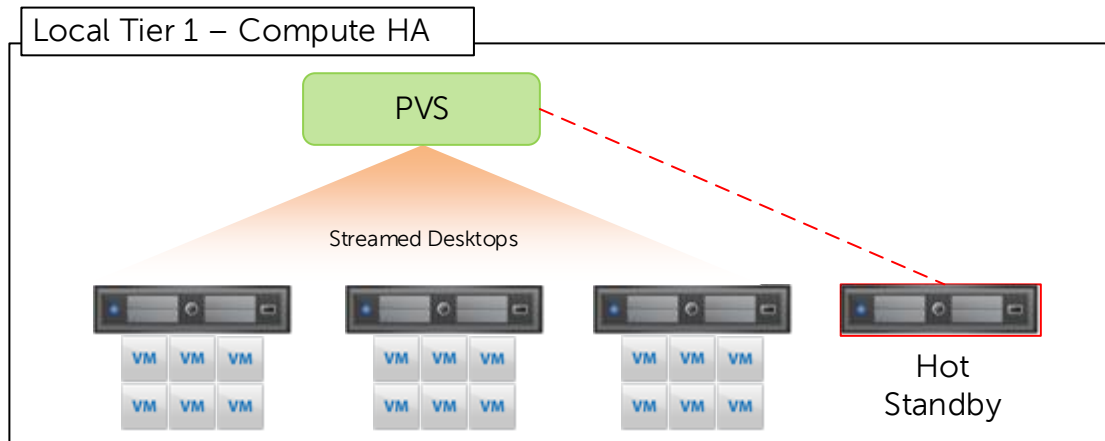
The HA options provide redundancy for all critical components in the stack while improving the performance and efficiency of the solution as a whole.

- An additional switch is added at the network Tier which is configured with the original as a stack and thereby equally spreading each host's network connections across both switches.
- At the compute Tier an additional ESXi host is added to provide N+1 protection provided by Citrix PVS. In a rack based solution with local Tier 1 storage, there is no vSphere HA cluster in the compute Tier as VMs run on local disks.
- A number of enhancements occur at the Management Tier, the first of which is the addition of another host. The Management hosts are configured in an HA cluster. All applicable Citrix server roles can then be duplicated on the new host where connections to each are load balanced via the addition of a virtual NetScaler appliance. SQL Server databases also receive

greater protection through the addition and configuration of a 3-way SQL mirror with a witness.

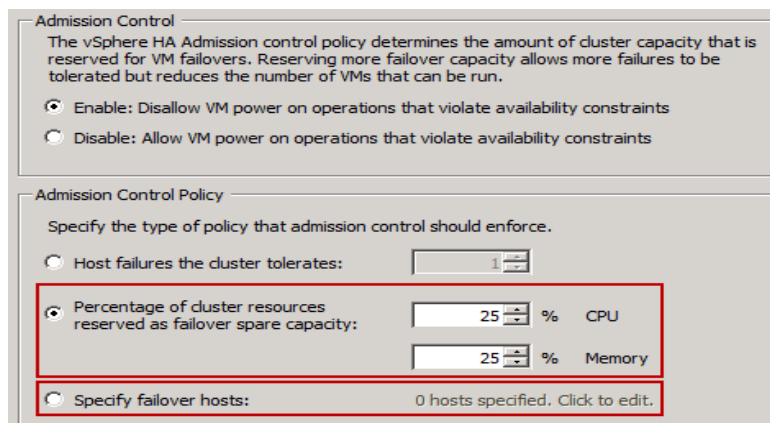
5.6.1 Compute Layer HA (Local Tier 1)

The optional HA bundle adds an additional host in the Compute and Management layers to provide redundancy and additional processing power to spread out the load. The Compute layer in this model does not leverage shared storage so hypervisor HA does not provide a benefit here. To protect the Compute layer, with the additional server added, PVS will ensure that if a single host fails, its load is spun up on the hot standby.



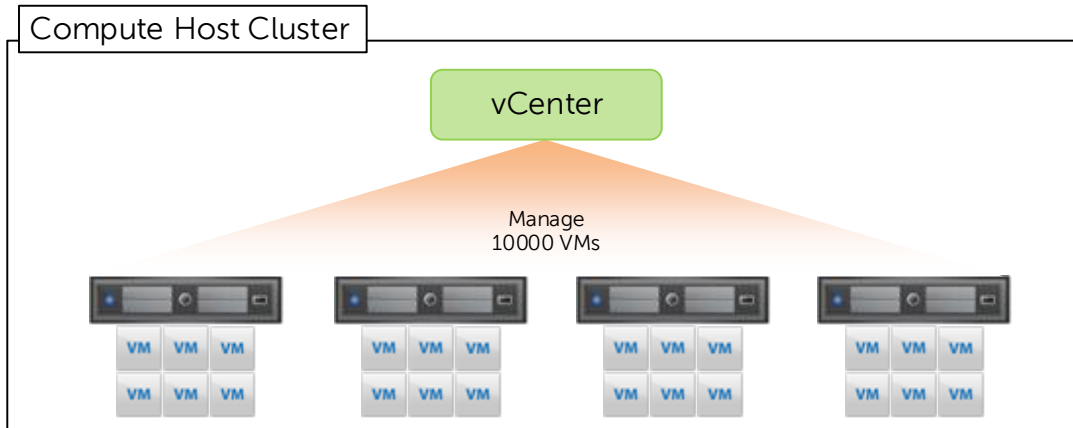
Because only the Management hosts have access to shared storage, in this model, only these hosts need to leverage the full benefits of hypervisor HA. The Management hosts are configured in an HA cluster with or without the HA bundle. An extra server in the Management layer will provide protection should a host fail.

vSphere HA Admission control are configured one of three ways to protect the cluster. This will vary largely by customer preference but the most manageable and predictable options are percentage reservations or a specified hot standby. Reserving by percentage will reduce the overall per host density capabilities but will make some use of all hardware in the cluster. Additions and subtractions of hosts will require the cluster to be manually rebalanced. Specifying a failover host, on the other hand, will ensure maximum per host density numbers but will result in hardware sitting idle.



5.6.2 vSphere HA (Shared Tier 1)

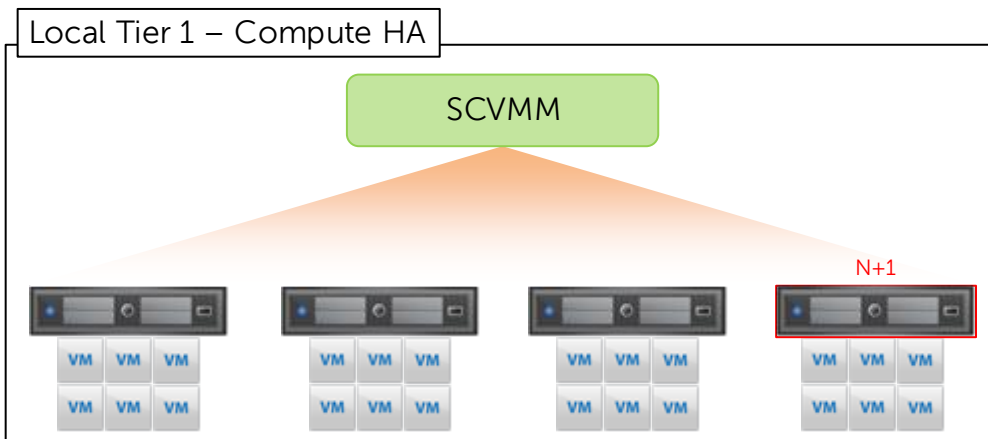
As shown below, both Compute and Management hosts are identically configured, within their respective Tiers, and leverage shared storage thus making full use of vSphere HA. The Compute hosts are configured in an HA cluster following the boundaries of vCenter with respect to limits imposed by VMware (3000 VMs per vCenter). This will result in multiple HA clusters managed by multiple vCenter servers.



A single HA cluster is sufficient to support the Management layer up to 10K users. An additional host is used as a hot standby or to thin the load across all hosts in the cluster.

5.6.3 Hyper-V HA (Shared Tier 1)

The computer layer hosts are provided using typical N+1 fashion as shown in the diagram below. An additional host is added to the pool and is configured to absorb additional capacity or as a standby node should another fail.



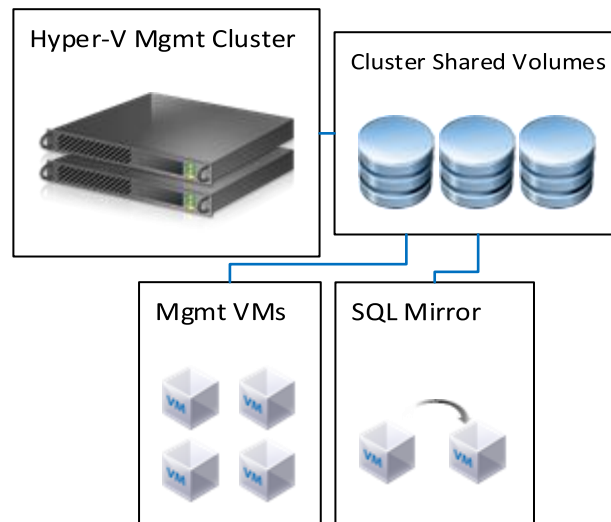
5.6.4 Management Server High Availability

The applicable core Citrix roles are load balanced via DNS namespaces by default. In environments requiring HA, NetScaler VPX is introduced to manage load-balancing efforts. XenDesktop, PVS, and vCenter configurations are stored in SQL which is protected via the SQL mirror.

Citrix license server is protected from host hardware failure and Citrix licensing grace period by default. If customer desires, the license server are optionally protected further via the form of a cold stand-by VM residing on an opposing management host. A vSphere scheduled task is used, for example, to clone the VM to keep the stand-by VM current. Note – In the HA option, there is no file server VM, its duties have been replaced by introducing a NAS head.

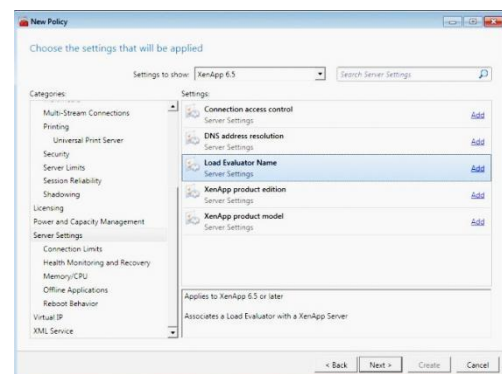
The following protects each of the critical infrastructure components in the solution:

- The Management hosts are configured in a Hyper-V cluster (Node and Disk Majority).
- The storage volume that hosts the Management VMs is upgraded to a Cluster Shared Volume (CSV) so all hosts in a cluster can read and write to the same volumes.
- SQL Server mirroring is configured with a witness to further protect SQL.



5.6.5 XenApp Server High Availability

The high availability configuration of XenApp virtual servers is introduced to avoid application or desktop unavailability due to a physical server failure. Enabling this configuration typically involves adding an additional one or more physical XenApp server hosts and then the appropriate number of virtual XenApp servers to attain the desired level of resiliency and high availability. A single server is configured with the addition of two (2) to eight (8) additional virtual servers per physical host.



Once joined to the farm, the additional XenApp virtual servers will leverage native XenApp high availability via Load Evaluators and failover policies.

5.6.6 Provisioning Services High Availability

The following components of the Provisioning Server Hierarchy are delivered in a highly available configuration:

- Provisioning Server
- Database Storage Device (SAN)
- vDisk Shared Storage System (SAN).

With the HA feature, a target device can connect to its vDisk through any Provisioning Server listed in the boot file. The HA feature is enabled on the Properties' Options tab for the vDisk.

The target device attempts to connect to one Provisioning Server at a time, in the order listed. If the attempt fails, it tries the next Provisioning Server in the list. If the attempt with the last server in the list fails, it repeats the process. From the Console Tool menu, you use the Configure Bootstrap option to add a Provisioning Server to the list.

The connecting Provisioning Server does not necessarily become the Provisioning Server that accesses the vDisk on behalf of the target device. The connecting Provisioning Server chooses the Provisioning Server that accesses the vDisk according to the Boot Behavior property of the connecting target device.

The HA feature requires that each Provisioning server has access to a shared copy of the database, an identical copy of the vDisk and the ability to write to the Write Cache. Within the environment the database is hosted on the clustered SQL server not one of the Provisioning servers and as such the SQL platform will ensure the database remains available. The vDisks and Write Cache are configured in two ways:

- A shared storage system that ensures the availability of the Provisioning Server database, and vDisks, assuming that the Write Cache is hosted on the Provisioning server
- Each Provisioning server has access to an identical copy of the vDisk via the same local path, and the Write cache located on the target device

Within the environment the second option is utilized, this is commonly referred to as a distributed model because the vDisks are located on each Provisioning server not on a shared storage platform.

Each Provisioning Server is responsible for the Write cache of each desktop that it is hosting. This Write cache is readable by the resilient Provisioning Server and as it is held on the target device (in this case virtual machine). In the event of a Provisioning Server failure, all desktops that were hosted will transfer to an alternate provisioning server for that site and users is unaware of the failure.

Streaming Services run under a user account with Service account credentials. The Service account credential (user account name and password) is a domain account that is configured on each Provisioning Server, in order to access the Streaming Service and the shared database.

5.6.7 Windows File Services High Availability

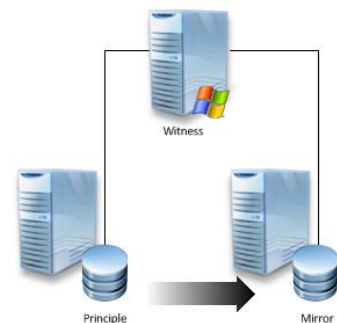
High availability for file services are provided by the Dell FS7600, FS8600 or PowerVault NX3300 clustered NAS devices. To ensure proper redundancy, the NAS cabling is distributed between ToR switches.

Unlike the FS8600, the FS7600 and NX3300 do not support for 802.1q (VLAN tagging) so the connecting switch ports are configured with native VLANs, both iSCSI and LAN/ VDI traffic ports. Best practice dictates that all ports are connected on both controller nodes. The backend ports are used for iSCSI traffic to the storage array as well as for internal NAS functionality (cache mirroring and cluster heart beat). Front-end ports are configured using Adaptive Load Balancing or a LAG (LACP).

The Dell Wyse Solutions Engineering recommendation is to configure the original file server VM to use RDMs or PTDs to access the storage LUNs; therefore migration to the NAS is simplified by changing the presentation of these LUNs from the file server VM to the NAS.

5.6.8 SQL Server High Availability

HA for SQL is provided via a 3-server synchronous mirror configuration that includes a witness (High safety with automatic failover). This configuration protects all critical data stored within the database from physical server as well as virtual server problems. DNS is used to control access to the active SQL server. Place the principal VM that will host the primary copy of the data on the first Management host. Place the mirror and witness VMs on the second or later Management hosts. Mirror all critical databases to provide HA protection.

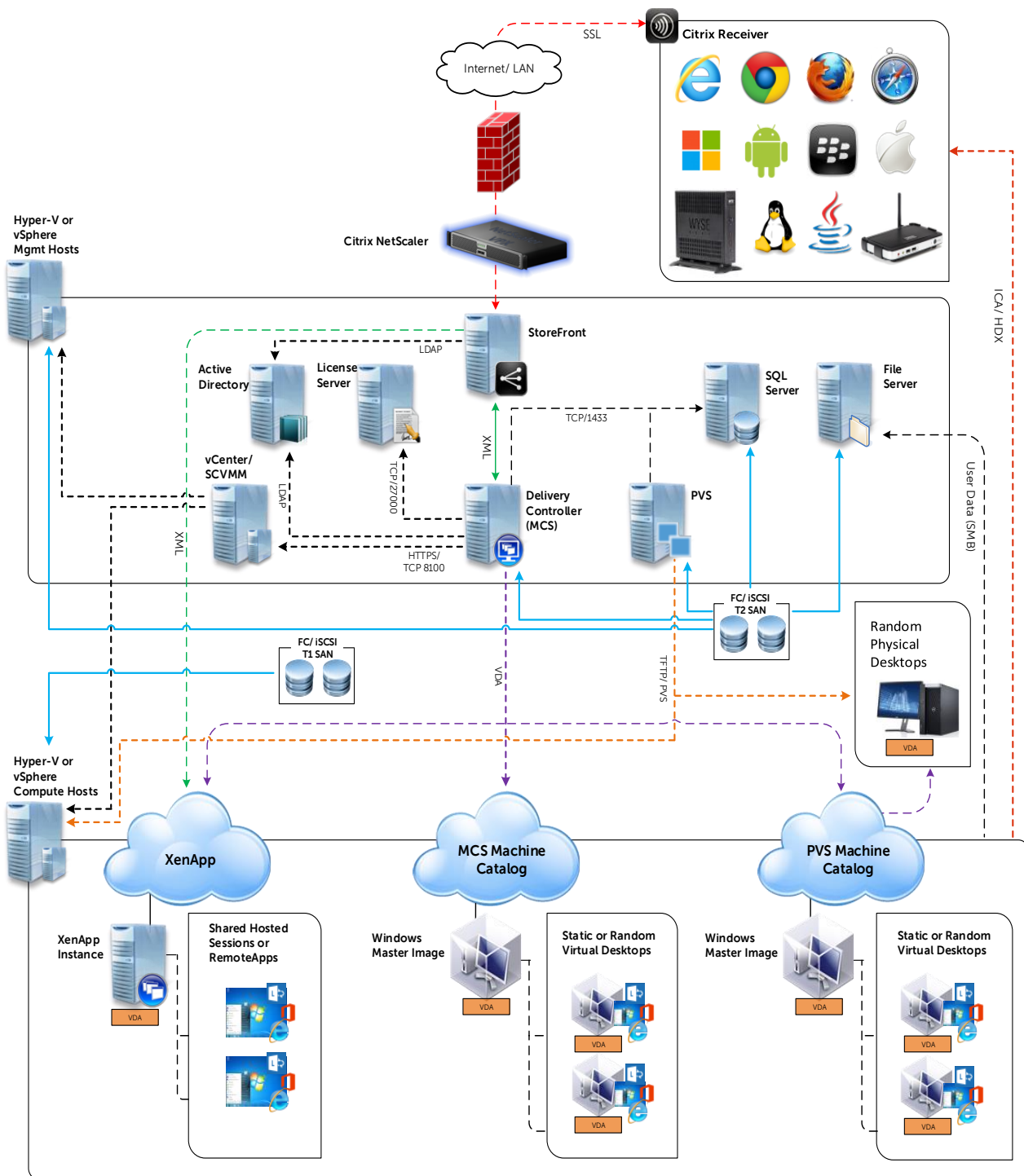

6 Customer Provided Stack Components

6.1 Customer Provided Storage Requirements

In the event that a customer wishes to provide his or her own storage array solution for a Dell Wyse Datacenter solution, the following minimum hardware requirements must be met:

7 Solution Performance and Testing

7.1 Load Generation and Monitoring

7.1.1 Login VSI 4 – Login Consultants

Login VSI is the de-facto industry standard tool for testing VDI environments and server-based computing / terminal services environments. It installs a standard collection of desktop application software (e.g. Microsoft Office, Adobe Acrobat Reader) on each VDI desktop; it then uses launcher systems to connect a specified number of users to available desktops within the environment. Once the user is connected the workload is started via a logon script which starts the test script once the user environment is configured by the logon script. Each launcher system can launch connections to a number of 'target' machines (i.e. VDI desktops), with the launchers being managed by a centralized management console, which is used to configure and manage the Login VSI environment.

7.1.2 Liquidware Labs Stratusphere UX

Stratusphere UX was used during each test run to gather data relating to User Experience and desktop performance. Data was gathered at the Host and Virtual Machine layers and reported back to a central server (Stratusphere Hub). The hub was then used to create a series of "Comma Separated Values" (.csv) reports which have then been used to generate graphs and summary tables of key information. In addition the Stratusphere Hub generates a magic quadrate style scatter plot showing the Machine and IO experience of the sessions. The Stratusphere hub was deployed onto the core network therefore its monitoring did not impact the servers being tested. This core network represents an existing customer environment and also includes the following services:

- Active Directory
- DNS
- DHCP
- Anti-Virus

Stratusphere UX calculates the User Experience by monitoring key metrics within the Virtual Desktop environment, the metrics and their thresholds are shown in the following screen shot:

7.1.3 EqualLogic SAN HQ

EqualLogic SANHQ was used for monitoring the Dell EqualLogic storage units in each bundle. SAN HQ has been used to provide IOPS data at the SAN level; this has allowed the team to understand the IOPS required by each layer of the solution. This report details the following IOPS information;

- Citrix Provisioning Server IOPS (Read IOPS for the vDisks)
- Desktop Write IOPS (WriteCache temporary session data)
- File Server IOPS for User Profiles and Home Directories
- SQL Server IOPS required to run the solution databases
- Infrastructure VM IOPS (the IOPS required to run all the infrastructure Virtual servers)

7.1.4 VMware vCenter

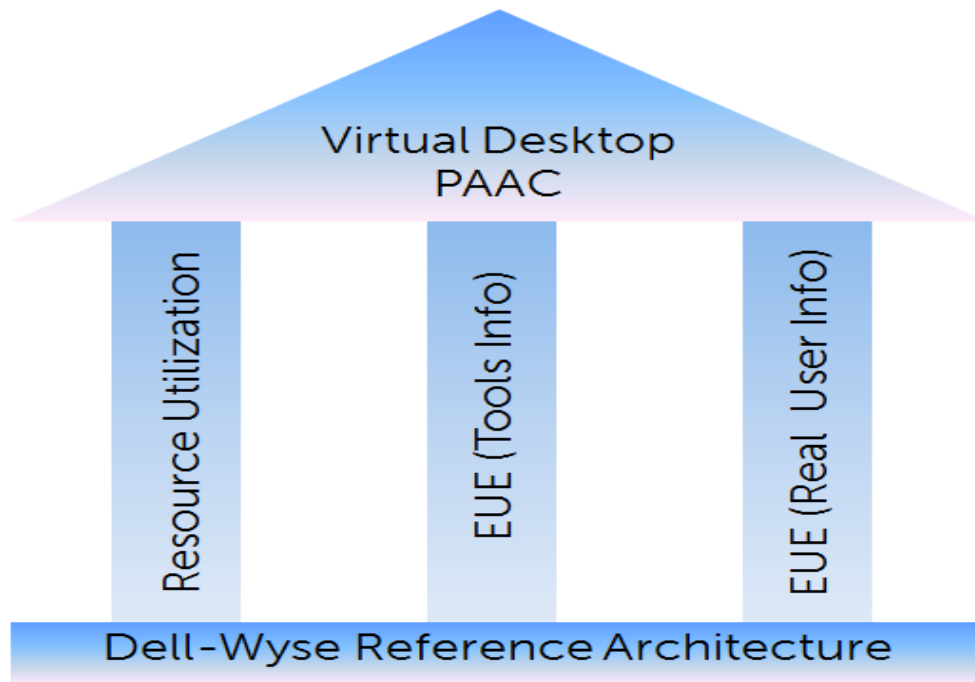
VMware vCenter was used for VMware vSphere-based solutions to gather key data (CPU, Memory and Network usage) from each of the desktop hosts during each test run. This data was exported to .csv files for each host and then consolidated to show data from all hosts. While the report does not include specific performance metrics for the Management host servers, these servers were monitored during testing and were seen to be performing at an expected performance level.

7.1.5 Microsoft Perfmon

Microsoft Perfmon was utilized to collect performance data for tests performed on the Hyper-V platform.

7.2 Performance Analysis Methodology

In order to ensure the optimal combination of end-user experience (EUE) and cost-per-user, performance analysis and characterization (PAAC) on Dell Wyse Datacenter solutions is carried out using a carefully designed, holistic methodology that monitors both hardware resource utilization parameters and EUE during load-testing. This methodology is based on the three pillars shown below. Login VSI is currently the load-testing tool used during PAAC of Dell Wyse Datacenter solutions; Login VSI is the de-facto industry standard for VDI and server-based computing (SBC) environments and is discussed in more detail below:



Each of the pillars shown in the above diagram is discussed in more detail below.

7.2.1 Resource Utilization

Poor end-user experience is one of the main risk factors when implementing desktop virtualization but the root cause for poor end-user experience is resource contention – hardware resources at some point in the solution have been exhausted, thus causing the poor end-user experience. In order to ensure that this has not happened (and that it is not close to happening), PAAC on Dell Wyse Datacenter solutions monitors the relevant resource utilization parameters and applies relatively conservative thresholds as shown in the table below. As discussed above, these thresholds are carefully selected to deliver an optimal combination of good end-user experience and cost-per-user, while also providing burst capacity for seasonal / intermittent spikes in usage. These thresholds are used to decide the number of virtual desktops (density) that are hosted by a specific hardware environment (i.e. combination of server, storage and networking) that forms the basis for a Dell Wyse Datacenter RA.

7.2.2 EUE (Tools Info)

Good EUE is one of the primary factors in determining the success of a VDI implementation. As a result of this fact, a number of vendors have developed toolsets that monitor the environmental parameters that are relevant to EUE. PAAC on Dell Wyse Datacenter solutions uses the Liquidware Labs Stratusphere UX tool to ensure that good EUE is delivered for the density numbers defined in our RAs. More specifically, our PAAC analysis uses a scatter plot provided by Stratusphere UX which presents end-user experience for all load-tested users. Stratusphere UX does this by algorithmically combining relevant parameters in relation to virtual desktop machine experience (e.g. login duration) and virtual desktop IO experience (e.g. disk queue length) to provide a plot that shows end-user experience as good, fair or poor using a magic-quadrant type approach.

7.2.3 EUE (Real User Info)

In order to complement the tools based end-user experience information gathered using Stratusphere UX (as described above) and to provide further certainty around the performance of Dell Wyse Datacenter solutions, PAAC on our solutions also involves a user logging into one of the solutions when they are fully loaded (based on the density specified in the relevant RA) and executing user activities that are representative of the user type being tested (e.g. task, knowledge or power user). An example is a knowledge worker executing a number of appropriate activities in Excel. The purpose of this activity is to verify that the end-user experience is as good as the user would expect on a physical laptop or desktop.

7.2.4 Dell Wyse Datacenter Workloads and Profiles

It's important to understand user workloads and profiles when designing a desktop virtualization solution in order to understand the density numbers that the solution can support. At Dell, we use five workload / profile levels, each of which is bound by specific metrics and capabilities. In addition, we use workloads and profiles that are targeted at graphics-intensive use cases. We present more detailed information in relation to these workloads and profiles below but first it is useful to define the terms "workload" and "profile" as they are used in this document.

- **Profile:** This is the configuration of the virtual desktop - number of vCPUs and amount of RAM configured on the desktop (i.e. available to the user).
- **Workload:** This is the set of applications used by performance analysis and characterization (PAAC) of Dell Wyse Datacenter solutions e.g. Microsoft Office applications, PDF Reader, Internet Explorer etc.

7.2.5 Dell Wyse Datacenter Profiles

The table shown below presents the profiles used during PAAC on Dell Wyse Datacenter solutions. These profiles have been carefully selected to provide the optimal level of resources for common use cases.

7.2.6 Dell Wyse Datacenter Workloads

Load-testing on each of the profiles described in the above table is carried out using an appropriate workload that is representative of the relevant use case. In the case of the non-graphics workloads, these workloads are Login VSI workloads and in the case of graphics workloads, these are specially designed workloads that stress the VDI environment to a level that is appropriate for the relevant use case. This information is summarized in the table below:

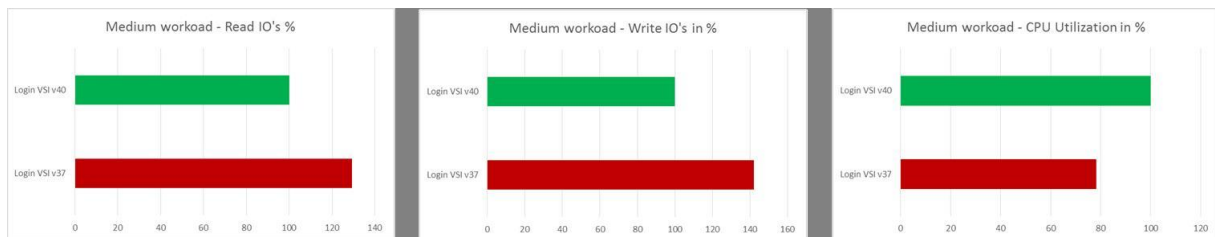
As noted in the table above, further information for each of the workloads is given below. It is noted that for Login VSI testing, the following login and boot paradigm is used:

- For single-server / single-host testing (typically carried out to determine the virtual desktop capacity of a specific physical server), users are logged in every 30 seconds.
- For multi-host / full solution testing, users are logged in over a period of 1-hour, to replicate the normal login storm in an enterprise environment.
- All desktops are pre-booted in advance of logins commencing.

For all testing, all virtual desktops run an industry-standard anti-virus solution (currently McAfee VirusScan Enterprise) in order to fully replicate a customer environment.

7.2.6.1 Login VSI 3 versus Login VSI 4

PAAC on Dell Wyse Datacenter solutions is currently carried out using Login VSI version 4. However, some previous Dell Wyse Datacenter solutions used Login VSI version 3 for this PAAC work. Login VSI version 3 used a slightly different set of workloads to those used by Login VSI 4 and in order to allow comparison of results obtained using these different Login VSI versions, it is useful to be aware of the information presented in the figure below. This information (for Login VSI medium workload) illustrates higher CPU utilization and lower disk IO for Login VSI 4 (green / upper set of graphs) when compared to Login VSI3 (red / lower set of graphs). The exact variation between these Login VSI versions will vary between environments.



7.2.6.2 Login VSI Light Workload

Compared to the Login VSI medium workload described below, the light workload runs fewer applications (mainly Excel and Internet Explorer with some minimal Word activity) and starts/stops the applications less frequently. This results in lower CPU, memory and disk IO usage.

7.2.6.3 Login VSI Medium Workload

The Login VSI medium workload is designed to run on 2vCPU's per desktop VM. This workload emulates a medium knowledge worker using Office, IE, PDF and Java/FreeMind. The Login VSI medium workload has the following characteristics

- Once a session has been started the workload will repeat (loop) every 48 minutes.
- The loop is divided in four segments; each consecutive Login VSI user logon will start a different segment. This ensures that all elements in the workload are equally used throughout the test.
- The medium workload opens up to five applications simultaneously.
- The keyboard type rate is 160 ms for each character.
- Approximately two minutes of idle time is included to simulate real--world users.

Each loop opens and uses:

- Outlook, browse messages.
- Internet Explorer, browse different webpages and a YouTube style video (480p movie trailer) is opened three times in every loop.
- Word, one instance to measure response time, one instance to review and edit a document.
- Doro PDF Printer & Acrobat Reader, the Word document is printed and exported to PDF.
- Excel, a very large randomized sheet is opened.
- PowerPoint, a presentation is reviewed and edited.
- FreeMind, a Java based Mind Mapping application.

7.2.6.4 Login VSI Heavy Workload

The heavy workload is based on the medium workload except that the heavy workload:

- Begins by opening four instances of Internet Explorer. These instances stay open throughout the workload loop.
- Begins by opening two instances of Adobe Reader. These instances stay open throughout the workload loop.
- There are more PDF printer actions in the workload.
- Instead of 480p videos a 720p and a 1080p video are watched.
- Increased the time the workload plays a flash game.
- The idle time is reduced to two minutes.

7.2.7 Workloads Running on Shared Graphics Profile

Graphics hardware vendors (e.g. Nvidia) typically market a number of graphics cards that are targeted at different markets. Consequently, it is necessary to provide two shared graphics workloads – one for mid-range cards and the other for high-end cards. These workloads are described in more detail below. It is noted that technologies such as the Citrix / Nvidia vGPU technology (where the Nvidia drivers reside on the virtual desktop, giving shared-level density with near pass-through functionality) mean that in some cases, the higher-end workloads, traditionally used for pass-through GPU PAAC, may be more appropriate for shared GPU PAAC. Such scenarios will explicitly state the workload used.

7.2.8 Workloads Running on Pass-through Graphics Profile

Similarly for pass-through graphics, two workloads have been defined in order to align with graphics cards of differing capabilities.

Mid-Range Pass-through Graphics Workload

The mid-range pass-through graphics workload consists of one desktop running Heaven Benchmark and n-1 desktops running eFigures Advanced Animation activity where n = per-host virtual desktop density being tested at any specific time.

High-End Pass-through Graphics Workload

One desktop running Viewperf benchmark; n-1 desktops running AutoCAD auto-rotate activity where n = per host virtual desktop density being tested at any specific time.

7.3 Testing and Validation

7.3.1 Testing Process

The purpose of the single server testing is to validate the architectural assumptions made around the server stack. Each user load is tested against four runs. A pilot run is conducted to validate that the infrastructure is functioning and valid data is captured. Subsequently three more runs are conducted allowing for correlation of data. Summary of the test results is listed out in the below mentioned tabular format.

At different stages of the testing the testing team will complete some manual "User Experience" Testing while the environment is under load. This will involve a team member logging into a session during the run and completing tasks similar to the User Workload description. While this experience is subjective, it will help provide a better understanding of the end user experience of the desktop sessions, particularly under high load, and ensure that the data gathered is reliable.

Login VSI has two modes for launching user's sessions:

- Parallel

Sessions are launched from multiple launcher hosts in a round robin fashion; this mode is recommended by Login Consultants when running tests against multiple host servers. In parallel mode the VSI console is configured to launch a number of sessions over a specified time period (specified in seconds)

- Sequential

Sessions are launched from each launcher host in sequence, sessions are only started from a second host once all sessions have been launched on the first host and this is repeated for each launcher host. Sequential launching is recommended by Login Consultants when testing a single desktop host server. The VSI console is configured to launch a specified number of session at a specified interval specified in seconds

All test runs which involved the six desktop hosts were conducted using the Login VSI "Parallel Launch" mode and all sessions were launched over an hour to try and represent the typical 9am logon storm. Once the last user session has connected, the sessions are left to run for 15 minutes prior to the sessions being instructed to logout at the end of the current task sequence, this allows every user to complete a minimum of two task sequences within the run before logging out. The single server test runs were configured to launch user sessions every 60 seconds, as with the full bundle test runs sessions were left to run for 15 minutes after the last user connected prior to the sessions being instructed to log out.

7.4 XenDesktop Test Results

This validation was performed for XenDesktop 7.6 delivering VDI desktops on two x R730 compute hosts, one running vSphere ESXi 5.5 and the other Windows 2012 R2 Hyper-V. Each compute host was outfitted with 256 GB RAM (1600 MHz), dual 3.0 GHz E5-2690v2 processors, and 10 300GB 15K RPM SAS drives in a RAID 10 configuration. Each host comes with Broadcom 5720 4-port NICs running 1Gb Ethernet. Two NICs were connected on each compute host and teamed. All VDI desktops were hosted on the local disk storage on the compute hosts.

The management host was a dedicated R730 running Windows Server 2012 R2 with the same hardware configuration as the compute hosts, with the exception of an added 10GbE dual-port SFP NIC. The management host connects to an EqualLogic PS6010 storage array via a PowerConnect 8024F 10GbE switch to store all of the management server VMs. For each hypervisor scenario, the compute host had its own separate stack of management VMs. The management VMs for each compute host were deployed on the management host using the following configurations:

- 1 VM, 4 vCPU and 8 GB RAM for XenDesktop 7.6 DDC
- 1 VM, 1 vCPU and 2 GB RAM for StoreFront
- 1 VM, 1 vCPU and 2 GB RAM for Licensing Server
- 1 VM, 4 vCPU and 24 GB RAM for PVS 7.1 (powered off during MCS testing)
- 1 VM, 2 vCPU and 8 GB RAM each for VMware vCenter 5.5 or Microsoft System Center 2012 R2
- 1 VM, 2 vCPU and 8 GB RAM for Microsoft SQL Server 2012 SP1

For testing with MCS provisioning, each compute host used a total of 5 management VMs (DDC, Storefront, Licensing, SQL, and vCenter/System Center). For testing with PVS provisioning, a PVS Server was enabled for each compute host.

The Desktop images were built using Windows 8.1 Enterprise and Microsoft Office 2010. For Standard and Enhanced workloads the 32-bit versions were used, but for Professional workloads the 64-bit versions were installed.

The PVS desktops were each configured to boot from vDisk hosted on the PVS Server VM. Each PVS desktop had a local write cache disk attached that was sized according to the formula $1.5 * \text{Memory} + 1 \text{ GB}$. The write cache disks were created to use thin provisioning in all of the test cases below, and were formatted with NTFS. In PVS the vDisks were each configured to use only the target device's local disk for the write cache ("Cache on device hard drive").

The following table illustrates the CPU and memory configuration of the user profiles as tested for both ESXi and Hyper-V.

Windows 8 desktops were configured with some optimizations to enable the Login VSI workload to run and in order to prevent long delays in the login process. Previous experience with Windows 8 has shown that the login delays are somewhat longer than experienced with Windows 7. These were alleviated by performing the following customizations:

- Bypass Windows Metro screen to go straight to the Windows Desktop. This is performed by a scheduled task provided by Login Consultants at logon time
- Disable the **"Hi, while we're getting things ready..."** first time login animation. In random assigned Desktop groups each login is seen as a first time login. This registry setting can prevent the animation and therefore the overhead associated with it.

- McAfee antivirus is configured to treat the Login VSI process VSI32.exe as a low risk process and to not scan that process. Long delays during login of up to 1 minute were detected as VSI32.exe was scanned
- Before closing or sealing the Golden image (either for PVS or MCS), perform a number of logins using domain accounts. This was observed to significantly speed up the logon process for VMs deployed from the Golden image. It is assumed that Windows 8 has a learning process when logging on to a domain for the first time.

Validation was performed using Dell Wyse Solutions Engineering standard testing methodology using LoginVSI 4 load generation tool for VDI benchmarking that simulates production user workloads. Stratusphere UX was not used in this validation since it is not yet compatible with the Windows 8.1 Enterprise.

Each test run was configured to allow for 30 minutes of steady state operations after the initial session launch and login period. This allowed for all sessions to be logged in and active for a significant period of time to allow statistical measuring during steady state operations.

The following table summarizes the steady state test results for the various workloads and configurations. The charts in the sections below show more details about the max values for CPU, memory, IOPS, and Network during the test run.

* CPU % for ESX Hosts was adjusted to account for the fact that on Intel E5-2600v2 series processors the ESX host CPU metrics will exceed the rated 100% for the host if Turbo Boost is enabled (by default). E5-2690v2 CPUs rated at 100% utilization in vSphere is 60000 MHz, while actual usage with Turbo Boost has been seen to reach 67000 MHz in some cases. The Adjusted CPU % Usage is based on 100% = 66000 MHz usage and is used in all charts for ESX to account for Turbo Boost. Windows Hyper-V metrics by comparison do not report usage in MHz, so only the reported CPU % usage is used here.

In terms of CPU usage, ESX seems to show less usage at the higher-intensity workloads (Enhanced and Professional desktops use 2 vCPUs) but higher usage at the Standard Workload (1 vCPU). Hyper-V seems to do somewhat better on the Standard Workload with 170 users but worse on the heavier workloads.

Memory usage is a different story however, as many of the ESX test runs approached very close to the memory limit for the host even while CPU was safely below limits. Hyper-V on the other hand shows some room for increased density at the heavier workloads since the Memory usage was significantly lower than the host limit.

Network utilization was very consistent across all tests, showing as expected that PVS required more Network IO per desktop since it was offloading the disk IOPS to the network. Also in the PVS charts below you can clearly see that the network utilization graph resembles the IOPS graph, while in MCS the network graph is clearly shaped differently from IOPS. The only thing of note is that Hyper-V produced 10-15% more network traffic per user in PVS than the same workloads on ESXi.

7.4.1 Recommended Densities

Based on the test results at the selected densities, we propose that it is reasonable to achieve higher densities in some cases. For instance on Hyper-V using MCS for an Enhanced workload with 110 users, CPU usage was 82% in steady state; and only 187 GB (73% of 256 GB) of memory was used. This implies that, all things being equal, a higher density of users at that workload could also be successful. Scaling the CPU usage to 90% yields a potential density of 120 users, and scaling the RAM usage to 90% yields a potential density of 135 users. Taking the lesser of these two densities implies that 120 Enhanced users utilize the host resources without exceeding any limits, so the new recommended user density for that workload is 120 users. In other cases, the recommendation may be lower than the tested density. Applying the similar reasoning to other workloads, while adjusting to maintain a similar pattern of densities

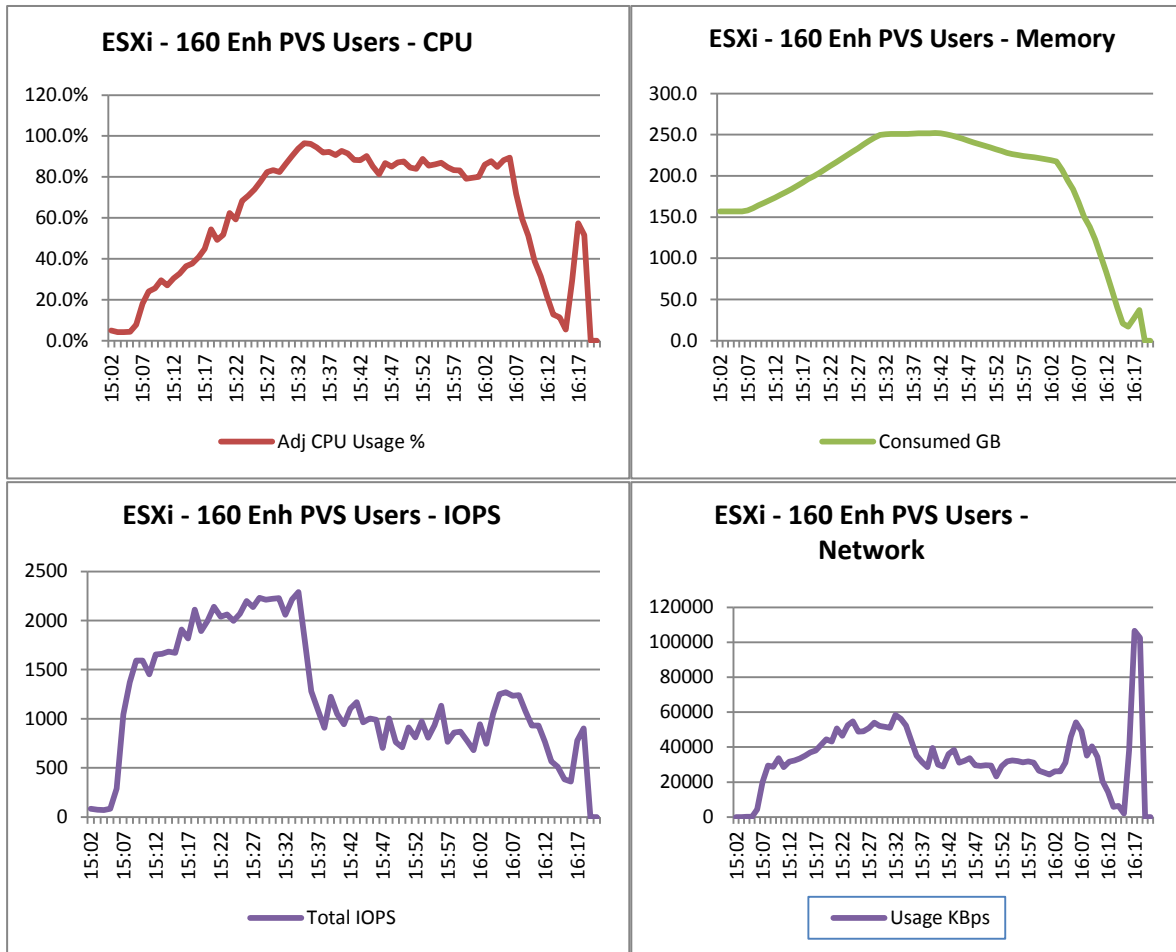

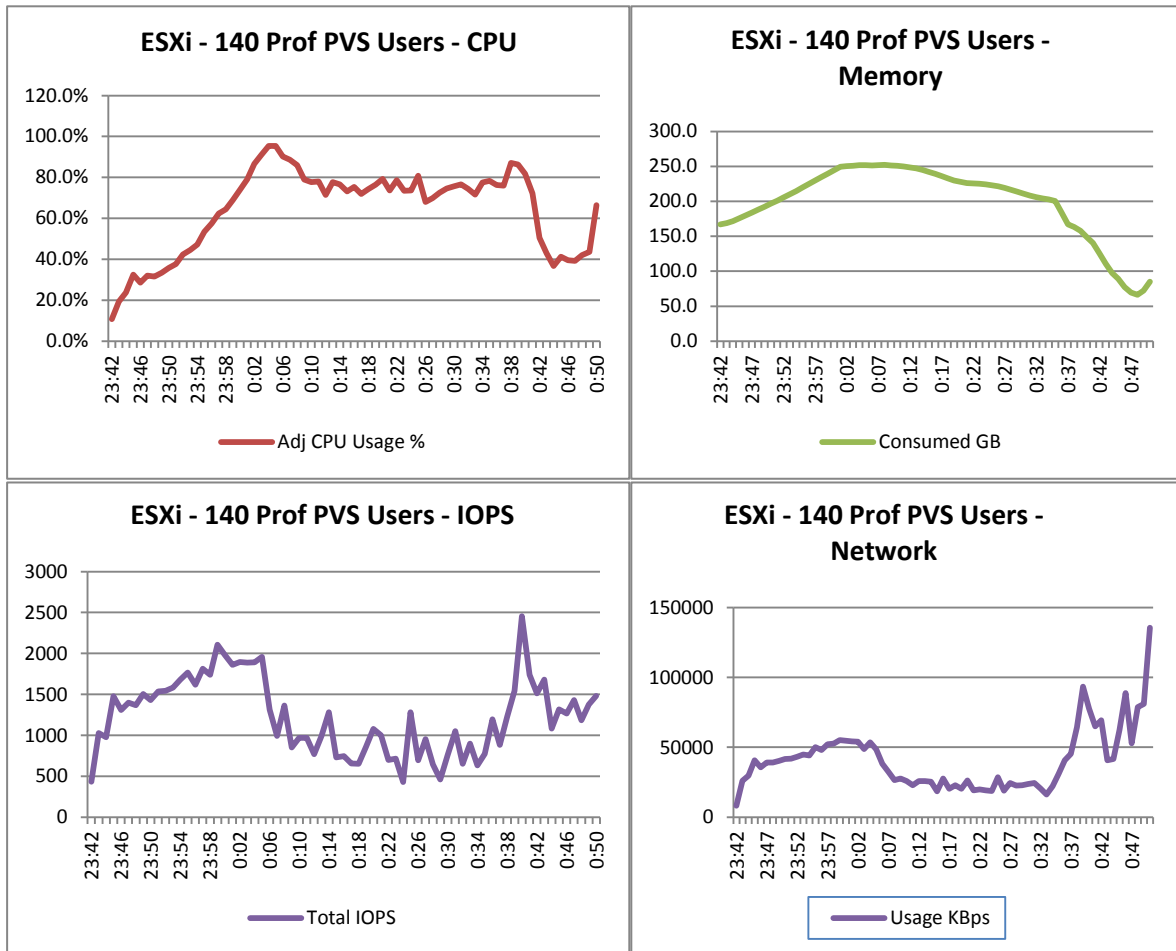

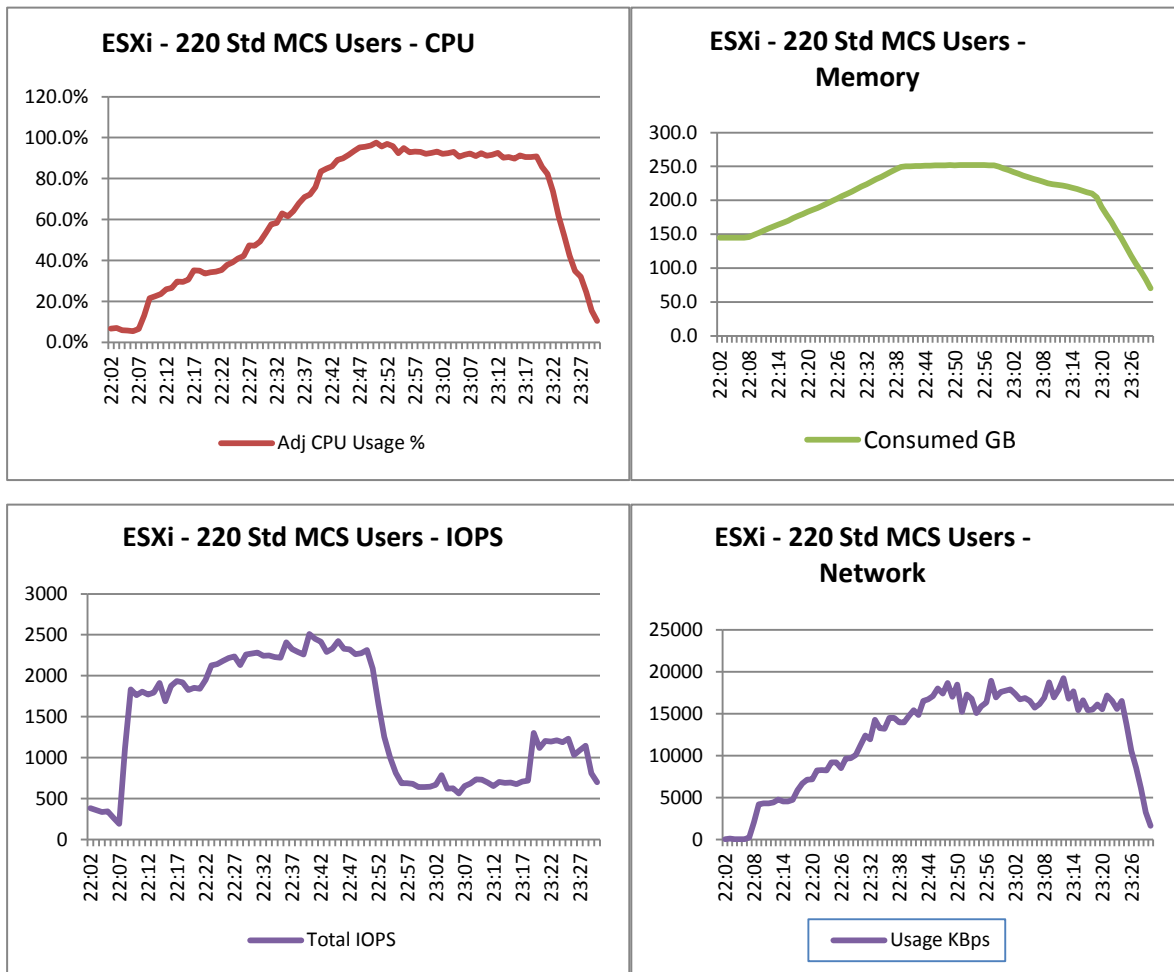

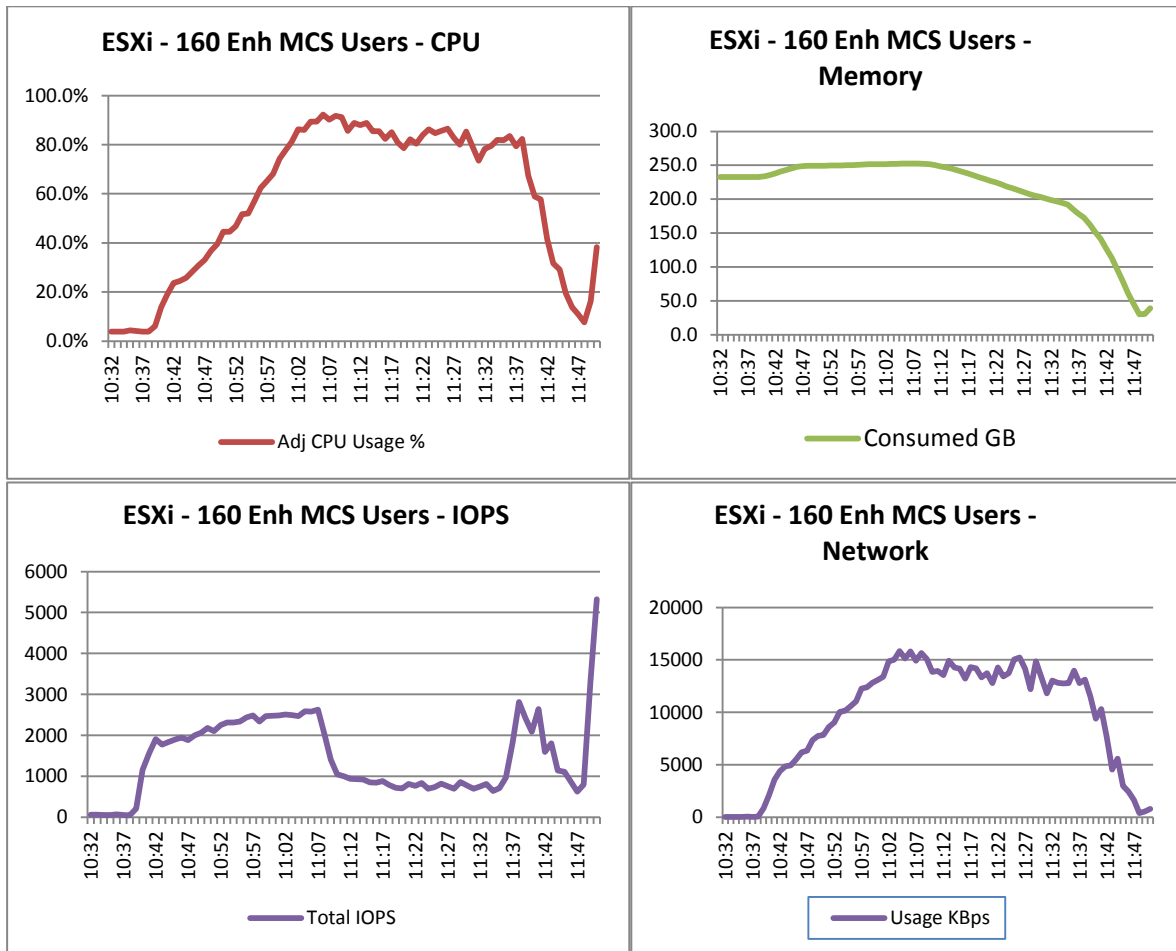

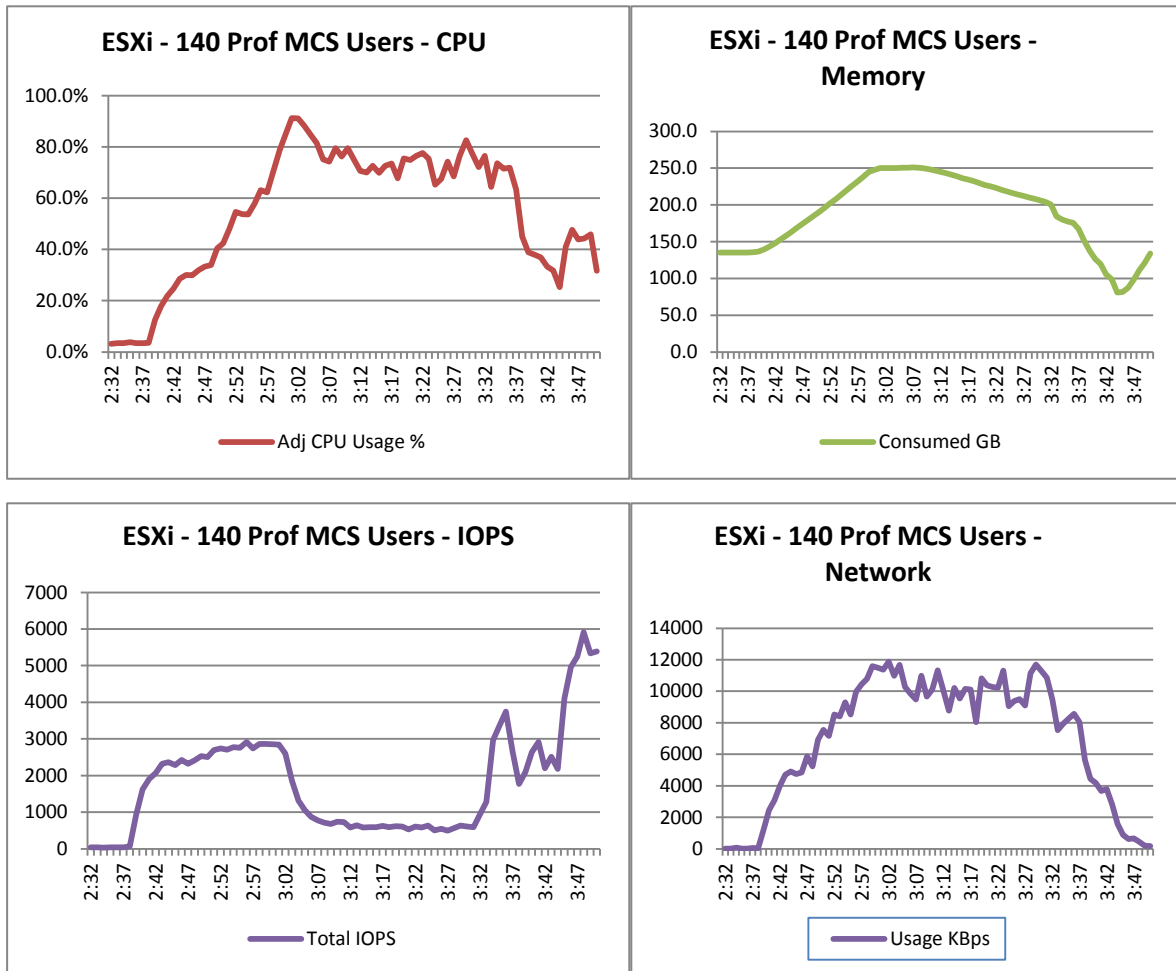

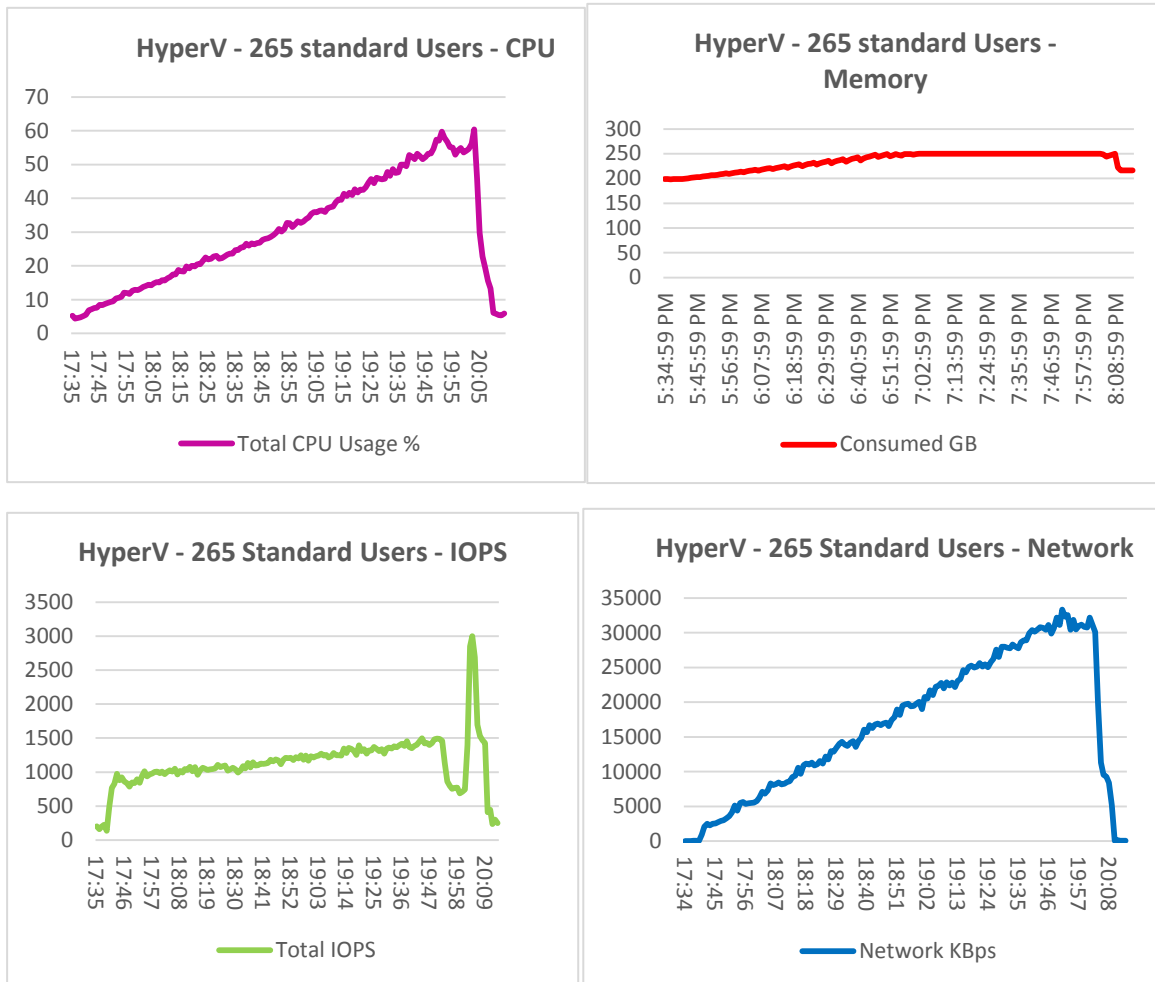

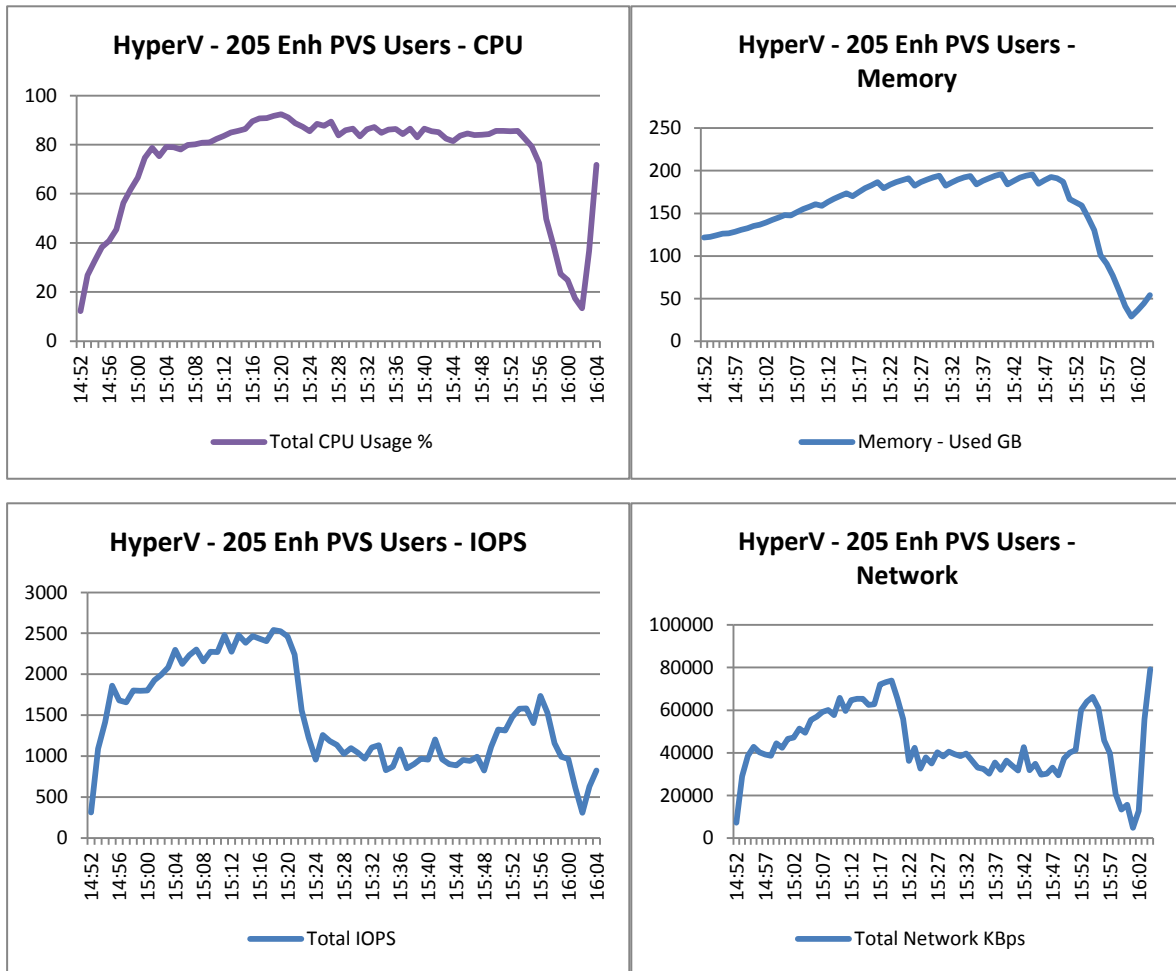

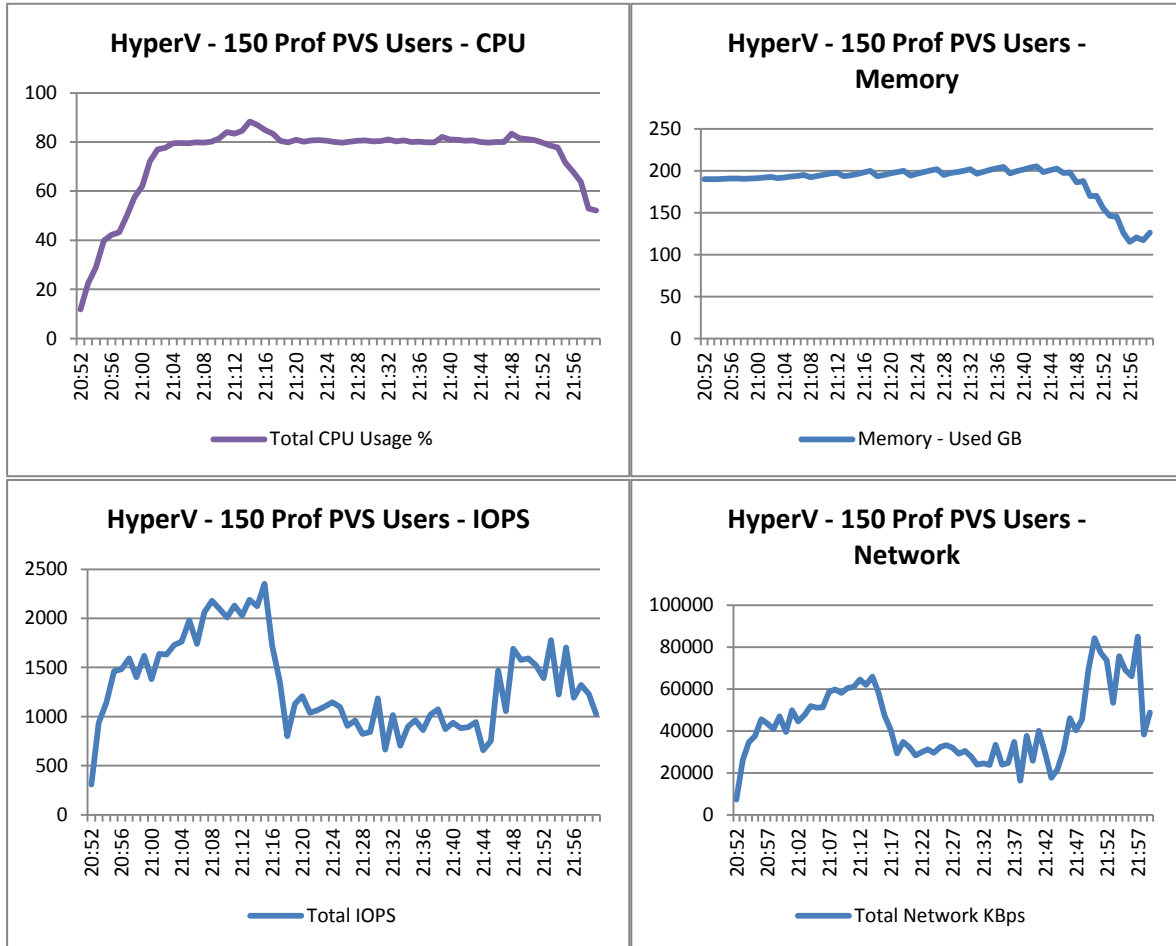

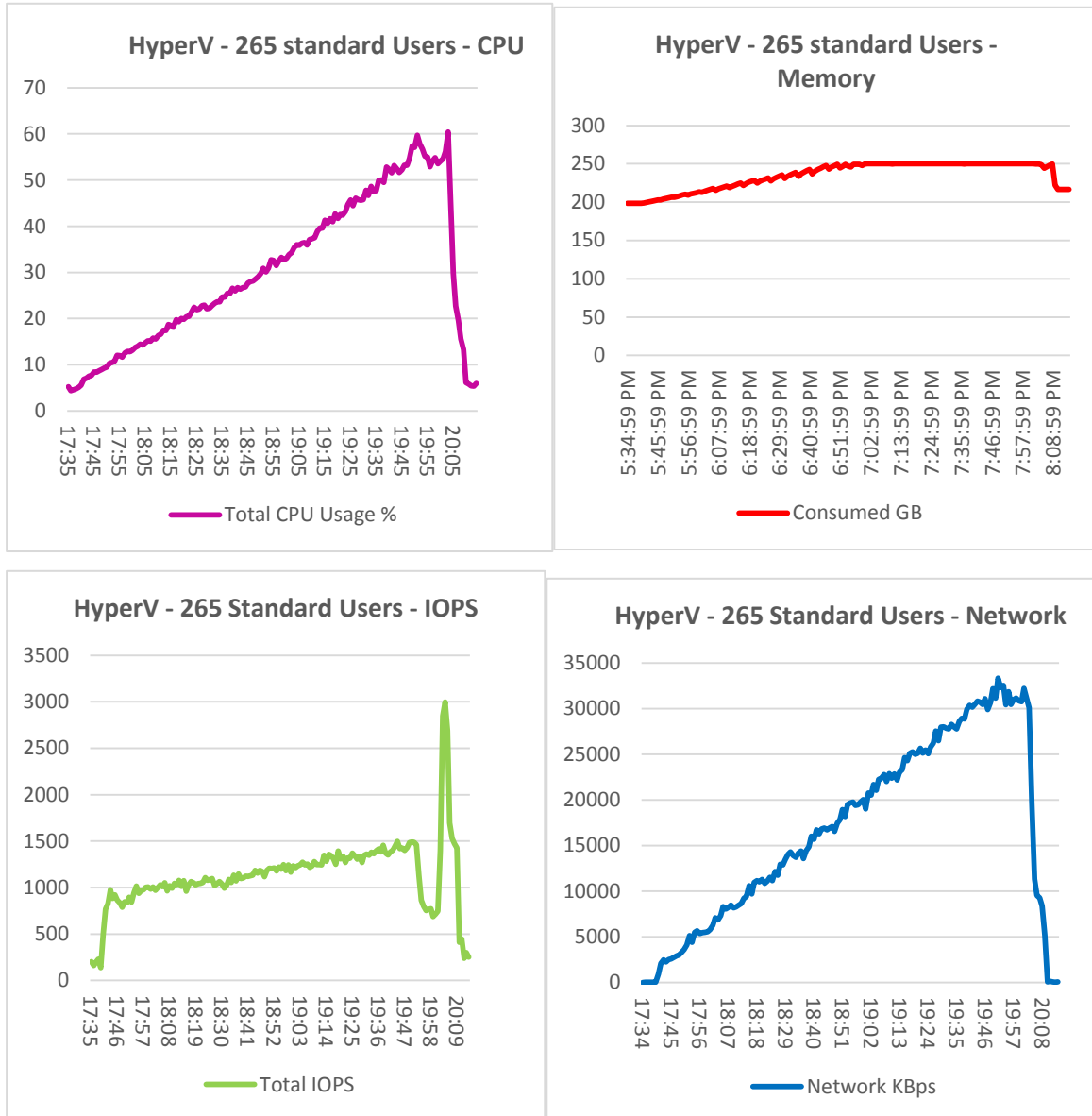

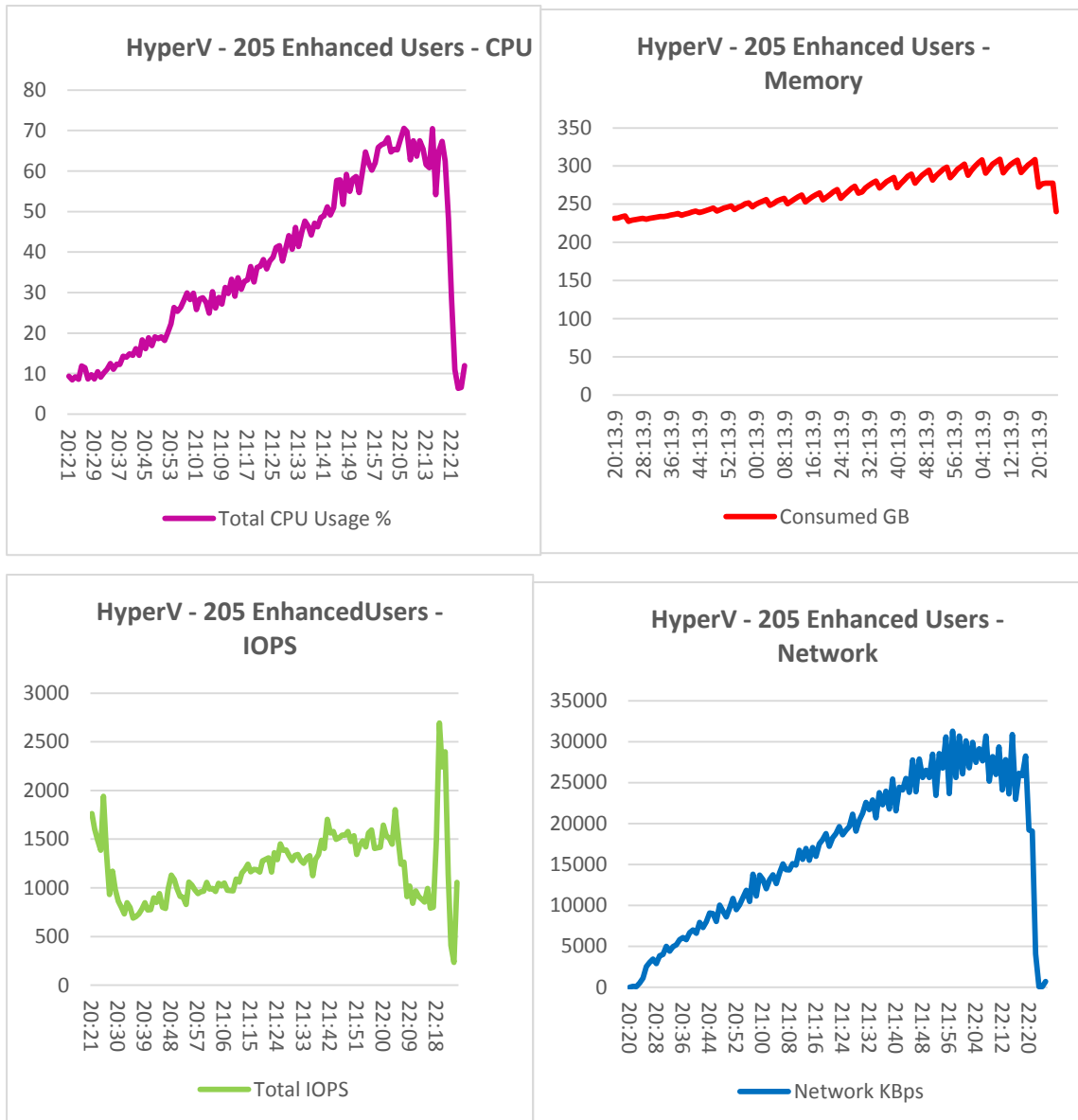

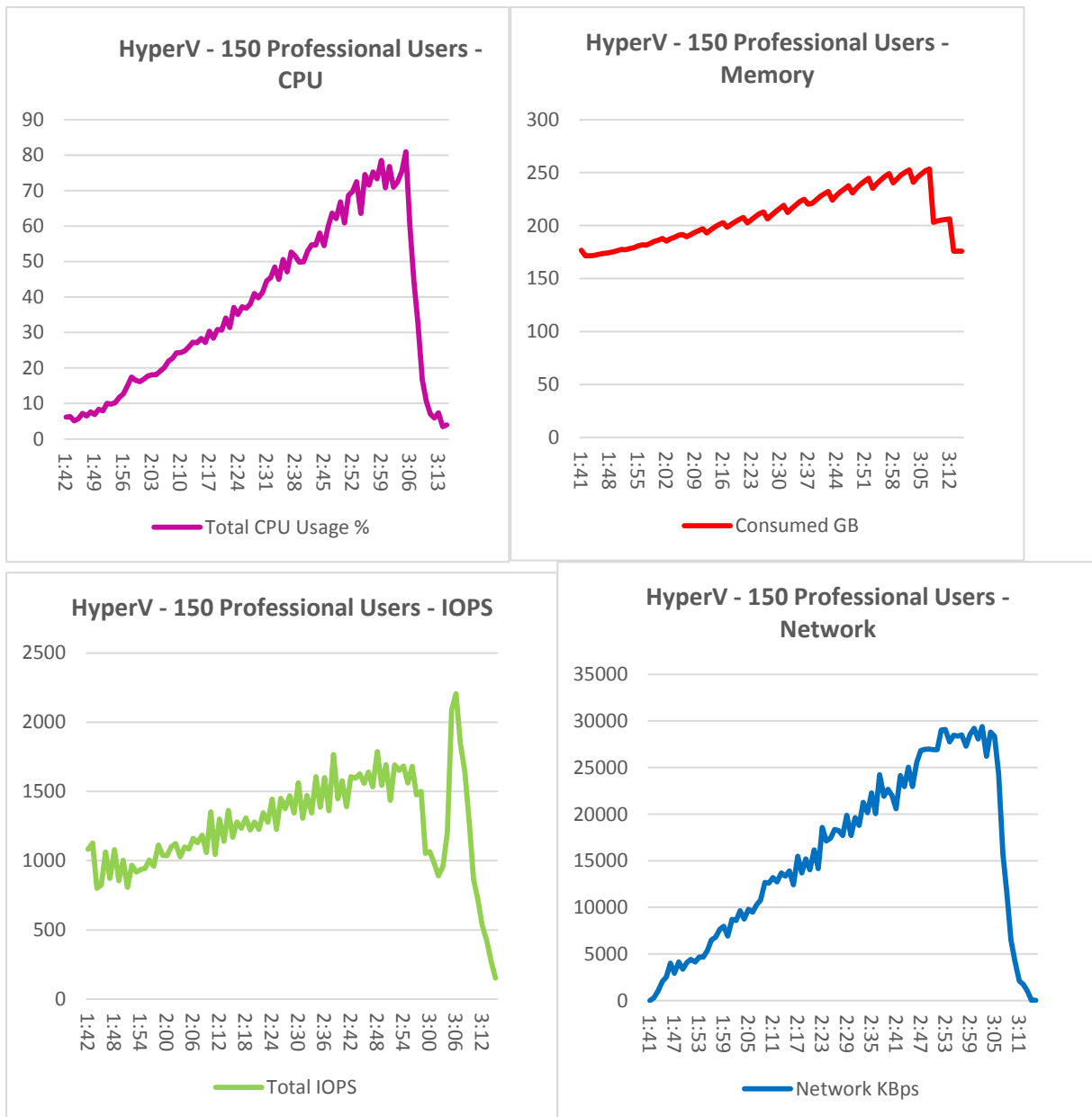

7.4.4 Local Tier 1 for Blades Test Results

7.4.4.1 Configuration

The purpose of this validation was to investigate the feasibility of providing a XenDesktop MCS based VDI solution on Dell M620 blade servers in Dell M1000E chassis that does not require access to an external storage array. All storage requirements are provided by internal solid state disks installed in the M620 blades. This includes both management and compute storage. External

access is only required by the solution for client access to the XenDesktop VMs and for access to other infrastructure such as Active Directory within the environment

This validation was performed for XenDesktop 7.6 delivering VDI desktops on a single M620 Compute server running vSphere ESXi 5.5. The Compute Host was outfitted with 256 GB RAM (1600 MHz), dual 3.0 GHz Ivy Bridge E5-2690v2 processors, and 2 800 MLC SSD drives in a RAID 1 configuration. The compute host connected to the SSD drives through a Dell H310 PERC controller

In the solution validated the management host was a separate M620 with 2 * 15K 300GB disks in a RAID 1 configuration connected by a PERC H310. However, for a full solution it is envisaged that there would not be a dedicated management host in the blade chassis. Instead, the management components will run on any of the Compute nodes. Each node is identically configured in the same way as the compute node above. Based on the latencies observed during the Login VSI tests on the compute nodes the solution should scale well to accommodate up to 16 blades. In addition the Virtual Center appliance was deployed with sufficient capacity for up to 20 hosts and 2000 VMs.

The M1000E blade chassis was fitted with a Dell MIO aggregator. This supported the external communication from the chassis for VDI and Active directory access, and provided support for all the internal communication between the various VMs hosted on the blades in the chassis. A simple management configuration was implemented using 3 management VMs only, a vSphere Virtual Center appliance, Citrix XenDesktop DDC, and Citrix Storefront server and license server combined. SQL Server 2008 Express was installed on the DDC to support XenDesktop

- 1 VM, 2 vCPU and 4 GB RAM for XenDesktop 7.6 DDC plus 30 GB system disk.
- 1 VM, 1 vCPU and 4 GB RAM for Storefront and Licensing server
- 1 VM, 2 vCPU and 8 GB RAM for Virtual Center Appliance, plus 30GB system disk plus 100GB disk for vCenter database

So for testing with MCS provisioning, each Compute host used a total of 3 management VMs (DDC, Storefront and Licensing, and vCenter). For testing with PVS provisioning, a PVS Server was enabled for each Compute Host.

The Desktop images were built using Windows 8.1 Enterprise and Microsoft Office 2010. For Standard and Enhanced workloads the 32-bit versions were used, but for Professional workloads the 64-bit versions were installed.

7.4.4.2 Test Results

Validation was performed using Dell Wyse Solutions Engineering standard PAAC testing methodology using LoginVSI 4 load generation tool for VDI benchmarking that simulates production user workloads. Stratusphere UX was not used in this validation since it is not compatible with the desktop OS, Windows 8.1 Enterprise.

Each test run was configured to allow for 15 minutes of steady state operations after the initial session launch and login period, so that all sessions is logged in and active for a significant period of time so that statistics could be measured during steady state to simulate daily operations.

The following table summarizes the steady state test results for the various workloads and configurations. The charts in the sections below show more details about the max values for CPU, memory, IOPS, and Network during the test run.

*** CPU % for ESX Hosts was adjusted to account for the fact that on Intel E5-2600v2 series processors the ESX host CPU metrics will exceed the rated 100% for the host if Turbo Boost is enabled (by default). With E5-2690v2 CPUs the rated 100% in vSphere is 60000 MHz usage, while actual usage with TB has been seen to reach 67000 MHz in some cases. The Adjusted CPU % Usage is based on 100% = 66000 MHz usage and is used in all charts for ESX to account for Turbo Boost.**





Many of the ESX test runs approached very close to the memory limit for the host even while CPU was safely below limits. ESXi reports however show Active memory usage much lower than consumed with very little memory ballooning in evidence

Network utilization was very consistent across all tests. User profiles were stored on a file server external to the test environment. This accounts for some extra network utilization. However, even for a fully populated bladed with 16 * 170 Standard users the network requirement is 800Mbps. The installed Dell IO aggregators provide 10Gbps connectivity to the external environment so provide plenty of capacity. It is also possible to support the profile storage within the chassis.





Disk latency on the SSD disks remained very low at 0 milliseconds on all the tests. Even during the boot storm when 170 VMs were powered on at approximately the same time the disk latency did not rise above 15 milliseconds.

An addition test was run against the Professional image with none of the desktops prebooted. So, for each session launched the VM had to be powered on before the session started and the test could begin. It is interesting to note that the results are almost identical to the professional test with all desktops powered on. Additionally, the SSD disk latency stayed at 0 ms for the duration of the test.





The SSD volumes provided enough space including the ESXi swap file for all the VMs in for 170 VMs. With the VMs powered off the space usage was as follows. The SSDs also hosted the Windows 32 bit and 64 images required to create the MCS catalogs

The SQL Express data file usage was 112MB. Adding a further 15 hosts should not increase this to more than 1.75GB. With the allocation used in the tests there was 13.7GB free on the DDC so there is room for expansion of the database as further hosts and VMs are added. Space usage on the Management Datastore was as follows. This also includes space used by Windows 8.1 32 bit and 64 bit templates to provision the XenDesktop VMs. It is intended however that the Management node should also be provisioned on 800GB SSDs

- Add extra IOPS (22) within each VSI session for a standard Login VSI test to produce a total of 8000 IOPs on the host during the VSI test. Measure the effect on the latency of the SSD volume
- Perform a logon storm with 170 Standard VSI sessions logging on within a 10 minute interval instead of sessions logging on at 30 second intervals. Measure the effect of the increased logon rate on the SSD volumes

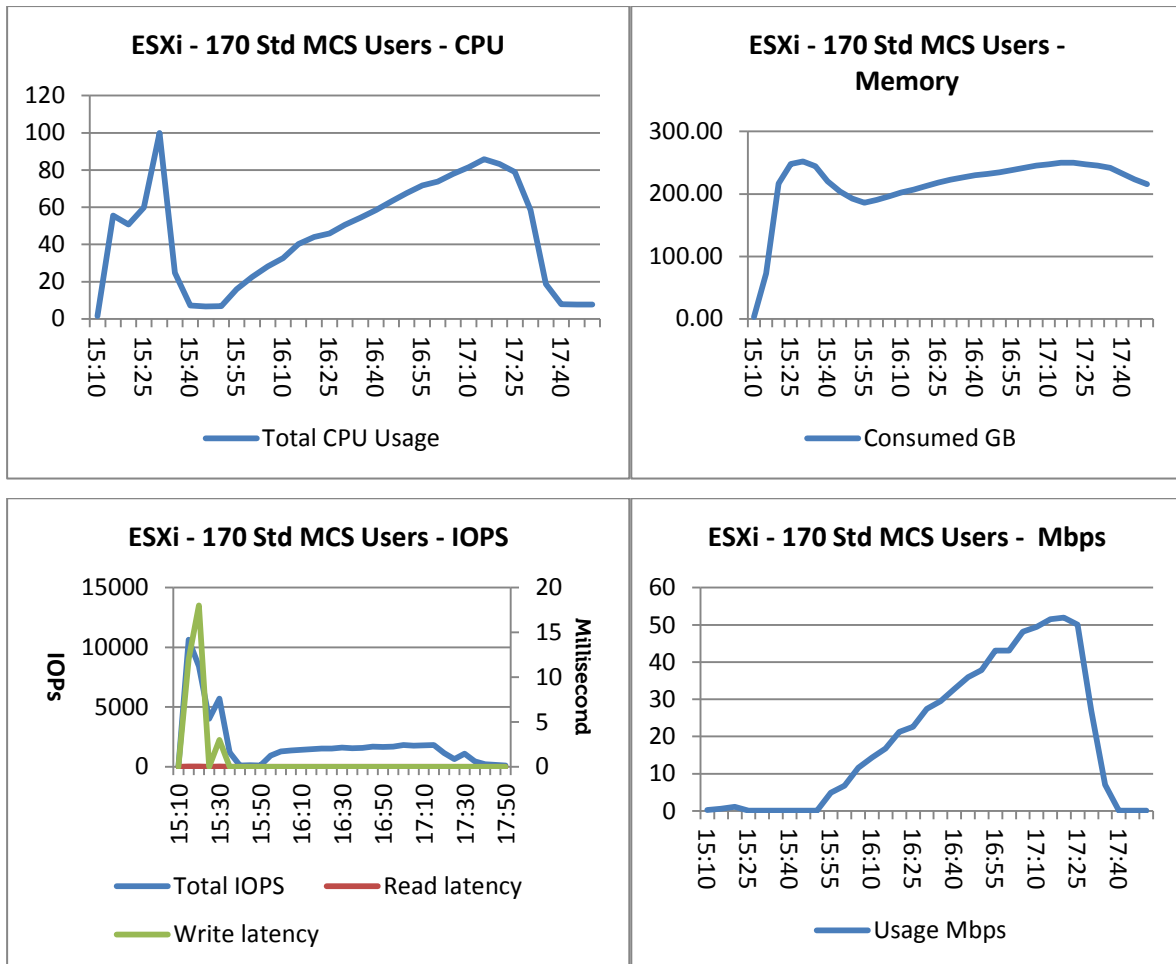

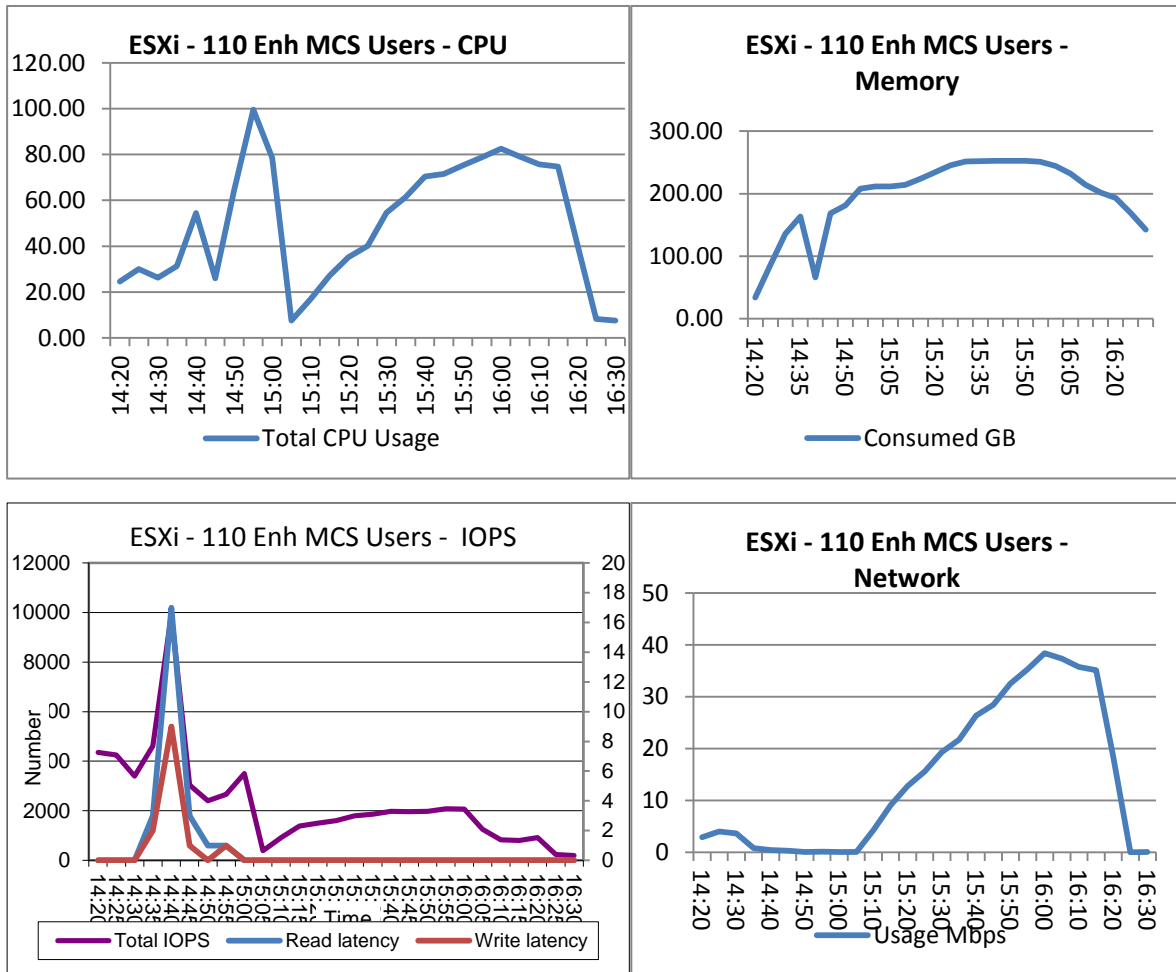

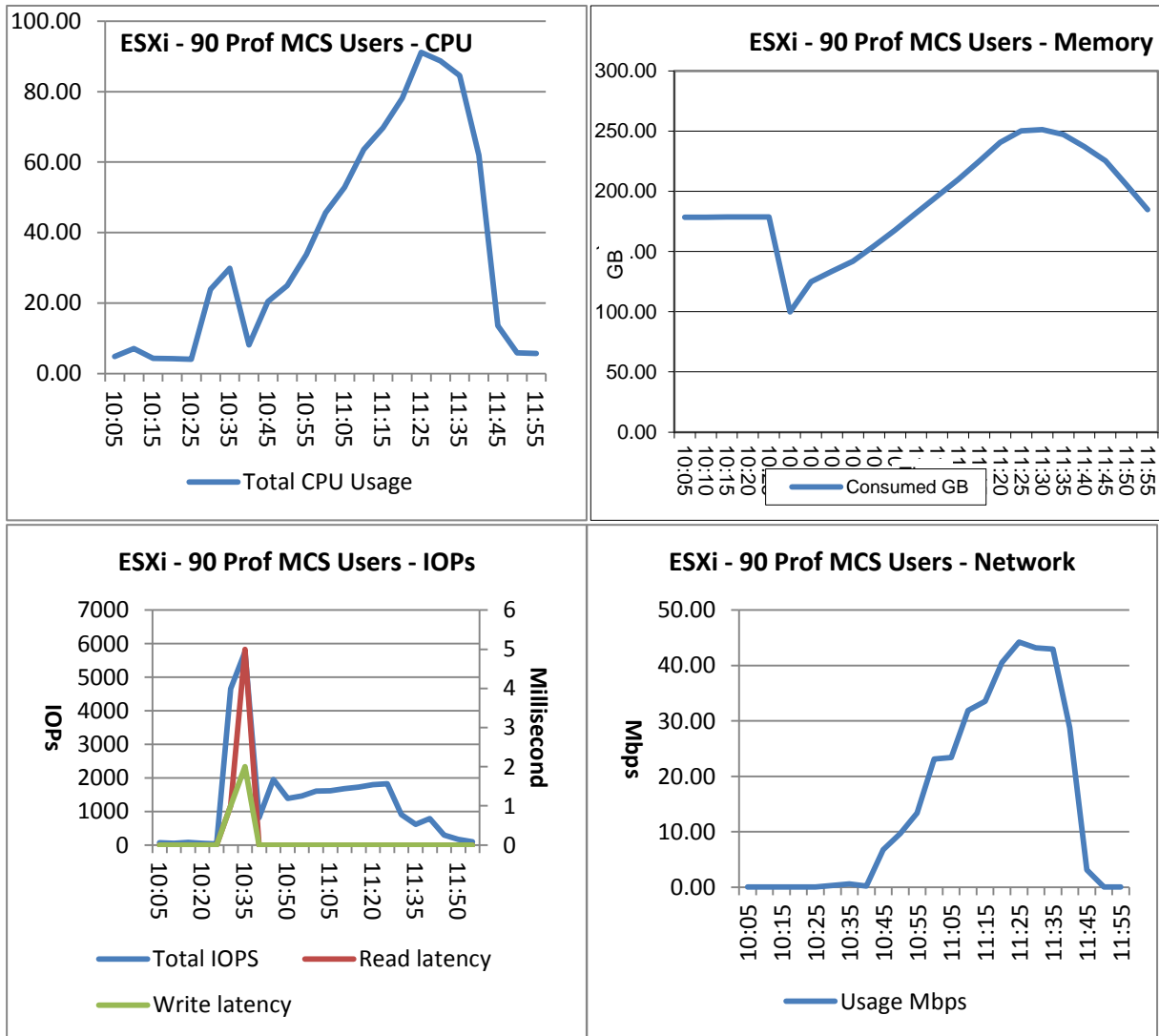

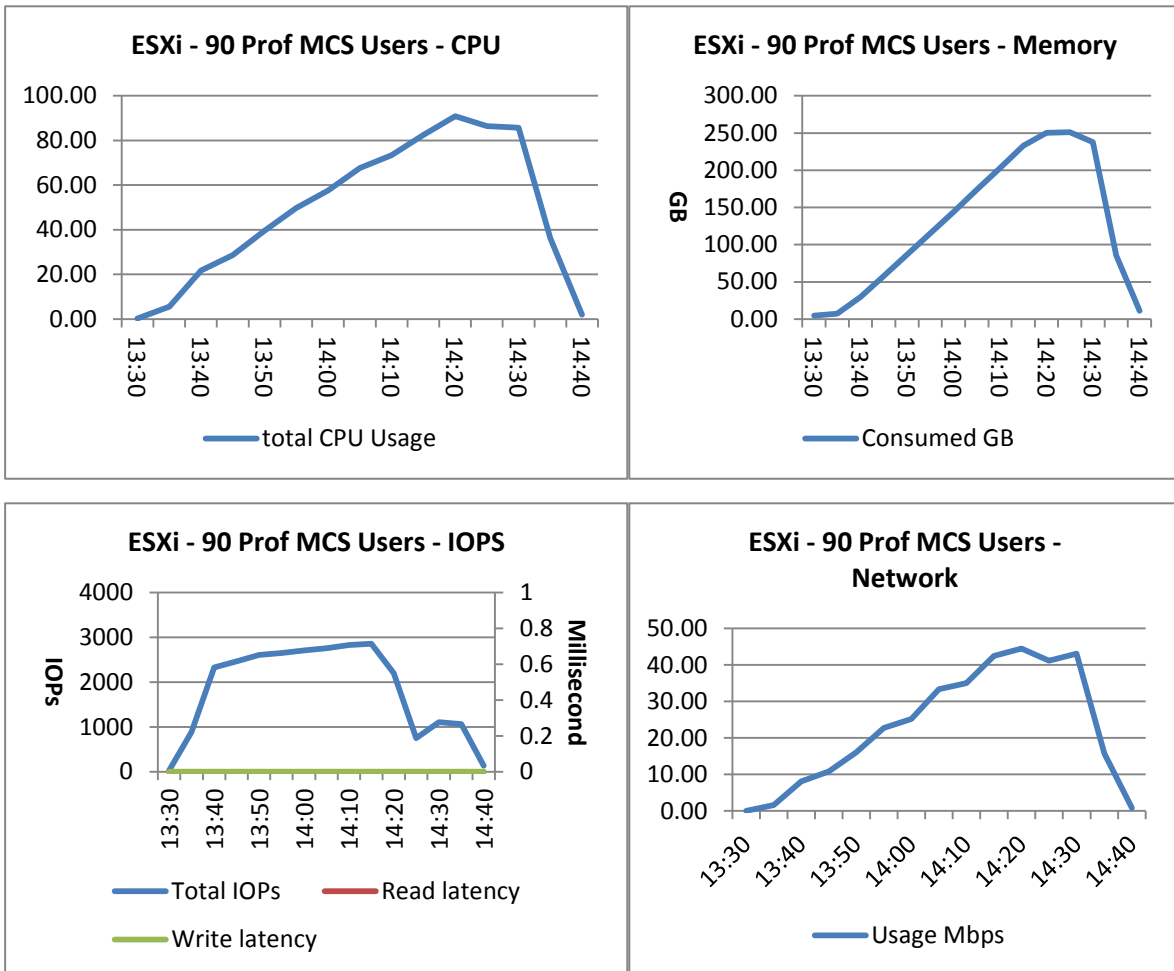

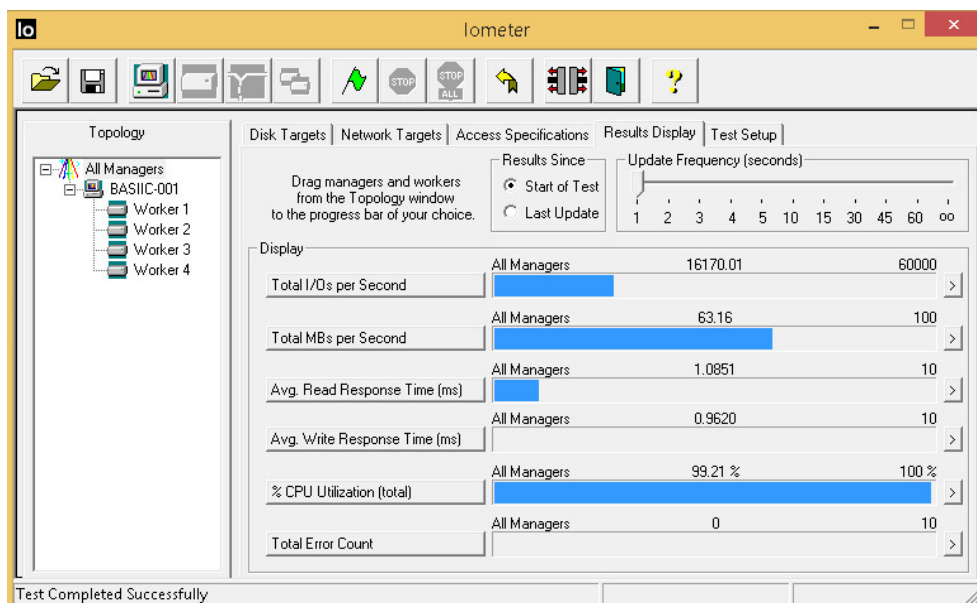
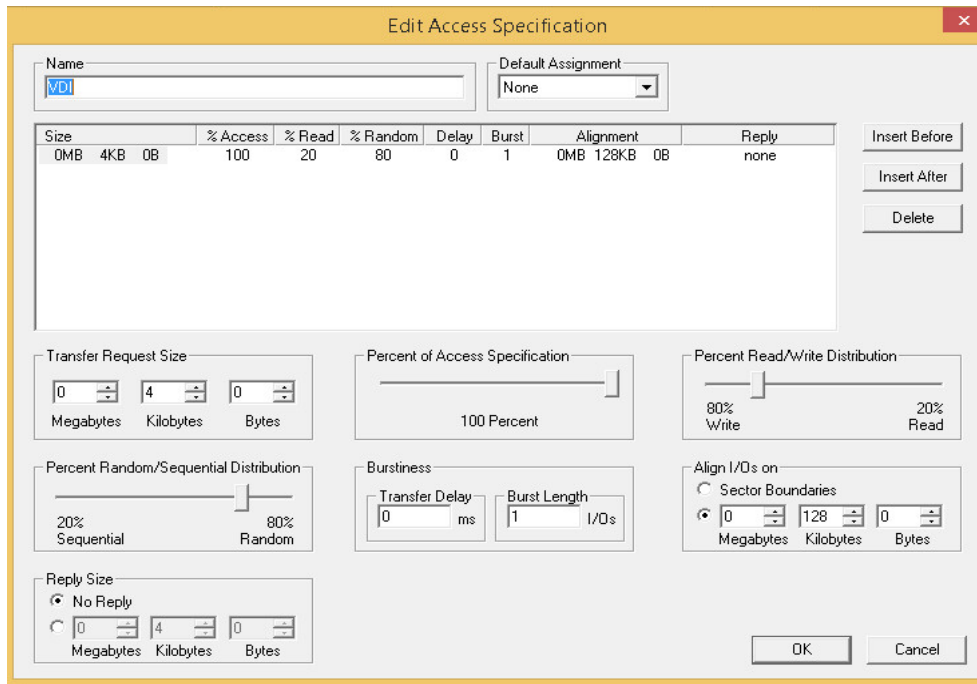
7.4.4.7 MCS Professional User Workload (140 users) with 0% preboot

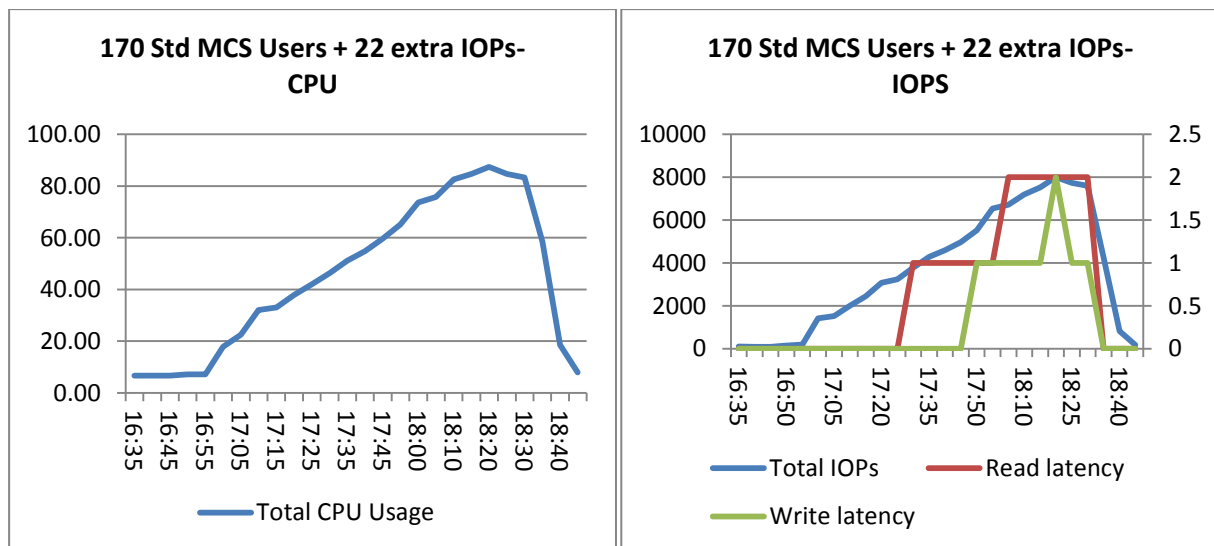

It can be seen that at 16000 IOPs with 80% write the latency remains at approx. 1 millisecond. While IOMETER test scenarios are very subjective and it is arguable whether the test specification used above truly represents a VDI workload, it does represent a reasonable approximation and the result of 16000 IOPs available on the SSD volume does indicate that it is possible for the solution to support much more IO intensive workloads as indicated in the following graph

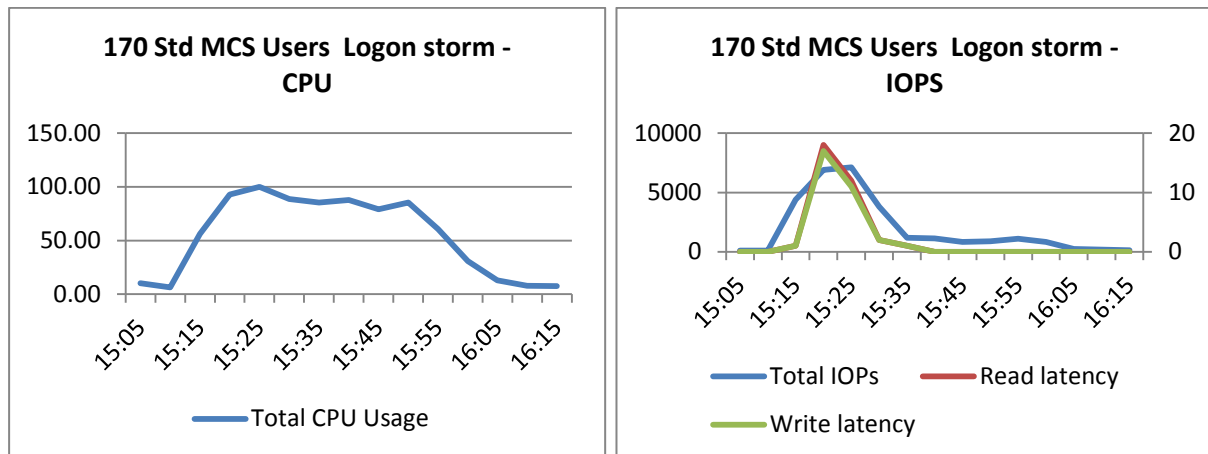

The login script launched an automated IOMeter workload in each VDI session to generate extra IOPs within the session. This generated sustained IOPs of approximately 8000. As can be seen from the graphs above the latency of the local tier 1 storage on the SSD volumes did not rise above 2 milliseconds which is well within the bounds that are considered appropriate for VDI performance (i.e. < 20ms)

7.4.4.10 MCS Standard User Workload (170 Users) Logon storm



During the logon period of 10 minutes the Read and Write latency on the SSD volume rose to 17 milliseconds but quickly dropped to 0 once the sessions reached steady state. A latency of 17 seconds is still below a value that could affect VDI performance. The shortened logon interval produced a peak CPU of 100% usage but this dropped off once the steady state was reached.

7.4.5 XenDesktop with Personal vDisk Enabled

The Personal vDisk technology provides a savings in storage by leveraging a smaller private vDisk versus using a full dedicated desktop image. The impact on storage was found to be minimal. While evaluating the desktop density per server, server CPU was monitored closely. Based on the use of a low level filter driver to determine and then write user/application data, a CPU hit was expected and validated. The overall impact on storage both Tier 1 and Tier 2 is approximately 2 IOPS per user. It was therefore determined that on the same R730 server configuration where 145 basic users are supported, 116 basic user sessions are supported with PvDisk enabled. Also it was determined that on an M620 blade server configuration where 135 basic users are supported, 108 basic user sessions are supported with PvDisk enabled.

7.4.6 EqualLogic PS6210XS Hybrid Array Testing Summary

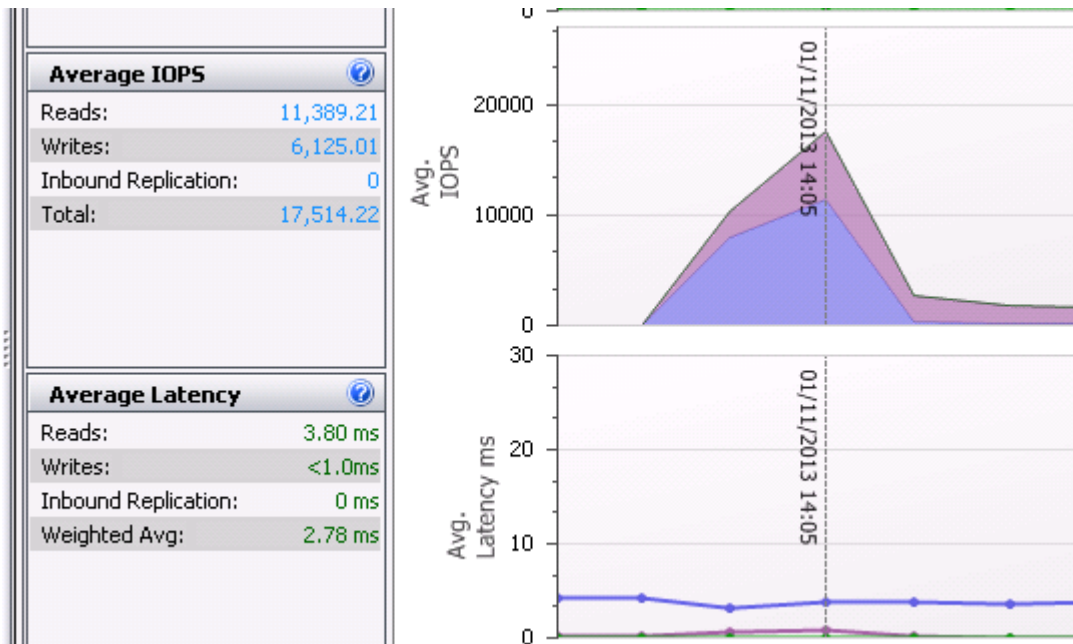
The following tests were conducted using a VMware View solution stack but demonstrate the capability of the array given the following common VDI events:

1. **Boot storm:** Boot storms represent the worst-case scenario where many virtual desktops are powered on at the same time and they all contend for the system resources simultaneously. This test was used to evaluate if the storage array hosting the desktops was capable of handling huge spikes in storage I/O without causing significant impact on other services.
2. **Login storm:** Login storms also represent a heavy I/O scenario where many users are logging into their virtual desktops at the beginning of a work day or a shift at the same time. In this test, all the desktops were pre-booted and left in an idle state for more than 20 minutes to let their I/O settle before running the Login VSI Medium workload to simulate users logging in to their virtual desktops.
3. **Steady state workload for standard users:** Once the login storm for the previous test is completed, the Login VSI Medium workload is allowed to run for at least one hour to simulate the real world scenario of users performing their daily tasks. Stratusphere UX is used to capture user and machine performance during testing.

The following sections provide results from the boot storm, login storm, and steady state testing for a standard LoginVSI user on a single EqualLogic PS6210XS hybrid storage array.

Boot storm I/O

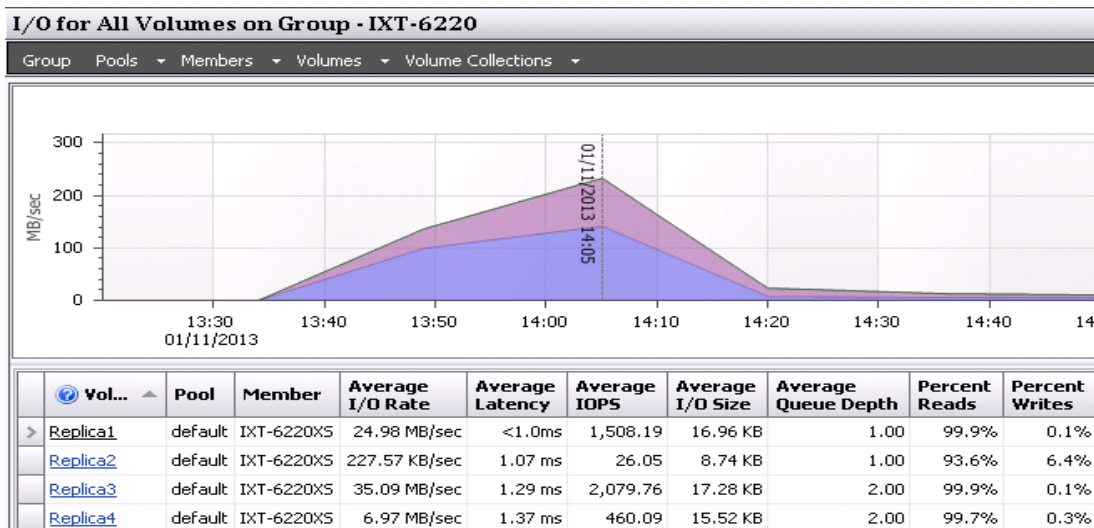
To simulate a boot storm, the virtual desktops were reset simultaneously from the VMware vSphere client. The PS6210XS array delivered 17,514 IOPS (8.7 IOPS per VM) with less than 3 ms average latency under the peak load during this test and all 2,000 desktops were available in about 25 minutes.



SAN HQ data showing EqualLogic PS6210XS array IOPS and latency during boot storm

The above screenshot represents the boot storm for 2,000 VMware Linked Clone VMs with a read/write ratio of 65% read and 35% write. The Replica volumes contributed to the majority of the I/O. Latency was extremely low at a weighted average of 2.78ms.

Due to the number of VMs being powered on, each replica generated maximum IOPS at different times in the boot storm. Figure 3 below shows two Replica volumes generating the majority of I/O operations at peak of the boot storm. The IOPS recorded are predominantly read operations.



Read and write IOPS on the replica volumes

The remaining I/O operations were handled by the linked clone volumes with an average ratio of 40% read and 60% write operations. The table below shows that the majority of the I/O operations were handled by the SSDs during the boot storm.

Storage network utilization was well within the available bandwidth. The peak network utilization during the boot storm reached approximately 6% of the total storage network bandwidth and then gradually declined once all the VMs were booted up. There were also no retransmissions on the iSCSI SAN.

The above results show that EqualLogic PS6210XS hybrid array can handle a heavy I/O load like a boot storms in a VDI environment with no issues.

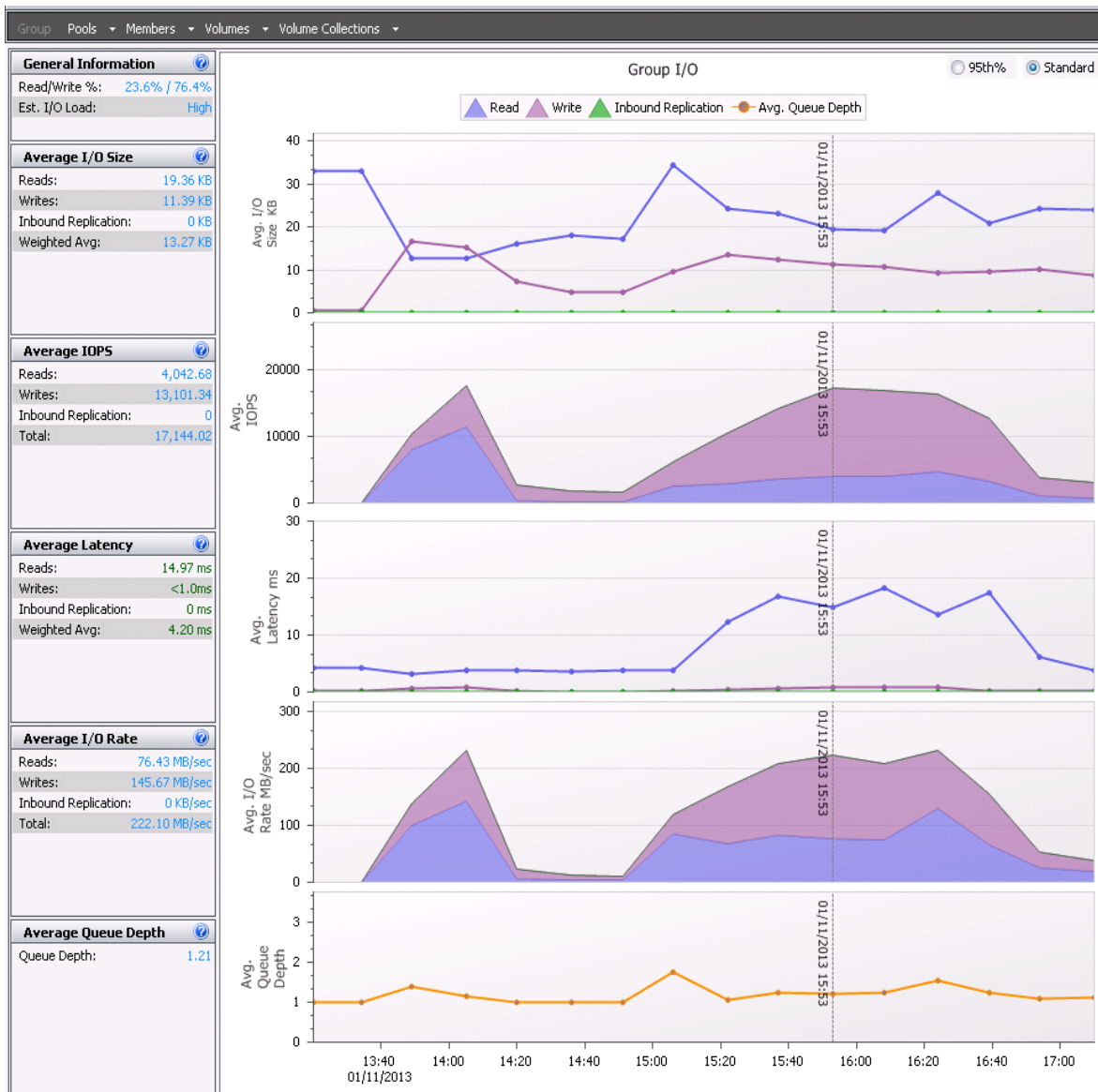
Login storm I/O

Login VSI was configured to launch 2,000 virtual desktops over a period of about 30 minutes after pre-booting the virtual desktops. The peak IOPS observed during the login storm was about 17,144 IOPS (8.5 IOPS per VM).

Login storms generate significantly more write IOPS than a boot storm due to multiple factors including:

- User profile activity
- Starting operating system services on the desktop
- First launch of applications

Once a virtual desktop has achieved a steady state after user login, the Windows 7 OS has cached applications in memory and does not need to access storage each time the application is launched. This leads to lower IOPS during the steady state. Figure below shows the IOPS and latency observed during the login storm.

EqualLogic PS6210XS easily handled logging in 2,000 sessions in a short time delivering the required 17,144 IOPS with 4.2 ms of average latency at the peak of the login storm. The table below shows the overall disk usage in the array during the login storm.

The table above shows that most of the login storm I/O is handled by SSDs and therefore the array is able to provide the best possible performance. Each SSD handled approximately 4,950 IOPS at the peak of login storm; the average latency was very low during the entire login storm time period, and the array clearly demonstrated its ability to handle the workload.

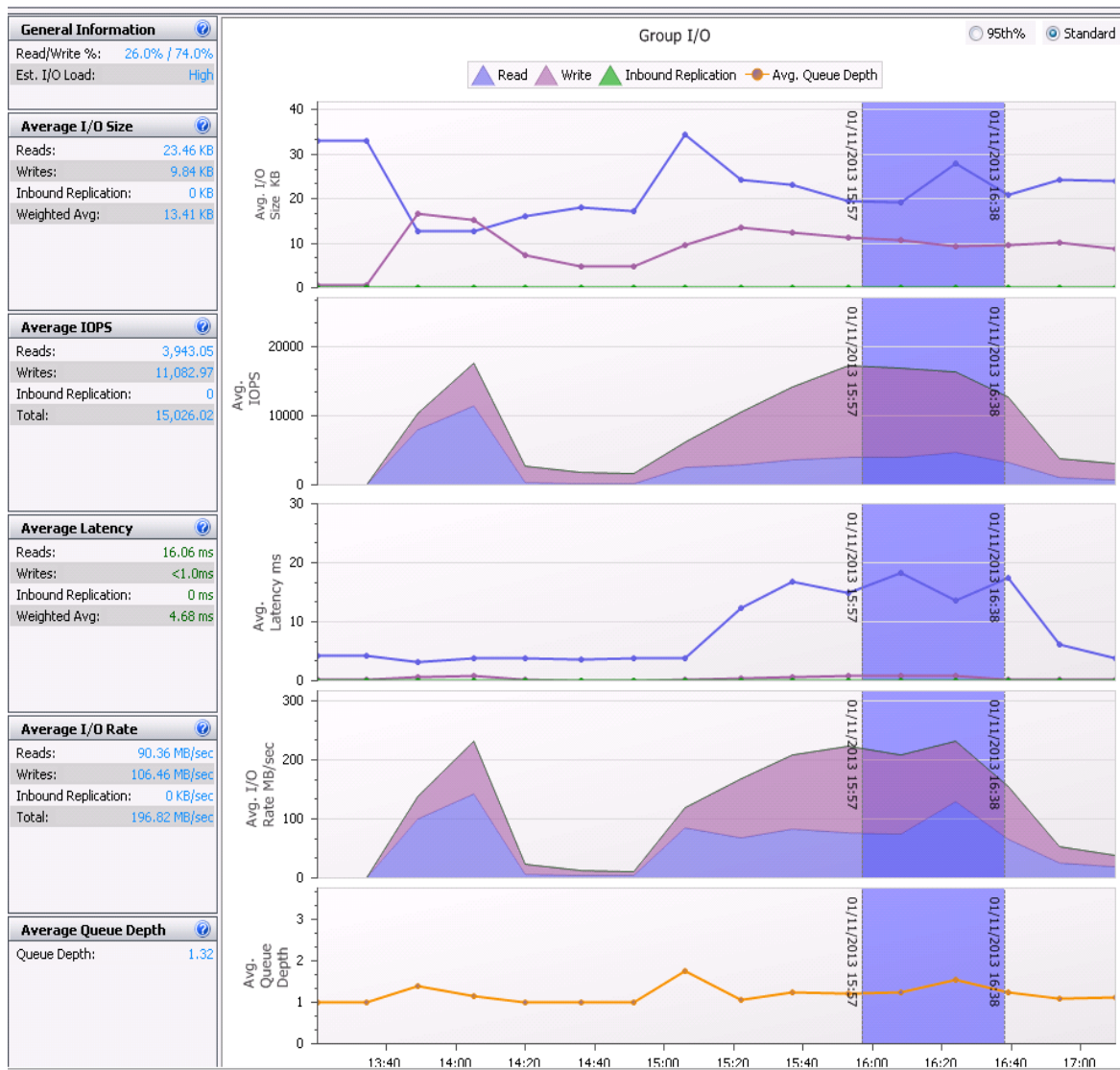
Steady state I/O

Following the completion of the login storm, the I/O profile changed to approximately 24% Read and 76% Write I/O operations at steady state. The total IOPS required during the peak load at steady state with all the users logged in was around 16,773 (8.3 IOPS per VM). EqualLogic PS6210XS delivered these IOPS with 5 ms average latency, which is well below the 20 ms threshold. The average load during the entire steady state test period was approximately 15,000 IOPS, which EqualLogic PS6210XS delivered with 4.7 ms average latency as shown in Figure 5.

All changes that occur on the virtual desktop (including temporary OS writes such as memory paging) are being written to disk. The I/O pattern is mostly writes due to this activity. Once the desktops are booted and in a steady state, the read I/O becomes minimal due to Horizon View Storage Accelerator enabling content based read caching (CBRC) on the ESXi hosts.

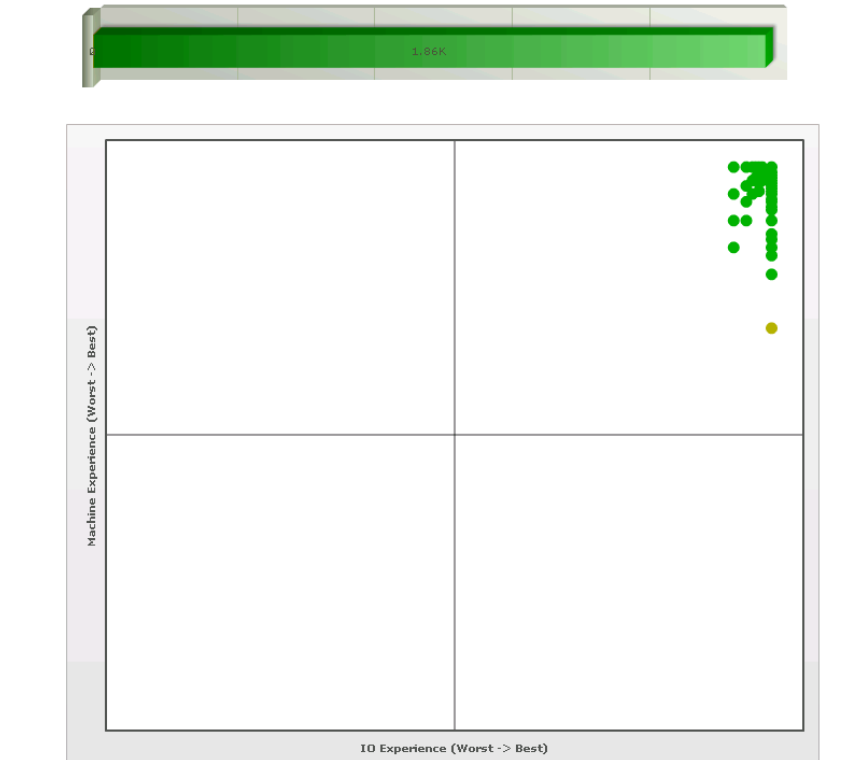
During steady state there is minimal activity on the replica volume and most of the activity is seen on the VDI-Images volumes that host the virtual desktops.

The figure below shows the performance of the array during the steady state test.



Based on the criteria in Section 4.3.3, Figure 9 shows Stratusphere UX scatter plot for user experience. Virtually all the users are in the Good category. This shows that the EqualLogic PS6210XS array is capable of easily providing adequate user experience for all the users in the VDI environment.

Note that Stratusphere UX was able to register 1,860 of the total 2,000 desktops for the scatter plot in the figure below, but the Good performances of the remaining ones were verified in other reports.



7.4.7 Dell Compellent Storage Testing Summary

The Dell Compellent MSV Solutions team tested and validated the fibre channel-based Dell Compellent storage with the following configuration and criteria:

- 2000 XenDesktop VMs
- 0% pre-booted desktop images ([all 2000 desktops booted on demand](#))
- VSI Medium workload to generate maximum IOPS demand.

The results show the performance of a Dell Compellent SC8000 under load. The screen captures come directly from the Dell Compellent Charting viewer, which can display real-time load from the storage perspective. A subset of all data is presented here for clarity, with each of the screen captures showing the load from a different layer of the storage architecture.

Performance charts

The performance charts are captured from real-time data, averaged on 10 second intervals. This granularity will provide accurate results based on the volume of data and the short data collection interval.

Front end performance

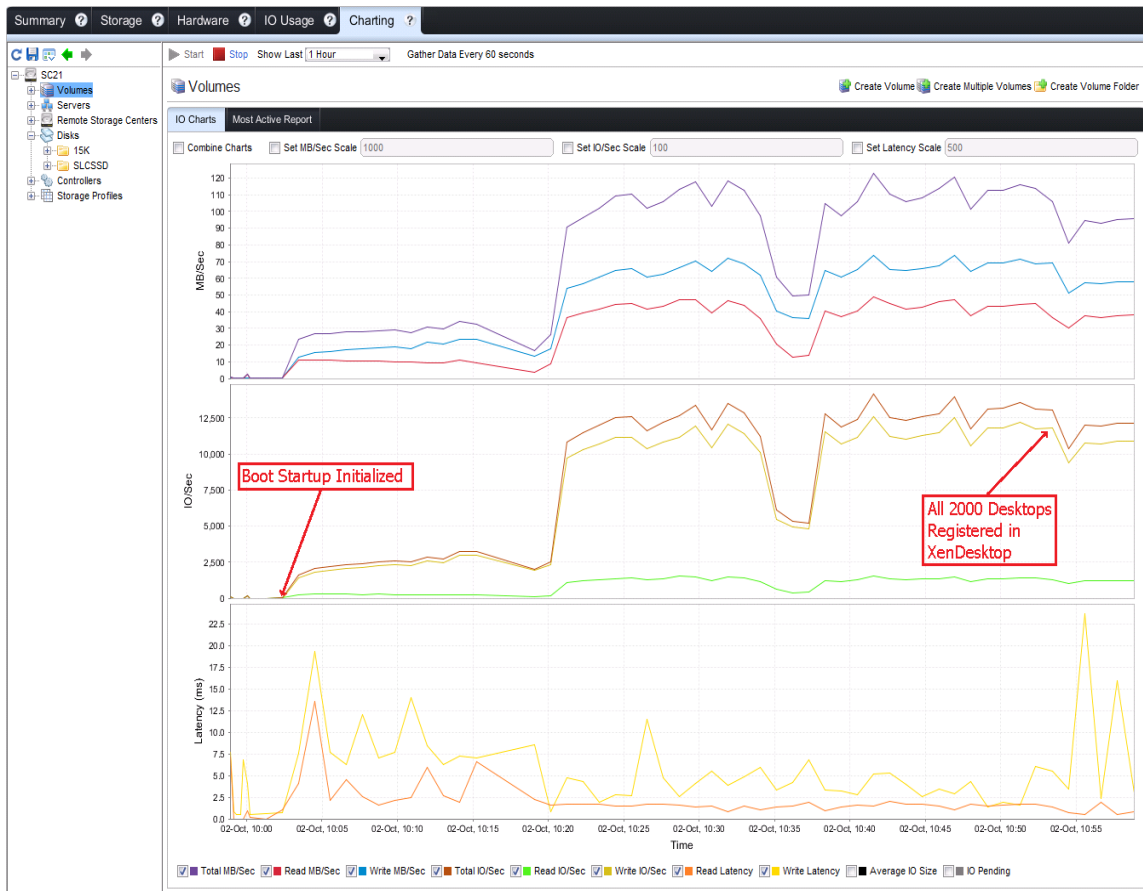
Front-end performance is measured as time to complete an I/O operation, from the time an I/O is initiated from a host, until the response is sent that the I/O is complete.

Boot storm

The boot storm shows the ramp up in load from the time the first machine starts the boot process, until the last machine displays the Windows login screen. Additional I/O will continue to be generated, but at this point all machines are available for login.

In a customer environment this would show how long a cold state boot would take from a storage perspective. This does not include host start-up times, or the time required for the desktop broker to initiate the connections to the vSphere hosts and start the power-on process.

Figure 1 – Boot storm:



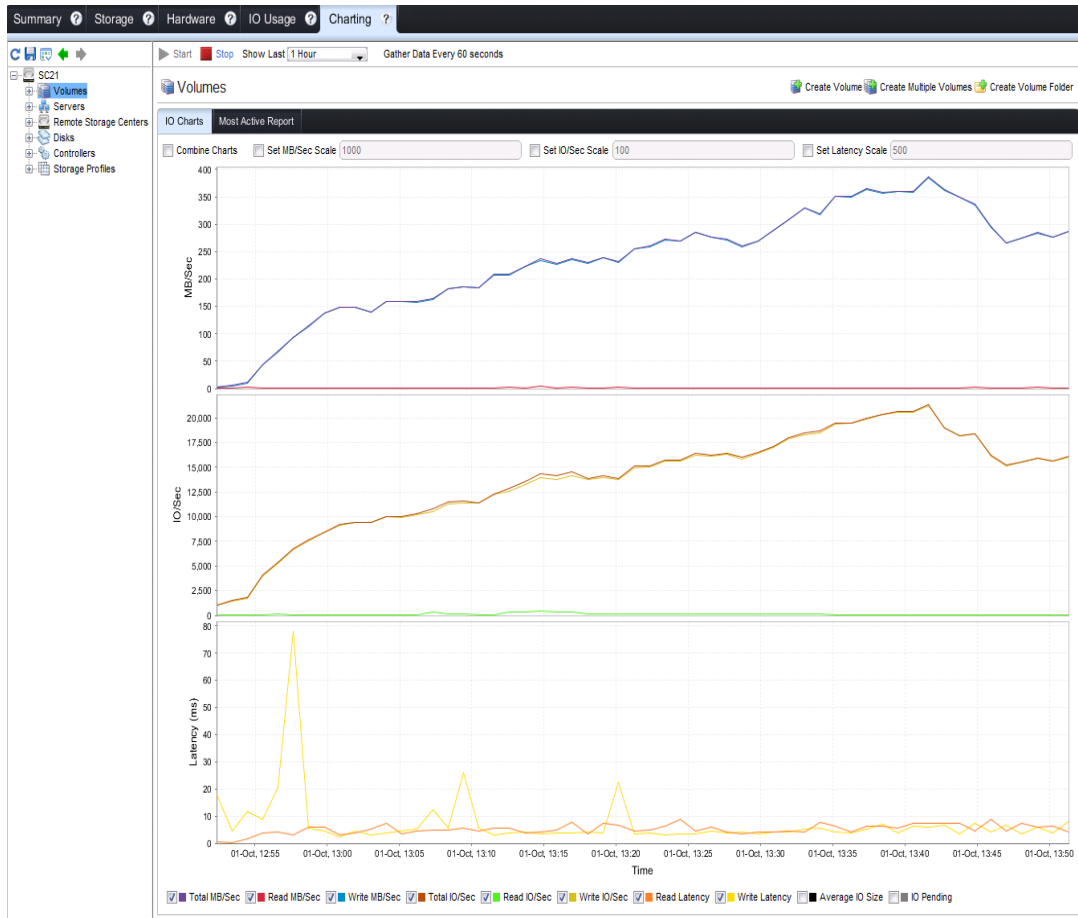
The peak IOPS load was about 13,000 IOPS. The write ratio is about 95% as the majority of the boot data is read from the PVS streaming service. Even under peak load conditions, the average write latency was approximately 5ms, with a corresponding average read latency of approximately 2ms.

Login storm

The Login storm displays the load ramp-up from the time the first workstation starts the login process, until the last workstation has completed login and starts the testing workload. Over approximately a 50 minute period, all virtual desktops are logged in and have started processing the assigned tasks.

This simulates the time required for all users to login, such as the start of user workday. It would also simulate performance if a complete VDI environment required a restart during a workday.

Figure 2 – Login Storm:

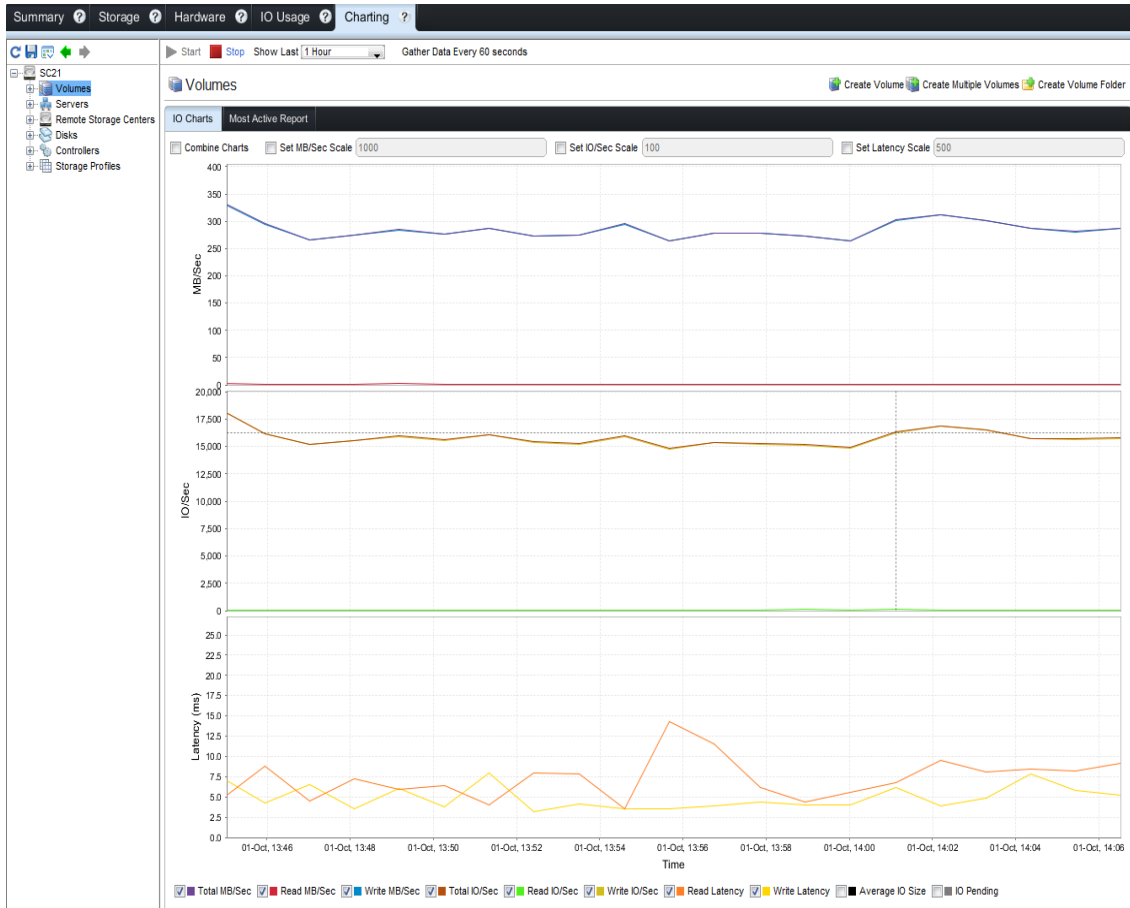


During the login window, the storage load peaks at approximately 22,000 IOPS. Through this peak, the average write latency measured 5 ms, with the corresponding read latency averaging at 7 ms. This results in a very smooth login process with very good overall response times inside of the virtual desktops. Since the industry considers any storage latency under 20 ms to offer acceptable performance, this low latency configuration results in an excellent user experience.

Steady state VDI load

The steady state load shows a continuous 2,000 user workload simulating all the users performing their daily duties. During the test run the steady state load averaged about 16,250 IOPS (about 8 IOPS/user), with an average write latency of 6 ms, and an average read latency of 7 ms.

Storage Scaling

Due to the nature of spinning drives, sizing a solution are done making linear scaling assumptions. For example, if 92 drives can support 2000 users at a given I/O load, sizing for 1000 or 3000 users would require 46 or 138 active drives respectively. Along those lines, once a ratio of spindles per user has been established, expanding the user base as it grows can save an upfront purchase of the total needed drives. For example, if 500 users are deployed in each phase of the rollout, the linear math suggests that if the users being added share the same I/O profile, that adding 23 drives per phase is required to handle the desktop's performance.

Summary

In conclusion, a 2000 desktop Citrix XenDesktop based VDI solution are deployed on a Dell Compellent Storage Center platform comprised of two SC8000 and four SC220 enclosures with 96

– 300 GB 15K drives (92 active and 4 spares) for the tested workload. This mimics a typical knowledge worker as represented by the Login VSI Medium workload.

It is highly recommended to run a pilot to determine the key disk metrics typical of a particular set of users to be virtualized in the environment. Knowing the number of IOPS per user, read and write ratios, average transfer sizes, and how much data each user consumes, will help prevent under or oversizing a storage solution for a virtual desktop deployment.

Keep in mind that the performance based solution shown within this document is architected for non-persistent desktops, and thus, due to the transient nature of the data, array based snapshots on the operating system volumes were not utilized. In any final solution based on this architecture, additional capacity for user profile data and user files will need to be considered for the file servers within the infrastructure. Also if desired, additional storage may also be added to the array to allow for a snapshot schedule to store any desktop data deemed important.

7.5 XenApp Test Results

7.5.1 Configuration

This validation was performed for XenDesktop 7.6 delivering hosted shared desktops on 2 R730 Compute servers where one was running vSphere ESXi 5.5 and the other Windows 2012 R2 Hyper-V. Each Compute Host was outfitted with 96 - 256 GB RAM (1600 MHz), dual 3.0 GHz Ivy Bridge E5-2690v2 processors, and 10 300GB 15K RPM SAS drives in a RAID 10 configuration. Each host comes with Broadcom 5720 4-port NICs running 1Gb Ethernet. 2 NICs were connected on each Compute Host and were teamed. All of the hosted shared desktops were hosted on the local disk storage on the Compute Hosts.

The Management Host was a separate host, an M620 running vSphere ESXi 5.5 with the same hardware configuration as the Compute Hosts. The Management Host used an EqualLogic PS4100E storage array connected via iSCSI on a Power Connect 8024F 1GbE network switch to store all of the management server VMs. A common Storefront, Desktop Delivery controller, and License server was used. The Management node also hosted the SCVMM virtual machine and VMware vCenter appliance. The Management VMs for the solution were deployed on the Management Host using the following configurations:

- 1 VM, 4 vCPU and 8 GB RAM for XenDesktop 7.6 DDC
- 1 VM, 2 vCPU and 4 GB RAM for Storefront and Licensing Server
- 1 VM, 4vCPU and 16 GB RAM for PVS 7.1 (powered off during MCS testing)
- 1 VM, 2 vCPU and 8 GB RAM each for VMware vCenter 5.5 appliance or Microsoft System Center 2012 R2
- 1 VM, 4 vCPU and 8 GB RAM for Microsoft SQL Server 2012 SP1

The XenApp images were built using Windows Server 2012 R2 Standard edition and Microsoft Office 2010 plus the support tools required for Login VSI testing.

The PVS desktops were each configured to boot from a vDisk hosted on the PVS Server VM. Each PVS VM had a local write cache disk attached that was sized at 32GB. The write cache disks were created to use thin provisioning in all of the test cases below, and were formatted with NTFS. In PVS the vDisks were each configured to use the target device's local disk for the write cache ("Cache on device hard drive"). In addition further tests were run on Hyper-V with the Write cache set to RAM plus overflow to local hard disk.

7.5.2 Test Results Summary

Validation was performed using DWD Solution Engineering standard testing methodology using LoginVSI 4 load generation tool for VDI benchmarking that simulates production user workloads. Stratusphere UX was not used in this validation since it is not compatible with the server OS in use here (Windows 2012 R2 Standard).

The following scenarios were tested to identify the optimal configurations:

- Virtual XenApp server optimization on both vSphere and Hyper-V to discover the right mix of vCPUs, oversubscription, RAM and total number of VMs per host
- Physical Windows 2012 R2 host running XenApp
- The performance impact and benefit of NUMA enabled
- The performance impact of various provisioning mechanisms: MCS, PVS write cache to disk, PVS write cache to RAM
- The performance impact of an increased user idle time to simulate a less than 80+% concurrency of user activity on any given host.

These scenarios were tested using the Login VSI light and medium workloads. Medium and heavy user workloads are likely better suited to full VDI desktops. The results presented in this document for virtual machine configurations were optimized for 6 x XenApp Server VMs with 5 vCPU and 16GB of memory for each VM. This configuration was found to give slightly improved results compared to other configurations using either 2 or 3 VMs with varying CPU and memory configurations. In all cases the R730 host was configured to allow NUMA operation. With 20 physical CPU cores we followed the 1.5x oversubscription model and assigned vCPUs according to 30 logical cores.

Each test run was configured to allow for 16 minutes of steady state operations after the initial session launch and login period, so that all sessions would be logged in and active for a significant period of time so that statistics could be measured during steady state to simulate daily operations. In the CPU charts below it can be seen that the max CPU usage on the Hyper-V solution was reached before all the sessions logged in but did not rise further as more sessions logged in. This pattern is repeated in other Hyper-V tests for Standard and Enhanced workloads on MCS and PVS.

Testing of the physical server showed a percentage of users that did not complete the logoff process (approximately 15%) which was also tested using only the Login VSI medium workload (Enhanced). The light workload was not successful. Based on the results we find using virtual XenApp servers to be more scalable and higher performing than XenApp running on physical Windows servers, generally speaking. The following table summarizes the steady state test results for the various workloads and configurations. The charts in the sections below show more details about the max values for CPU, memory, IOPS, and Network during the test run.

Summary of configuration recommendations:

- Enable Hyper-Threading and Turbo for oversubscribed performance gains.
- NUMA did not show to have a tremendous impact enabled or disabled.
- Virtual XenApp servers outperform dedicated physical hosts with no hypervisor so we recommend virtualized XenApp instances.
- Using 10-Core Ivy Bridge CPUs, we recommend running 6 x XenApp VMs per host, each VM assigned 5 x vCPUs and 16GB RAM.
- 1.5x CPU oversubscription per host produced excellent results. 20 physical cores x 1.5 oversubscription netting 30 logical vCPUs assigned to VMs.
- PVS cache in RAM (with HD overflow) will reduce the user IO generated to disk almost nothing but will require greater RAM densities on the compute hosts. 256GB is a safe high water mark using PVS cache in RAM based on a 21GB cache per XenApp VM.

CPU utilization was higher on the ESXi hosts compared to what was observed on the equivalent Hyper-V solution.

Memory utilization remains low for all solutions except PVS solution with write cache in RAM. This provides a significant saving over VDI solutions that typically require 256GB to provide lower user densities. Utilizing PVS write cache in RAM provides significant performance improvements and practically eliminates the need for tier 1 storage on local disk.

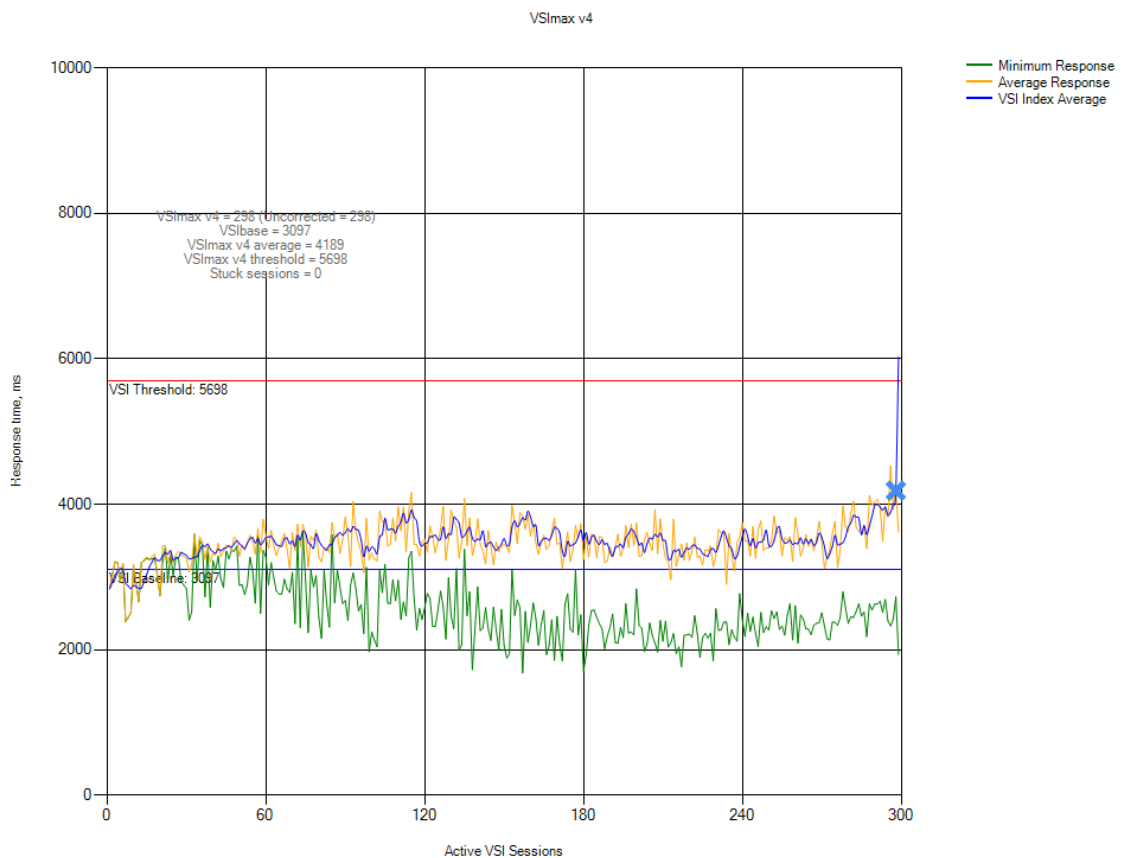
The IOPS results above were surprising in that PVS typically would offload IO to the network, relieving the local storage from a significant number of IOPS. In the chart above however it shows that PVS test cases consistently produced more IOPS per user than equivalent MCS test cases. As expected PVS with write cache in RAM showed practically no tier 1 IOPS.

Network Utilization was consistent between the solutions. It was expected that the PVS solution would show higher IOPs than MCS or physical solutions. However, this was not depicted in the results gathered. This is probably due to caching. Network utilization was higher for the equivalent Hyper-V solution than the ESXi solution for MCS. As expected the PVS solution produced significantly higher network utilization overall.

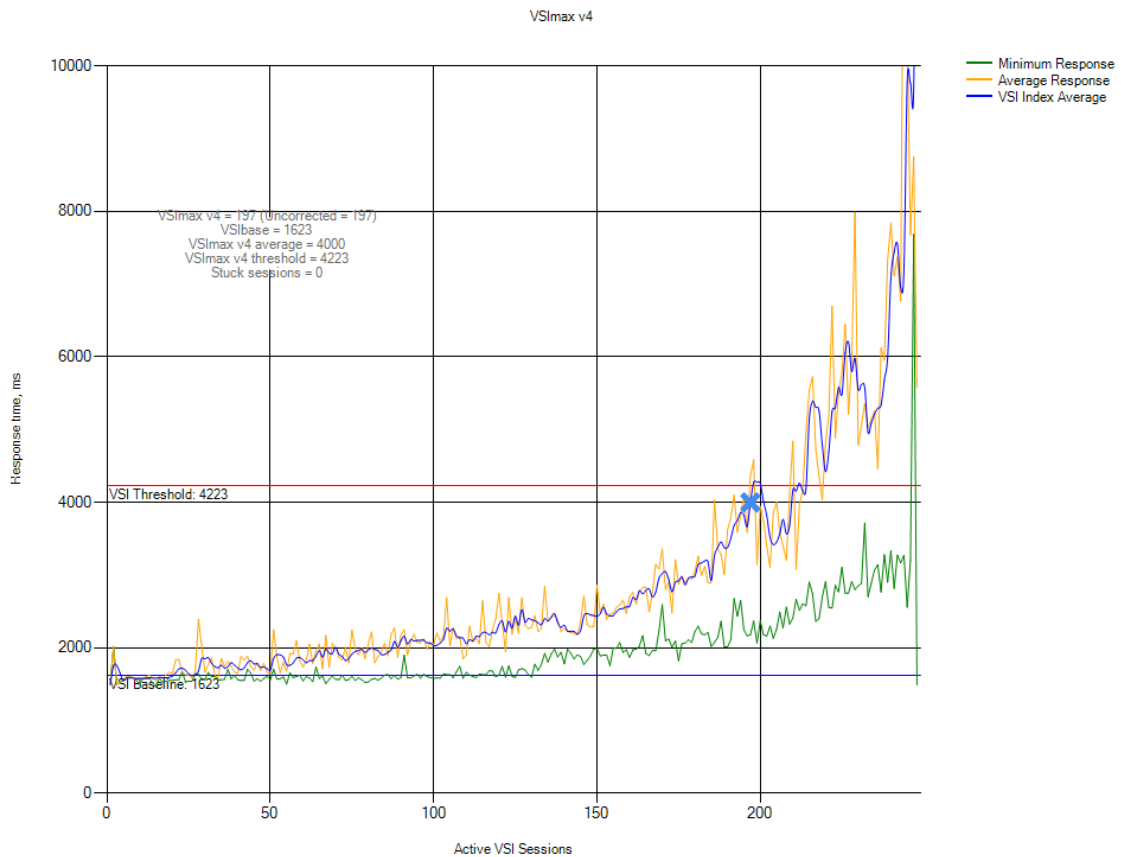
7.5.2.1 User Experience

The results show significant differences in user density achievable with Hyper-V compared to ESXi. Unfortunately Stratusphere UX was not available to gather User experience data but a subjective test of user experience was gathered in each test run. In all cases the user experiences was good. The subjective user test is performed when approximately 95% of users were logged in. Each test consists of browsing the internet, performing some tasks on Word, Excel, PowerPoint and playing some multimedia clips. The following graphs from VSI Analyzer indicate that the VSI tool does indeed indicate a difference in capability between the Hyper-V and ESXi solutions. The following graphs were taken for the VSI light workload on ESXi and Hyper-V deployed using MCS technology.

ESXi Standard workload for 250 users



The same image was used for both ESXi and Hyper-V testing except that the appropriate support tools were applied for each Hypervisor. The R730 hosts were configured identically in terms of processor, memory, BIOS, local tier1 disk and network. The performance data gathered does not indicate stress in any other area, e.g. local disk latency remains low in both solutions (≤ 5 ms).

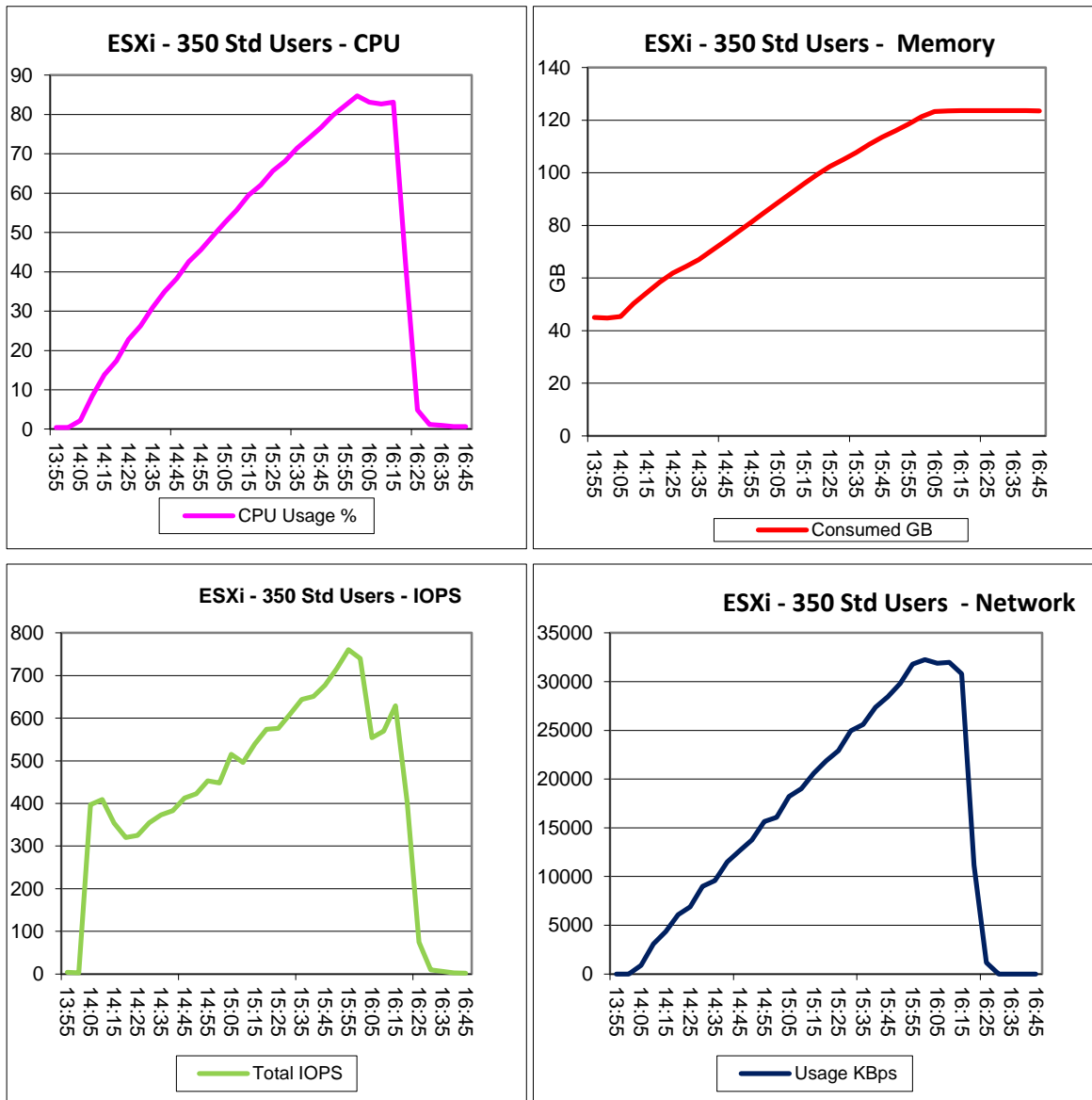
In both cases above the VSIMAX chart indicates that the solution is approaching its maximum capability. Overall, the PVS solution with write cache in RAM indicates a very viable solution provided the volume of changes in each session doesn't exceed the available memory. In any event this can be configured with an overflow to local hard disk.

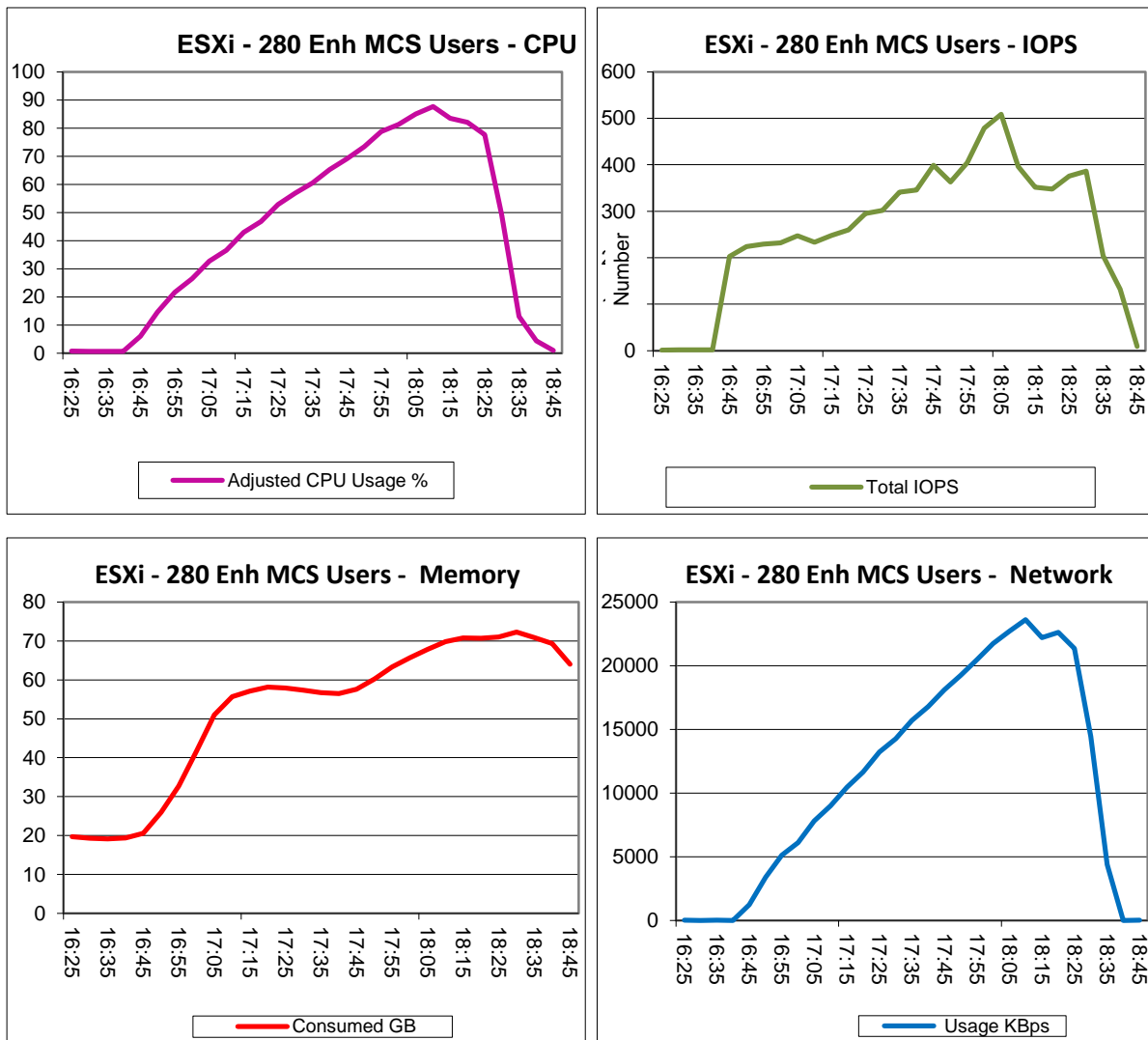

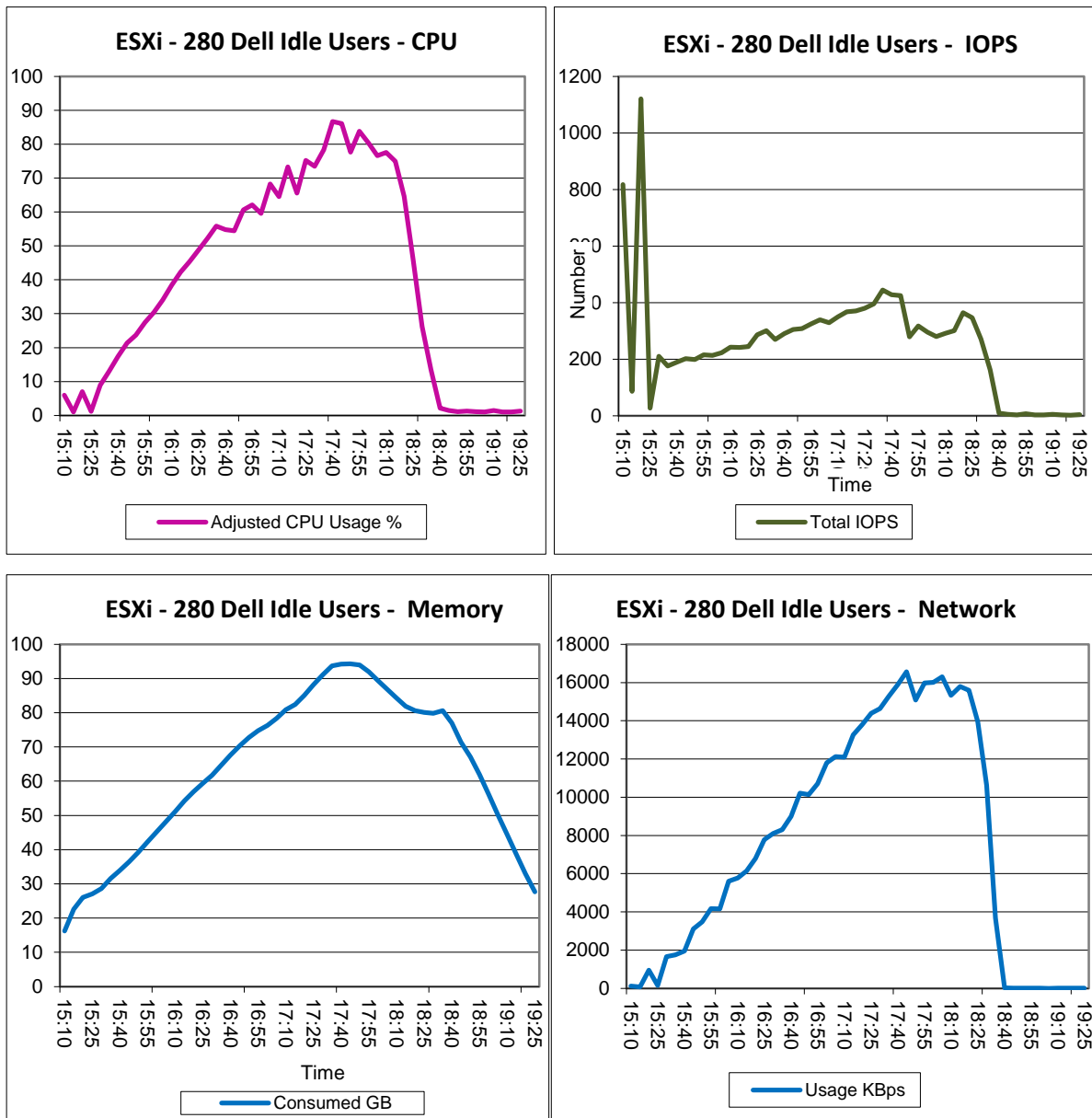

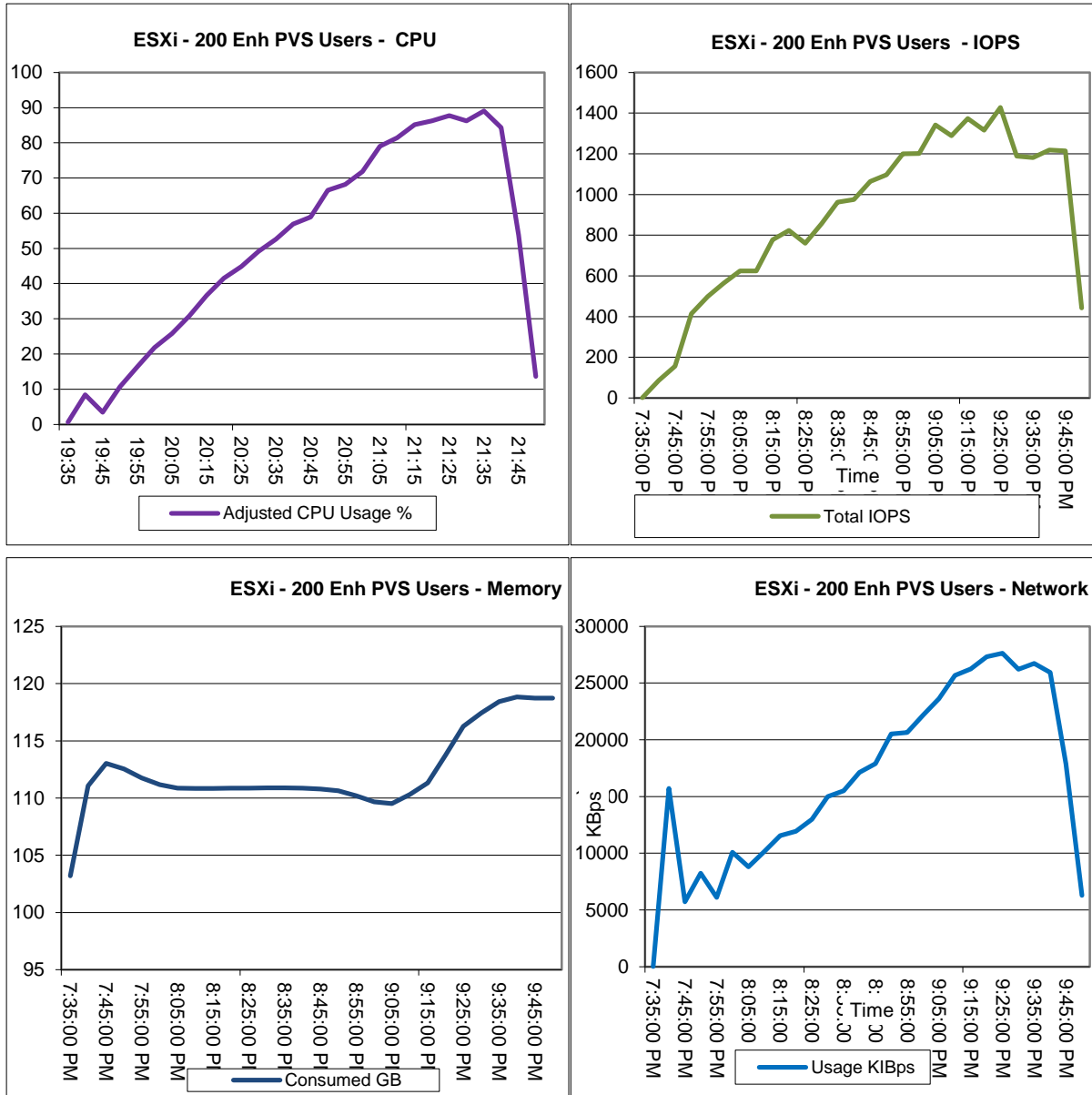
7.5.3.3 MCS Dell Extra Idle time User Workload (280 users)

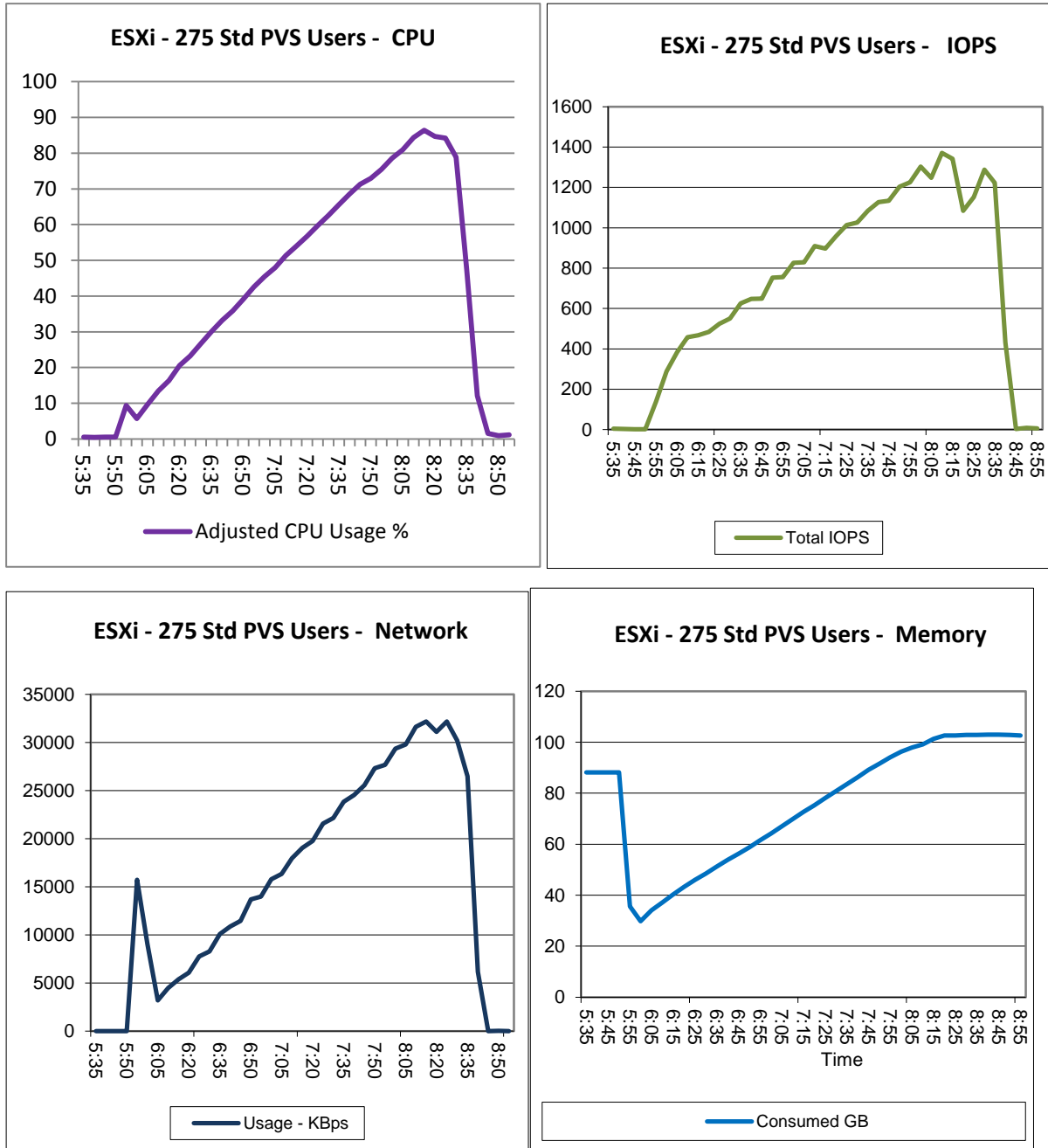

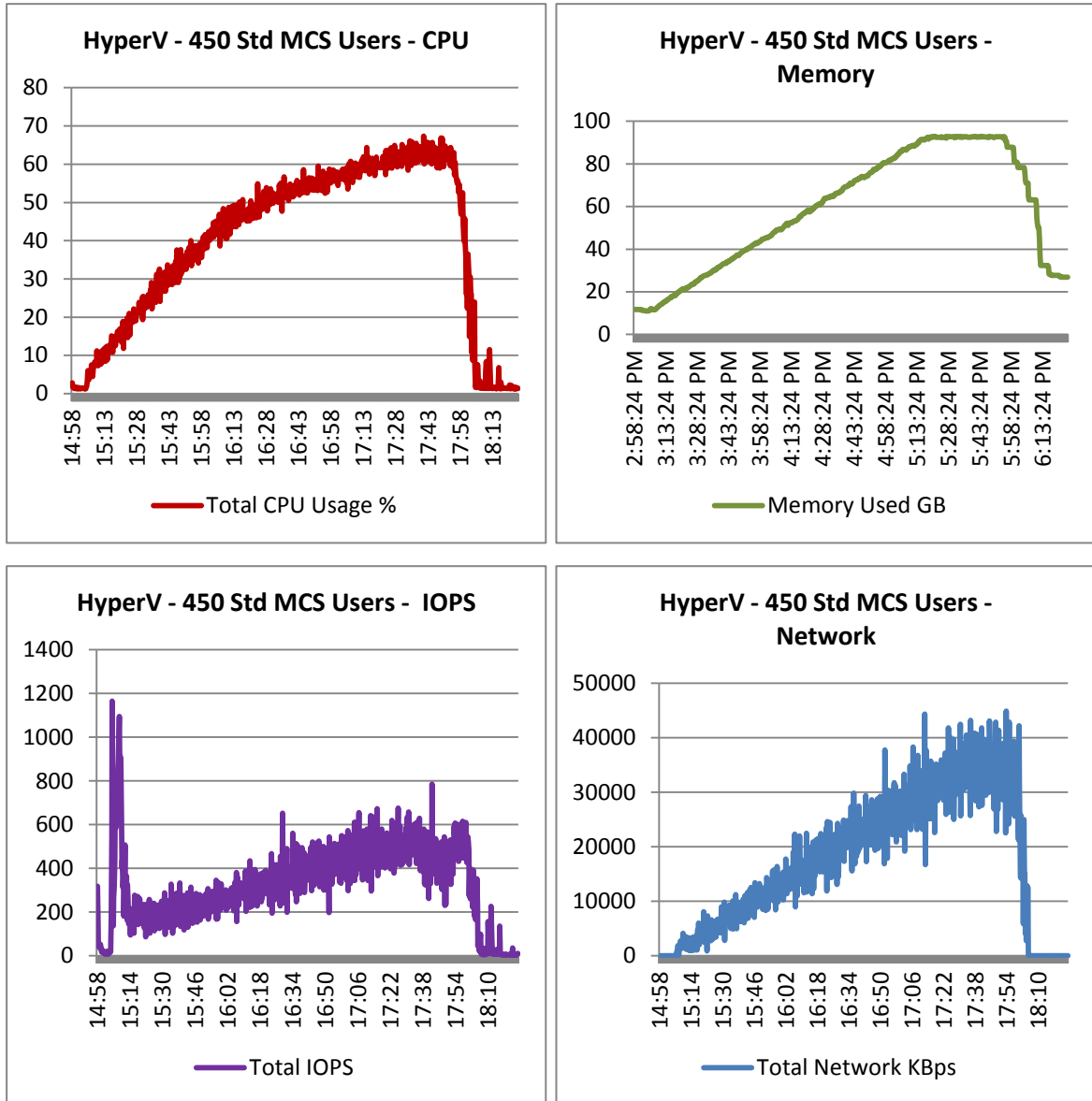

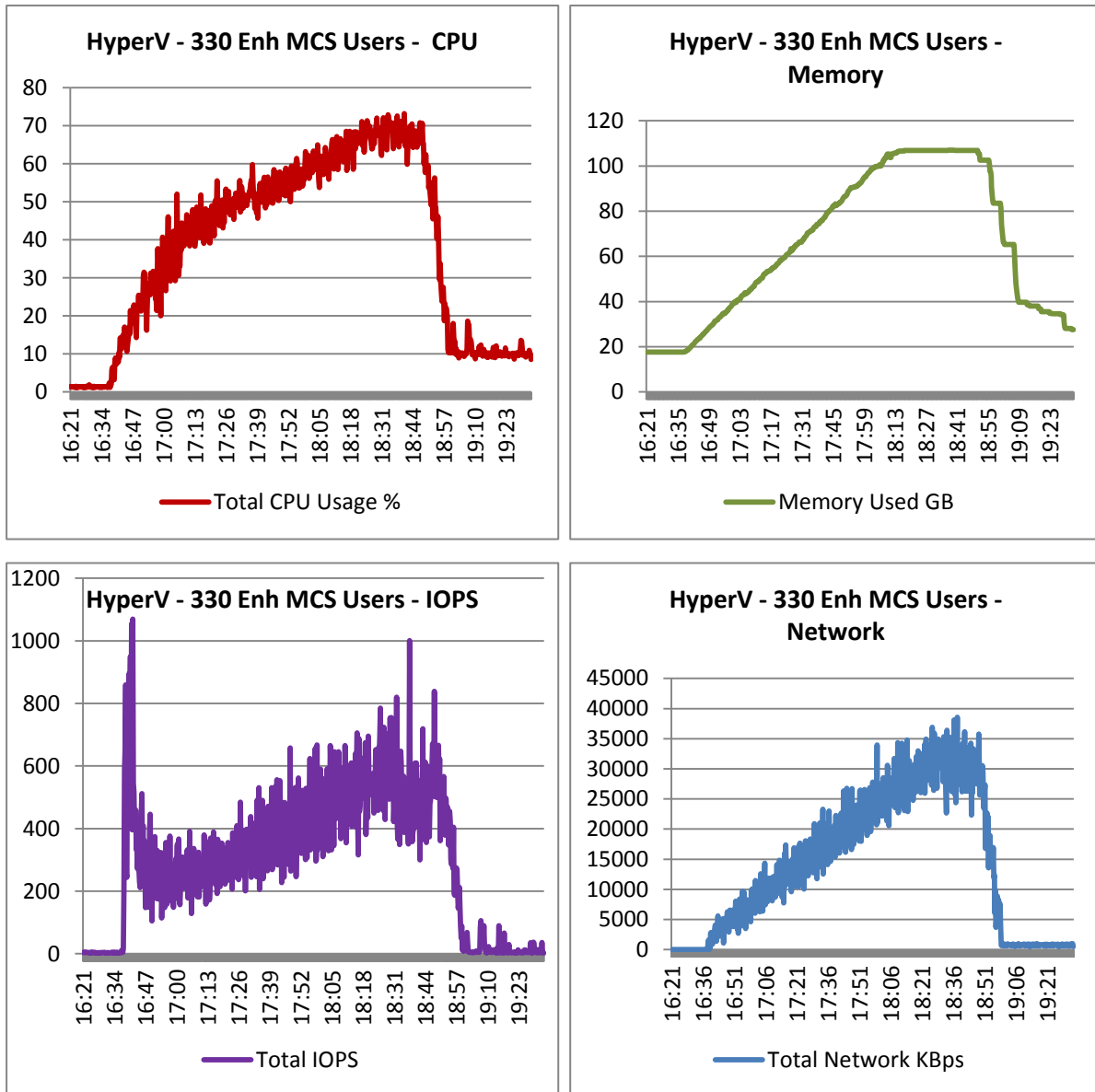

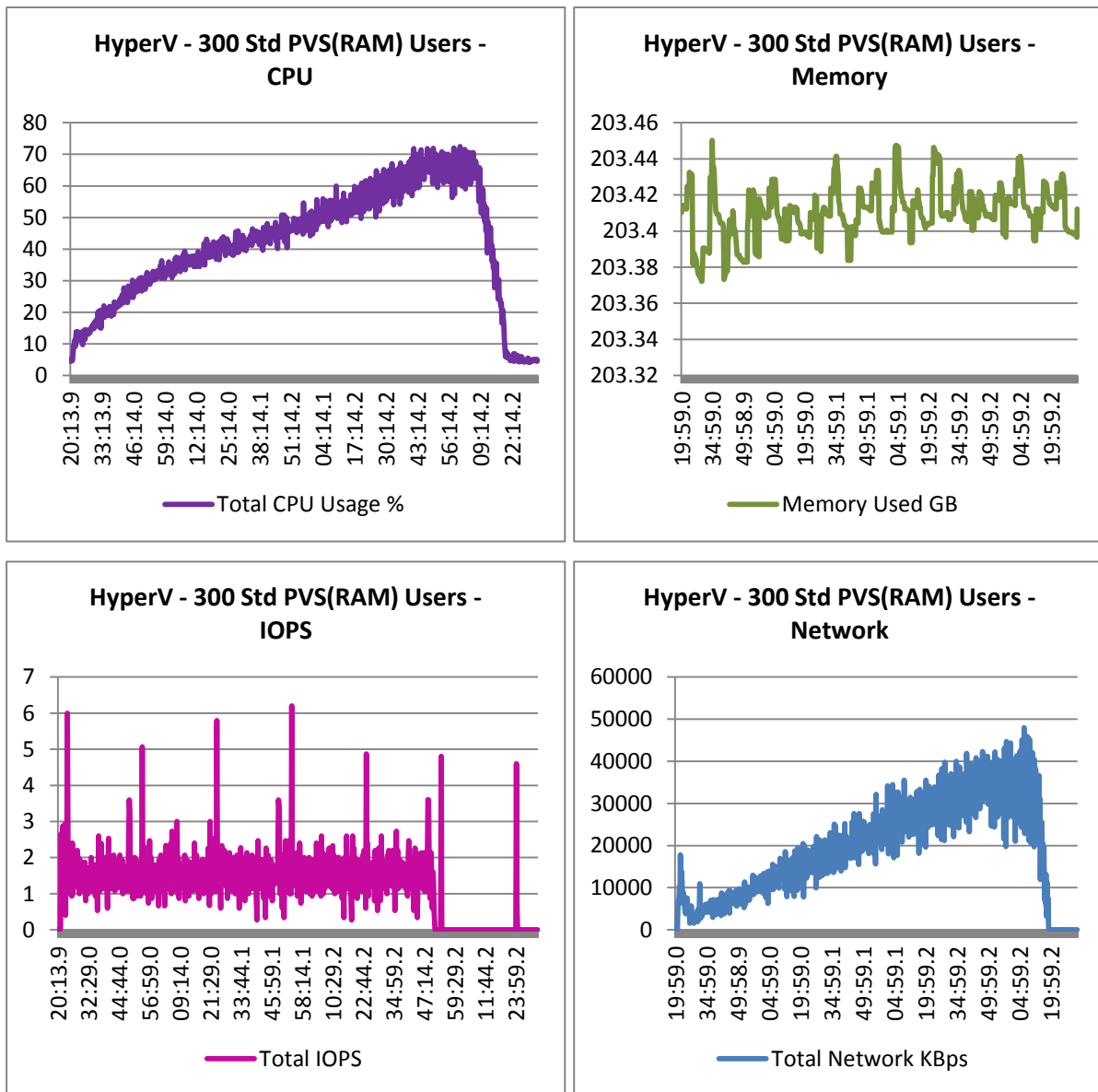

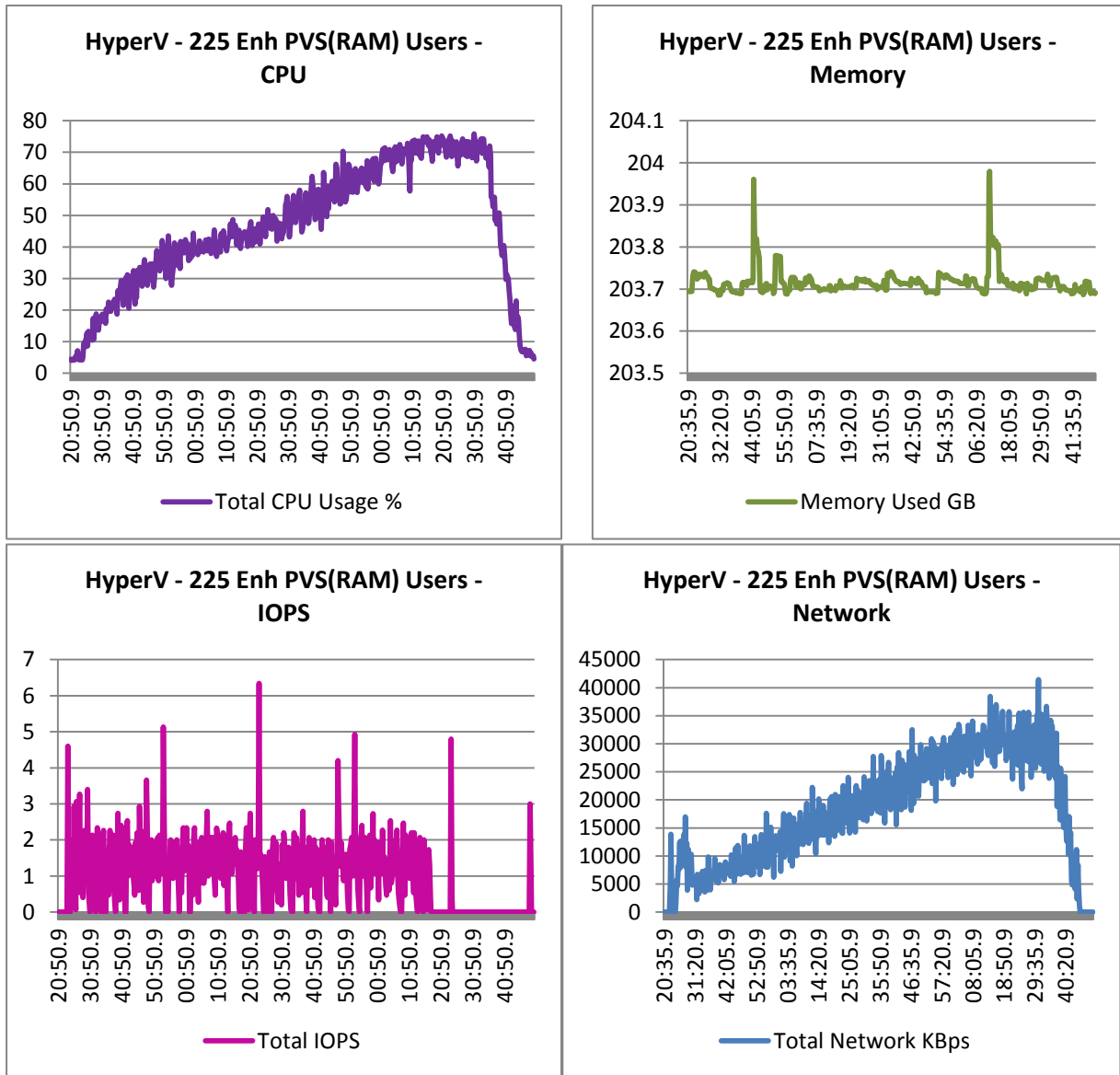

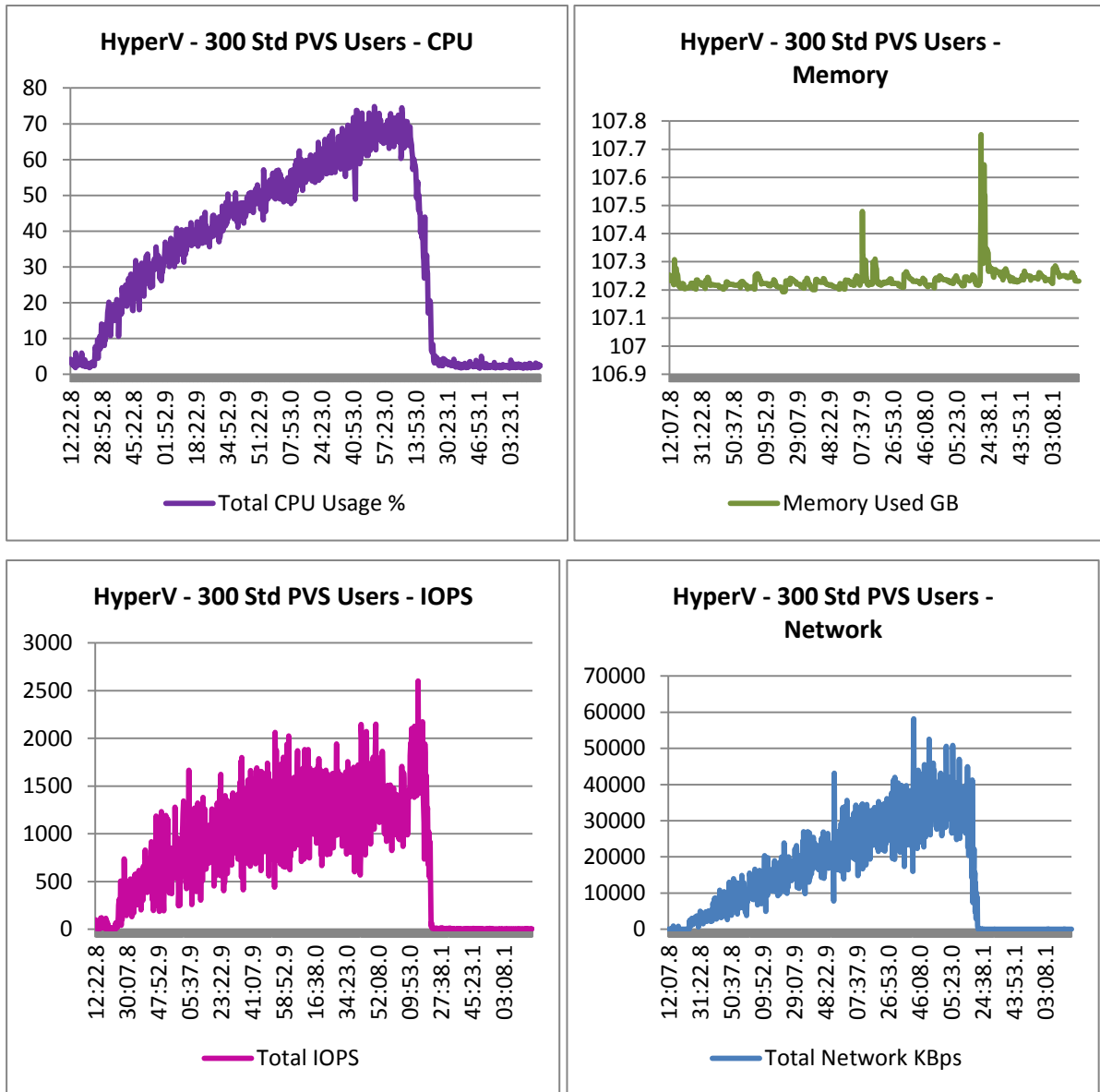

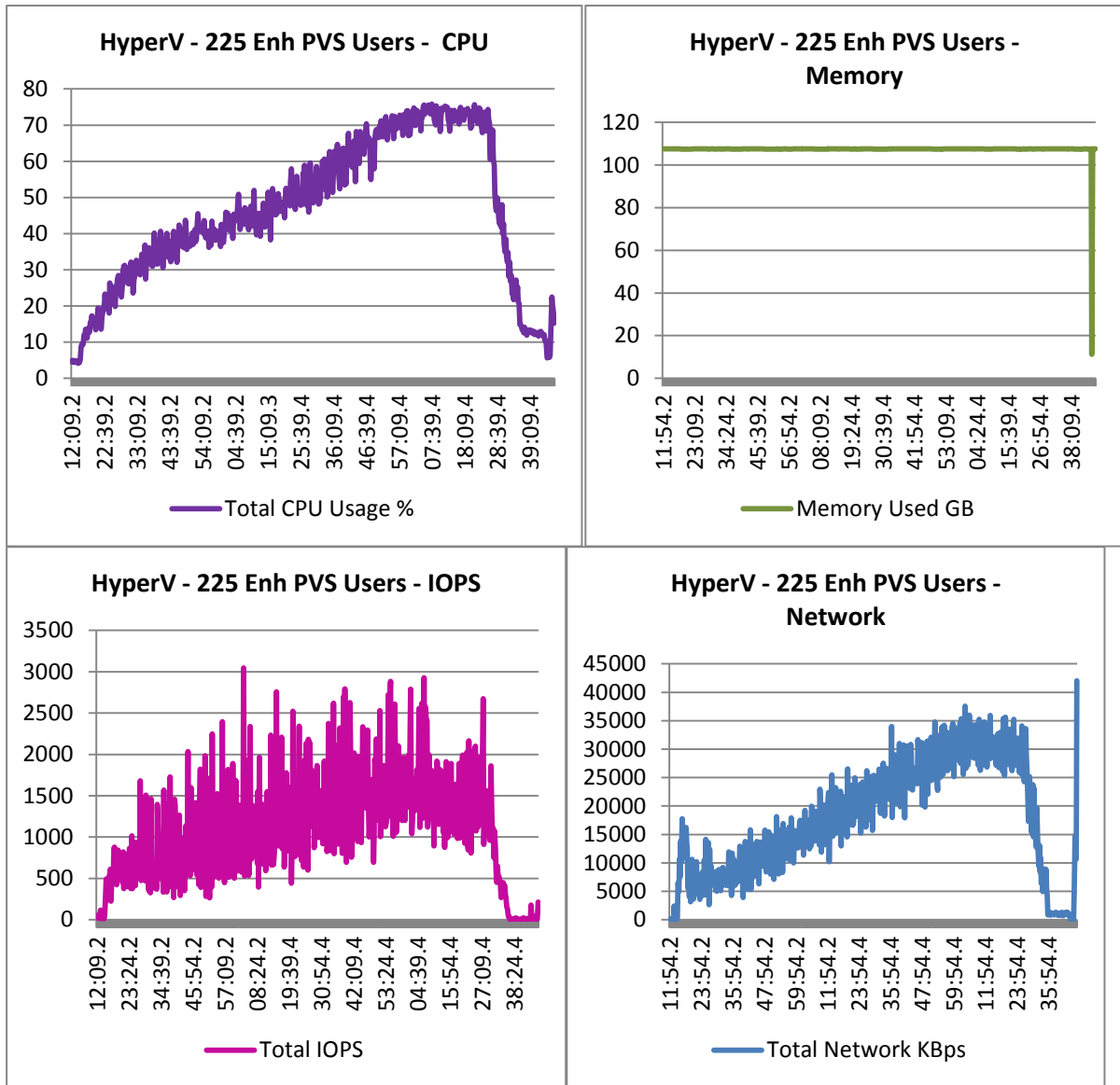

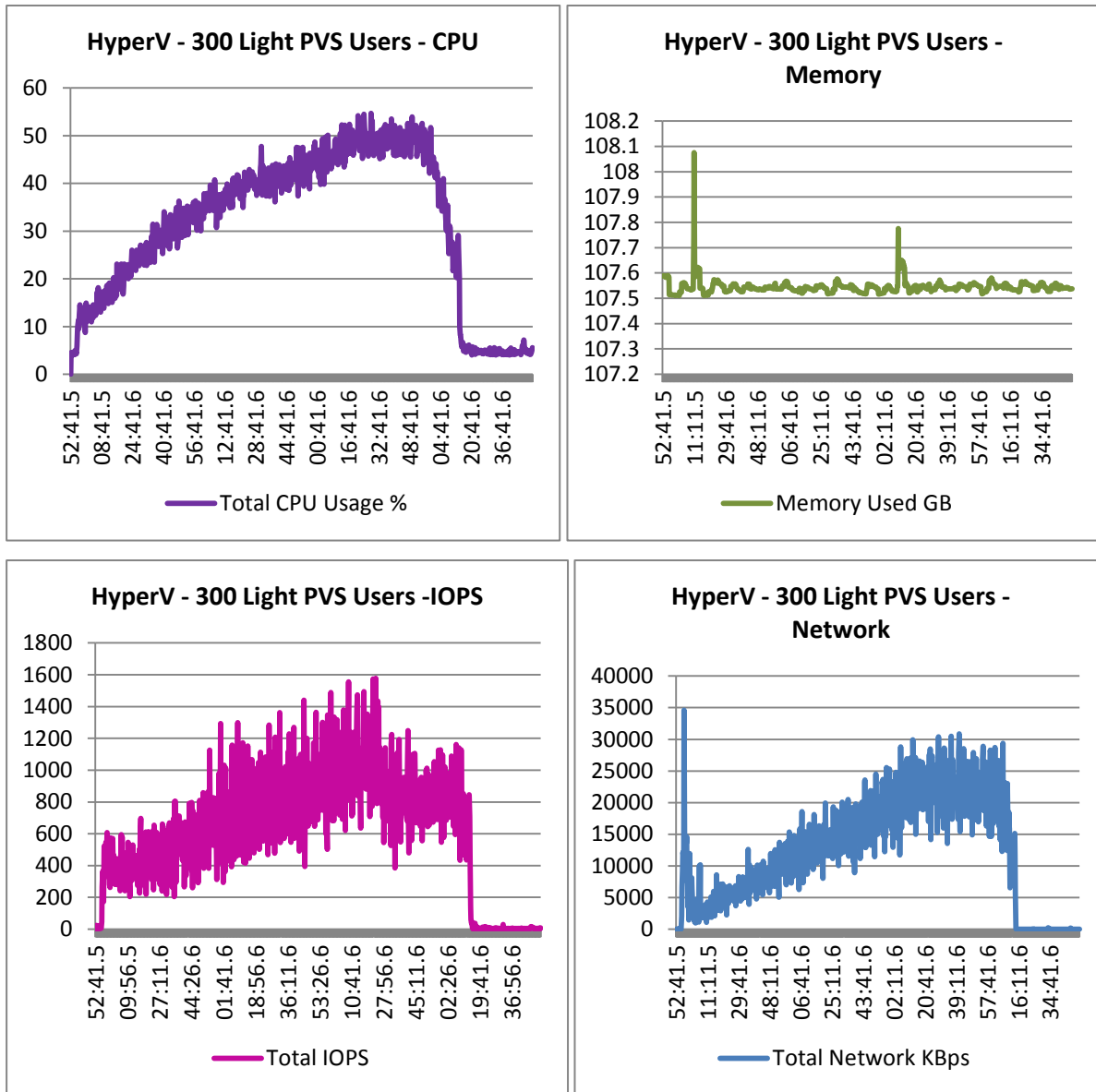

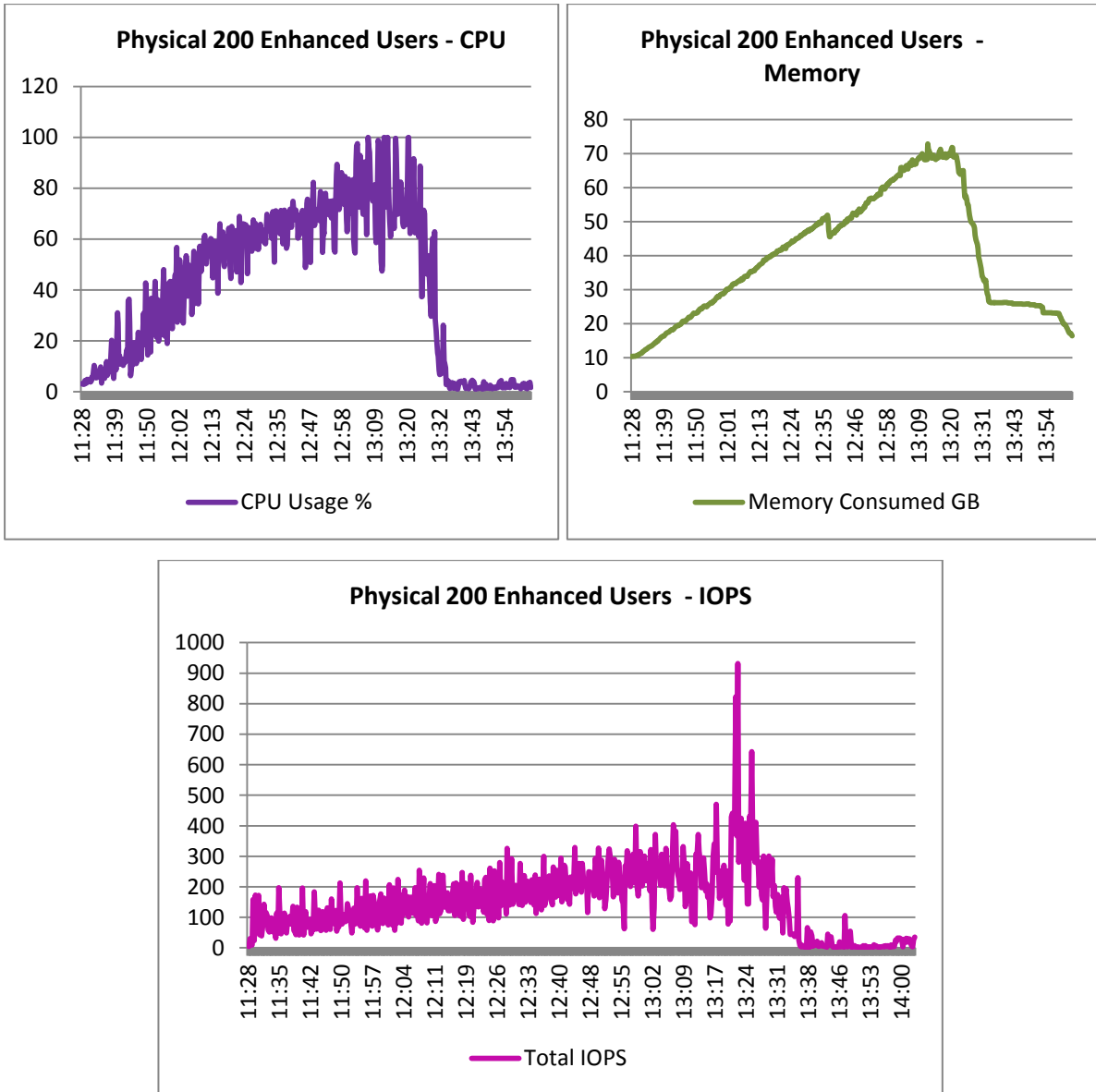
