Things to do prior to Removal Service picking up your equipment:

- 1. Remove and free the equipment from other connections, obstacles and make it a standalone piece ready for pick up.
- 2. Ensure that the equipment does not have serious hygiene issues. For example: clean and clear the presence of rancid food, presence of cockroaches, ants and/or other pests etc.... Please note that our staff does not have the right or expertise to remove such items. If they visit you for collection and are unable to make the collection, that visit will be counted as service performed and you will no longer be eligible for more free removal service.
- 3. It is your sole responsibility to ensure that all your data, software including proprietary, confidential, personal, and sensitive data is either securely transferred, backed up, cleaned out and removed from the equipment prior to pick up. Removal Service will collect the equipment on an 'as is' basis and is not responsible for any type of software, data loss, leakage and damage whether it occurs or arises with intent or is accidental whatsoever left in the equipment. This Removal Service is not designed for disposal of equipment containing confidential, proprietary, sensitive or any other non-public data. The equipment or parts of the equipment will be either disposed, destructed and/or recycled. Neither the equipment nor the data or software can be retrieved once it is picked up by the Removal Service. If you fail to perform your responsibility prior to the Removal Service visiting you for collection, it will be deemed that you have consented to part ways with the software, data and the data in the equipment is no longer of any value to you both monetarily and personally. The visit by our Removal Service will be counted as service performed, and you will no longer be eligible for any further free removal service.
