

**SOUNDS LIKE SUMMER GIVEAWAY: WEEK 3 - TWITTER
OFFICIAL RULES**

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. YOU HAVE NOT YET WON. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or player. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. The potential winners will be notified by direct message on Twitter. In order to receive the direct message, Your account settings must be set to "unprotected" and/or "public" and You must be following @Dell
