

DATA ACT CONNECTED PRODUCT DATA DISCLOSURE

This Disclosure covers the following connected product(s):

PowerSwitches running Dell Enterprise SONiC OS and PowerSwitches running Dell SmartFabric OS10

Type, Format, and Estimated Volume of Product Data:

Note: As used in this Disclosure, "product data" means raw and pre-processed data generated by the use of a connected product that Dell has designed to be retrievable.

The connected product generates various types of product data, including:

- Health Metrics: Switch operational status, fan status, power supply status, temperature sensors status, interface/link status.
- Performance Metrics: Port utilization (ingress/egress traffic), packet rates and error counts, CPU and memory usage.
- Configuration Data: Running configuration snapshot, VLANs, routing tables, ACLs, interface settings.
- Inventory Information: Model and serial number, firmware and OS version, module and transceiver details.
- Event and Fault Logs: Syslog entries, SNMP traps, REST API error responses.
- Topology and Connectivity: LLDP neighbor data, interface mappings, uplink/downlink relationships.
- Security and Access: user roles and access logs, authentication method.

The data generated uses the following formats: .txt, .json, and .xml

The connected product generates approximately 1 KB of product data per hour.

Continuous and Real-Time Data Generation:

The connected product does not continuously generate product data in real time.

Product Data Storage:

- On-Device Storage: The connected product stores product data locally on the device.
- Remote Storage: The connected product stores product data on remote, Dell-managed servers.

Duration of Retention of Remote Product Data:

Product data stored on remote servers is generally retained for <no explicit retention duration>. This retention period does not apply to product data that has been de-identified so that it does not identify any individual person or customer.

Access and Deletion of Data:

- Access: Users can review a copy of their product data currently in Dell's possession by visiting the <u>Dell Privacy Center</u>
 and selecting <u>Request Data Access</u>, then choosing the EU Data Act request option. If product data is accessible
 directly on the device, instructions for doing so can be found in the product documentation.
- **Deletion:** If product data is accessible directly on the device, instructions for deleting it can be found in the product documentation.
