Dell Document Hub is an innovative solution for seamless digital collaboration capabilities, with cloud-based Optical Character Recognition (OCR) to convert scanned documents to editable files. Devices with Dell Document Hub connect to multiple existing cloud service accounts, letting you access several online repositories at once.



Dell commissioned Buyers Laboratory LLC (BLI) to test the performance of Dell Document Hub against similar solutions that HP and Brother offer. The results speak for themselves:

Tested against HP's solution⁴

The analogous HP solution for small business customers is a combination of the apps available for download to supported HP ePrint MFPs, the Readiris Pro 12 OCR desktop utility that ships with the MFP, along with the HP Connected online service.

- From your computer, Readiris uses OCR processing to convert existing PDF and other image-format documents to editable files.
- Separate downloadable apps for the MFP allow you to scan and deliver uneditable PDF and other image-format files to supported cloud services⁵
- The HP Connected online service adds the option of printing from supported mobile devices via email



Tested against Brother's solution⁴

The comparable Brother ControlCentre4 desktop utility along with Nuance PaperPort 12 SE, a desktop OCR package from Nuance Communications, delivers capture, OCR and document management features.

- The combination of the two programs allows you to use a computer to scan and process documents into editable files
- You need to manually access individual cloud service websites to upload files to the cloud
