If you do not have a beneficiary in mind, on your behalf, we will donate your equipment to Camara, a charitable organization which provides affordable refurbished computers to schools in disadvantaged areas in seven countries in Africa, Ireland and the Caribbean. And where there are no schools, they set up eLearning centers using the technology you donate. After 3 years the systems will be recycled in adherence with European regulatory guidelines such as WEEE. Promote your brand. Secure your data. Protect the environment.
