As email is sent and received within the primary email system, a copy of each message is compressed and encrypted for transmission to the EMS data center. Email and attachments are stored encrypted along with relevant metadata. Dell EMS Email Archive automatically synchronizes user information, topology data and distribution lists with Microsoft Exchange to help significantly reduce maintenance and provide intelligent search and recovery capabilities. End users can search and restore their personal archives via Microsoft Outlook or a web browser. Administrators can search globally or they can delegate authority to users to act as scoped reviewers.

Reduce email stores by as much as 80%

Dell EMS Email Archive includes storage management capabilities that can immediately reduce the size of email data stores by as much as 80%. By replacing stored attachments with stubs (links) to their archived counterparts, EMS can dramatically reduce the amount of data stored in the primary system while still providing users with seamless access. EMS can provide end-users with virtually infinite mailboxes while helping reduce backup times and email data storage costs.
